Nancy J. Adler is Professor of International Management at the Faculty of Management, McGill University in Montreal, Canada. She received her BA in economics, followed by her MBA and PhD in management from the University of California at Los Angeles (UCLA). Dr Adler conducts research and consults on global leadership, cross-cultural management and women as global managers and leaders. She has authored over 100 articles, produced the film *A Portable Life*, and published the books *International Dimensions of Organisational Behavior* (4th edn, 2002), *Women in Management Worldwide* and *Competitive Frontiers: Women Managers in a Global Economy*. Her newest book is *From Boston to Beijing: Managing with a Worldview*. Dr Adler is a consultant to private corporations and government organizations on projects in Asia, Europe, North and South America and the Middle East. She has taught Chinese executives in the People's Republic of China, held the Citicorp Visiting Doctoral Professorship at the University of Hong Kong and taught executive seminars at INSEAD in France, Oxford University in England and Bocconi University in Italy. She received McGill University's first Distinguished Teaching Award in Management and was one of only a few professors to receive it a second time. Dr Adler has served on the Board of Governors of the American Society for Training and Development (ASTD), the Canadian Social Science Advisory Committee to UNESCO, the Strategic Grants Committee of the Social Sciences and Humanities Research Council, and the Executive Committees of the Pacific Asian Consortium for International Business, Education and Research, the International Personnel Association and the Society for Human Resource Management's International Institute, as well as having held leadership positions in the Academy of International Business (AIB), the Society for Intercultural Education, Training and Research (SIETAR), and the Academy of Management. She received ASTD's International Leadership Award, SIETAR's Outstanding Senior Interculturalist Award, the YWCA's Femme de Mérite (Woman of Distinction) Award, and the Sage Award for scholarly contributions to management. She was selected as a 3M Teaching Fellow honouring her as one of Canada's top university professors, and was elected to both the Fellows of the Academy of International Business and the Academy of Management Fellows.

Ilan Alon teaches International Business at Crummer Graduate School of Business, Rollins College. He is the author and co-editor of seven books

and over 60 articles and chapters published in refereed journals, books and conferences. Dr Alon's research focuses on international business, franchising and political risk assessment.

Paul W. Beamish is Associate Dean – Research, as well as Professor of International Business at the Richard Ivey School of Business, University of Western Ontario, in London, Canada. He is the author or co-author of 36 books and over 80 articles or contributed chapters. His books are in the areas of international management, strategic management, international entrepreneurship and, especially, joint ventures and alliances. His articles have appeared in the three Academy of Management journals, *SMJ*, *Journal of International Business Studies*, *Journal of Small Business Management* and elsewhere. He has received best research awards from the Academy of Management, the Academy of International Business and the Administrative Sciences Association of Canada (ASAC). Beamish has authored nearly 80 case studies, primarily in the international strategy area. These have appeared in *Asian Case Research Journal*, *Case Research Journal* and in over 50 books.

Jim Bell is Professor of International Business Entrepreneurship at the University of Ulster, Magee College, Northern Ireland and gained his PhD in Marketing from the University of Strathclyde, Scotland. He lectures in international marketing and has research interests in the internationalization of knowledge-based SMEs and international marketing/business education. He is the past State Director for Missouri Small Business Development Centers, past national chairperson of the Academy of Management's Entrepreneurship division, past President of the National Small Business Institute Directors' Association, past International President of the International Council for Small Business and was an elected delegate to the 1986 and 1995 White House Conference on Small Business. He is also a Fellow of three different academic entrepreneurship organizations – the only person so honoured. Dr Brockhaus is listed in *Who's Who in the World*, *Who's Who in America*, *Who's Who in Finance and Industry*, *International Who's Who in Education*, *International Businessmen Who's Who*, as well as over 15 other biographical sources of distinction. He has been invited speaker in Australia, Brazil, Canada, China, England, Egypt, Finland, Germany, Japan, Korea, Lebanon, Mexico, New Zealand, Singapore, South Africa and Switzerland, as well as throughout the United States.

Peter Brown spent over ten years actively engaged in international business and export market development prior to joining the University of Otago, Dunedin, New Zealand, as a lecturer in International Marketing. Peter's research interests include small firm internationalization, entrepreneurship and industrial cluster development. Peter is currently working with the Dunedin City Council in a senior management role responsible for marketing and economic development, actively implementing some of the results of his research in clusters and small firm internationalization.

Candida G. Brush is Policy Director of the Council for Women's Entrepreneurship and Leadership (CWEL), and Research Director for the Entrepreneurial Management Institute at Boston University. Dr Brush was one of 18 researchers selected to participate in the 1995 White House Conference Research Project: The Future of Small Business and Entrepreneurship into the Year 2010, and was recognized by INC Magazine in 1995 as one of the top 16 researchers in Entrepreneurship in the United States. She served on the Defense Department Advisory Committee on Women in the Services (DACOWITS) an advisory committee to the Department of Defense, is a member of Fleet-Boston's Advisory Board, The Women Entrepreneur's Connection, and served on the Research Advisory Committee for the National Foundation of Women Business Owners. Her research investigates the influence of gender in business start-up, and resource acquisition and strategies in emerging ventures.
