**Barry R. Chiswick** is Distinguished Professor and Head of the Department of Economics at the University of Illinois at Chicago and Program Director for Migration Studies, IZA-Institute for the Study of Labor (Bonn). He has published twelve books and monographs and over 140 journal articles and book chapters in economics, statistics and demography. His research on various aspects of the economics of immigration and the economics of minorities has been seminal. This research includes studies on the major immigrant receiving countries, including numerous studies for Australia. He has lectured at all of the major research universities in Australia. Professor Chiswick's research has earned him numerous honours and awards.

**Deborah A. Cobb-Clark** is the former Director of the Social Policy Evaluation, Analysis and Research Centre in the Research School of Social Sciences at the Australian National University. She is currently co-editor of the *Journal of Population Economics*. Dr. Cobb-Clark's research centres on the use of economics and applied, econometric methods to evaluate the impact of social policy – particularly immigration policy – on the labour market outcomes of individuals. This emphasis on rigorous evaluation of policy outcomes has led to a number of projects linked to various government agencies, both in Australia and abroad. She has published extensively on the subject of immigration in top international journals, including *American Economic Review*, *Journal of Labor Economics*, *Journal of Human Resources* and *Journal of Population Economics*.

**Tue Gørgens** is a Research Fellow of the Social Policy Evaluation, Analysis, and Research Centre, Research School of Social Sciences, the Australian National University. His research fields are applied labour economics and econometrics. He is especially interested in labour market issues related to individual behaviour and outcomes, such as the impact of business cycles and the influence of social policy. In addition to social implications, he is also interested in developing econometric methods that can be used to analyse behaviour and outcomes. Recently, he has become involved in a number of projects on the behaviour and outcomes of young Australians including, for

example, projects on the choice of job search methods and unemployment duration, on persistence in labour market histories, on the educational choices of young people, and on intergenerational welfare dependence.

**Steven Kennedy** is the General Manager of the Domestic Economy Division at the Australian Treasury. He leads a division responsible for preparing the Government's macroeconomic forecasts, providing policy advice on economic developments, and liaising with the Australian business community about current economic conditions. He obtained his PhD in economics from the Australian National University, and has a Bachelor degree in Economics (Honours) from the University of Sydney. Steven's research interests include labour and health economics, applied macroeconomics, income inequality and poverty measurement, and productivity analysis.

**Siew-Ean Khoo** is Senior Fellow in the Demography and Sociology Program in the Research School of Social Sciences at the Australian National University. A graduate of Harvard University, she has worked with the East-West Population Institute at the East-West Center, the Bureau of Immigration, Multicultural and Population Research and the Australian Government's Department of Immigration and Multicultural Affairs. She has published widely on international migration and immigrant settlement issues and is joint editor and contributing author of the recent book, *The Transformation of Australia's Population, 1970–2030* (Sydney: University of New South Wales Press, 2003).

**Anh T. Le** is Senior Lecturer in the School of Economics and Commerce at the University of Western Australia. She has a Bachelor of Business from Curtin University of Technology and a PhD in Economics from the University of Western Australia. She has undertaken research in a number of areas related to labour economics including employment outcomes of female migrants, educational attainment, unemployment, gender wage differential and self-employment. Her papers have appeared in a range of journals, including *Economics of Education Review*, *Education Economics*, *Economic Record*, *Australian Economic Papers*, *Australian Economic Review* and *International Migration Review*.

**James Ted McDonald** is an Associate Professor of Economics at the University of New Brunswick in Fredericton, Canada. He has an MCom and PhD from the University of Melbourne and was previously a senior lecturer at the University of Tasmania. He has published on a wide range of topics in journals such as *Social Science and Medicine* and the *Journal of Human Resources*. His current research interests are focused on the health behaviours,

health services use and health outcomes of immigrants in Canada, the United States and Australia.

**Paul W. Miller** is a Professor in the School of Economics and Commerce at the University of Western Australia. His primary research interest is labour market performance, particularly as it relates to educational attainment, gender and ethnic and racial origin. In 1997 he was elected as a Fellow of the Academy of the Social Sciences in Australia. In 1994, and again in 2004, he was awarded the Economic Society of Australia's Best Paper Prize, and in 2001 he received (together with Barry Chiswick) the US based Milken Institute Award for Distinguished Economic Research for the paper 'Do Enclaves Matter in Immigrant Adjustment?'
