He also serves as Distinguished Professor and Ameritech Chair of Economic Development at Indiana University, USA, and is a Research Fellow of the Centre for Economic Policy Research, London. His research has focused on the links between entrepreneurship, government policy, innovation, economic development and global competitiveness. His most recent book, *The Entrepreneurial Society*, was published by Oxford University Press in 2007. He was awarded the 2001 International Award for Entrepreneurship and Small Business Research by the Swedish Foundation for Small Business Research.

Pranab Bardhan is Professor of Economics at the University of California at Berkeley, USA, and co-chair of the MacArthur Foundation-funded

He has authored or edited a number of books, including *Scarcity, Conflicts, and Cooperation* (MIT Press, 2004) and *International Trade, Growth, and Development* (Blackwell, 2003). Paul D. Bush is Professor Emeritus of Economics, California State University, Fresno, USA. He is a past president of both the Association for Evolutionary Economics and the Association for Institutional Thought, and an honorary lifetime member of the European Association for Evolutionary Political Economy. He was given the Thomas Divine Award from the Association for Social Economics in 2002 and the Veblen–Commons Award from the Association for Evolutionary Economics in 2005.

Deborah M. Figart is Dean of Graduate Studies and Professor of Economics at The Richard Stockton College of New Jersey, USA. She has published books and articles on social economics topics related to the labour market: pay equity, discrimination, working time, job evaluation, emotional labour, career ladders, employment policies and poverty. From 2006 to 2007, she served as president of the Association for Social Economics. Currently, she is co-editor of the *Review of Social Economy*.

David George is Professor of Economics at La Salle University, USA and is the author of *Preference Pollution: How Markets Create the Desires We Dislike* (University of Michigan Press, 2001). His recent papers have covered such diverse topics as the effect of market values on higher education, the role of introspection in the economic discovery process, and a critical examination of Amartya Sen's analysis of free choice.
