**Norman E. Bowie** is the Elmer L. Andersen Chair in Corporate Responsibility at the University of Minnesota. He is a frequent contributor to scholarly journals in business ethics. His most recent book is *Business Ethics: A Kantian Perspective* and his most recent edited book is *Blackwell Guide to Business Ethics*. His next book *Management Ethics* (Blackwell Publishers) is in press. The seventh edition of his co-edited text *Ethical Theory and Business* was published in 2003. He has held a position as Dixons Professor of Business Ethics and Social Responsibility at the London Business School and been a fellow at Harvard's Program in Ethics and the Professions. He is past president of the Society for Business Ethics, the American Society of Value Inquiry and is past Executive Director of the American Philosophical Association.

Ciulla is a founding member of the leadership school. She has also held the UNESCO Chair in Leadership Studies at the United Nations International Leadership Academy and academic appointments at La Salle, Harvard, and Wharton. Her books include *Ethics; The Heart of Leadership; The Working Life: The Promise and Betrayal of Modern Work*; and *The Ethics of Leadership*. She recently co-authored a business ethics text with Robert C. Solomon and Clancy Martin called *Honest Work: A Business Ethics Reader*. Ciulla is on the editorial board of *The Business Ethics Quarterly*, *The Leadership Quarterly*, and *Leadership*. She is editor of the New Horizons in Leadership Series (Edward Elgar).

**Jay A. Conger** is Kravis Research Professor of Leadership Studies, Claremont College and Professor of Organizational Behavior, London Business School. Conger consults with a worldwide list of private corporations and nonprofit organizations and serves as an advisor and coach to numerous executives and CEOs. Author of over seventy articles and book chapters, and nine books including *Shared Leadership: Reframing the How's and Why's of Leading Others*; *Corporate Boards: New Strategies for Adding Value at the Top*; *Building Leaders: How Successful Companies Develop the Next Generation*; and *Charismatic Leadership in Organizations*.

**S.D. Noam Cook** is Professor of Philosophy at San Jose State University. His publications, research and consulting interests focus on social and technological change, particularly the roles of specialized knowledge, professional practice and values. He has given invited presentations on his work for academic, industrial and governmental institutions in the US and abroad, including MIT, UCLA, Virginia Tech, Texas A&M, Leiden University in The Netherlands, the University of Westminster in London, MITRE Corporation, Xerox research centers in the US, UK and France, the national government of The Netherlands, and various US federal agencies.

**Douglas A. Hicks** is Associate Professor of Leadership Studies and Religion in the Jepson School of Leadership Studies and Director of the Bonner Center for Civic Engagement at the University of Richmond. He is author of *Inequality and Christian Ethics* (2000) and *Religion and the Workplace: Pluralism, Spirituality, Leadership* (2003), both published by Cambridge University Press.

**Susan E. Murphy** is Associate Professor of Psychology at Claremont McKenna College and Associate Director of the Kravis Leadership Institute, currently serving as Interim Director of the Kravis Leadership Institute. Immediately prior to joining Claremont McKenna College, Professor Murphy worked as a research scientist at Battelle, Seattle Research Center. She is co-editor of two recent publications, *Multiple Intelligences and Leadership* and *The Future of Leadership Development* and numerous leadership and mentoring articles. Murphy is co-editor of the forthcoming Lawrence Erlbaum publication *Changing the Metaphor: From Work Family Balance to Work Family Interaction*.

**Terry L. Price** is Associate Professor of Leadership Studies at the Jepson School of Leadership Studies, University of Richmond where he teaches Ethics, History and Theories of Leadership, and Critical Thinking. He is co-editor of a three-volume set called *The International Library of Leadership*, Edward Elgar Press, and author of *Understanding Ethical Failures in Leadership*.

**Robert C. Solomon** is Quincy Lee Centennial Professor and a member of the Academy of Distinguished Teachers at the University of Texas at Austin. One of the most prolific philosophers in America, he is the author of over 40 books ranging from Sartre, Hegel, and Nietzsche, to justice, emotions, and a variety of other philosophic subjects. Five of his books are on business ethics, including *Above the Bottom Line; Ethics and Excellence; It's Good Business; A Better Way to Think about Business; and Building Trust* (with Fernando

Flores). Solomon is the President of the International Society for Research on Emotion. He has designed and delivered ethics programs for a number of Fortune 500 companies.

**Peter Temes** is President of Antioch New England Graduate School. He has taught literature, ethics, and writing at Columbia University, Harvard University, the University of Chicago, and other institutions of higher education. His most recent publications include: *The Just War: An American Reflection on the Morality of War*; and *Against School Reform and In Praise of Great Teaching*, as well as articles and book reviews on ethics, education and literature.

**Tom R. Tyler** is University Professor of Psychology at New York University. He teaches in the psychology department and at NYU Law School. His research explores the dynamics of authority in legal, political, and managerial groups. In particular, he is concerned with the influence of the fairness of the policies and procedures of organizations on the behavior of their members. He is the author of several books, including: *The Social Psychology of Procedural Justice*; *Why People Obey the Law*; *Social Justice in a Diverse Society*; and *Social Influences on Ethical Behavior in Organizations* (editor).

**Paul Woodruff** is Darrell K. Royal Professor in Ethics and American Society at the University of Texas, Austin. He has written plays, opera libretti, poetry, and short fiction, as well as a number of translations. His novella won an Austin Book Award, and his play won a B. Iden Payne Award for best new play in 1983. His academic publications include a commentary on Plato's *Hippias Major*; *Facing Evil*; and his *Reverence: Renewing a Forgotten Virtue* was published by Oxford University Press in 2001. His translations include Plato's *Symposium* and *Phaedrus*, an abridged version of Thucydides' *History*; *Early Greek Political Thought from Homer to the Sophists*; Euripides' *Bacchae*; Sophocles' *Antigone* in 2001; and Sophocles' *Theban Plays*. His latest book is *First Democracy: Facing the Original Ideas*.
