Magnus Boström is Associate Professor in Sociology and Lecturer in Environmental Science at the Department of Life Sciences at Södertörn University College. He previously worked as Research Director at Stockholm Centre for Organizational Research (Score), Stockholm University. Magnus Boström studies environmental organizations, policy making, rule setting, and green political consumerism in various sectors. His research has focused on debate, collaboration and negotiations among various types of actors in environmental policy making and rule setting, and on the role of political, regulatory, discursive and organizational settings in such processes. He publishes in such areas as organization literature, political sociology and environmental sociology. His most recent book is *Eco-standards, Product Labelling, and Green Consumerism* (Palgrave Macmillan, 2008), which he co-authored with Mikael Klintman.

Christina Garsten is Professor and Chair in the Department of Social Anthropology, and Research Director at Stockholm Centre for Organizational Research (Score), Stockholm University. Her research interests lie in the anthropology of organizations and markets, with a current focus on new forms of regulation and accountability in the labour market and in transnational trade. Her particular research concentrations are the varieties of cultural articulation at the interface of market and community: organization and sociality. She has published in the areas of organizational culture, flexibilization of employment, and corporate social responsibility. Her most recent books are *Workplace Vagabonds: Career and Community in Changing Worlds of Work* (Palgrave Macmillan, 2008) and *Transparency in a New Global Order: Unveiling Organizational Visions* (co-edited with Monica Lindh de Montoya, Edward Elgar Publishing, 2008).

Lars H. Gulbrandsen is Senior Research Fellow at the Fridtjof Nansen Institute in Norway. He was a visiting scholar in 2007 at the John F. Kennedy School of Government, Harvard University. His research interests include transnational forms of governance, international environmental regimes, corporate social responsibility, and the role of science in environmental governance. He is the author of a number of recent journal articles, book chapters and reports on the emergence, organization and effectiveness of non-state certification, and eco-labeling schemes.

Boris Holzer is Assistant Professor of Sociology at the University of Lucerne, Switzerland. His research interests include political and economic sociology, social networks and globalization. Recent publications include 'Political consumerism between individual choice and collective action: social movements, role mobilization and signalling', *International Journal of Consumer Studies*, 30 (2006); 'Framing the corporation: Royal Dutch/Shell and human rights woes in Nigeria', *Journal of Consumer Policy*, 30 (2007); and 'Turning stakeholders into stakeholders', *Business & Society* (Special Issue on the Politics of Stakeholder Influence, 2008).

Dieter Kerwer is Assistant Professor of International Politics at the Technical University in Munich, Germany. His major research interests are global and European governance, financial market regulation and organization theory. He is currently working on a book project on the role of global standards in the governance of financial markets. His recent publications include *Holding Global Regulators Accountable: The Case of Credit Rating Agencies*, Governance 18/3; *Rules That Many Use. Standards and Global Regulation*, Governance 18/4; and 'Global standards in action: insights from anti-money laundering regulation' (with Rainer Hülse), *Organization*, 14 (5), 625–642.

Rolf Lidskog is Professor in Sociology at the Centre for Urban and Regional Studies, Örebro University. His research interest is environmental policy and politics on an international and national level, especially the role of expertise in environmental politics. He is currently conducting research in three areas: international air policy, biodiversity and climate change adaptation. He has published extensively in academic journals on such topics as environmental sociology, environmental politics and policy making, science–policy relations and risk communication.

Jessica Lindvert is Senior Research Fellow and Associate Professor in Political Science at Stockholm Centre for Organizational Research (Score), Stockholm University. Her research interests include welfare policy, neo-institutionalism, public administration, gender politics and labour market policy. She recently published a book on the swift changes that have occurred in Swedish labour market arrangements over the past decade: *Hollow Labour Market Politics. Organization and Legitimacy in Sweden*. Her earlier work focused on the varieties of gender policy developments in Social Democratic and Liberal capitalist economies, a topic discussed in her thesis, *Feminism as Public Policy. Sweden and Australia 1960–1990* and in articles published in *Social Politics* and *Nordic Journal of Women's Studies*.

Susan Marton is Senior Lecturer at the Department of Politics and History, Karlstad University; and Researcher at the Center for Public Sector Research (CEFOS) at Göteborg University. Her research interests focus on the interplay between politics and economics and its expression in various public policy processes. Recently, this interest has included issues of corporate social responsibility, corporate governance and sustainable development. A further research interest, higher education and innovation policy, has led to contributions in *Transforming Higher Education: A Comparative Study* (Springer, 2006) and *Governing Knowledge: A Study of Continuity and Change in Higher Education* (Springer, 2005).

John W. Meyer is Professor of Sociology, emeritus, at Stanford University. He has contributed to organizational theory, comparative education, and the sociology of education, developing lines of thought now called sociological institutional theory. Since the late 1970s, he has done empirical research, and published many papers, on the impact of global society on national states and societies (some papers are collected in *Weltkultur: Wie die Westlichen Prinzipien die Welt Durchdringen*, Suhrkamp, 2005). Recently, he completed a collaborative study of worldwide science and its impact on national societies (Drori et al., *Science in the Modern World Polity*, Stanford, 2003). Another collaborative project, on the impact of globalization on organizational structures, has just been published (Drori et al., eds, *Globalization and Organization*, Oxford, 2006). He now studies the rise and impact of the world human rights regime, world curricula of mass and higher education, and the global expansion of higher education.

Arthur P.J. Mol is Chair and Professor in environmental policy at Wageningen University, the Netherlands. His research interests are in social theory and the environment, globalization, informational governance, greening production and consumption, and environment and development. His latest books are *Environmental Governance in China* (with Neil Carter; Routledge, 2007), *Partnerships, Governance and Sustainable Development: Reflections on Theory and Practice* (with Pieter Glasbergen and Frank Biermann; Edward Elgar, 2007) and *Environmental Reform in the Information Age: The Contours of Informational Governance* (CUP, 2008).

Luigi Pellizzoni is Associate Professor of Sociology of the Environment at the University of Trieste, Italy. His research interests focus on risk, environment, technology and participatory democracy. In the last years he has been dealing especially with the transformation of governance approaches and the implications of uncertainty for the science-policy interface. His recent publications include: *Sociologia dell'ambiente* (with

Osti; Il Mulino, 2008, 2nd edn); *La deliberazione pubblica* (ed., Meltemi, 2005); 'The myth of the best argument', *British Journal of Sociology*, 52 (1), 2001; 'Uncertainty and participatory democracy', *Environmental Values*, 12 (2), 2003; 'Knowledge, uncertainty and the transformation of the public sphere', *European Journal of Social Theory*, 6 (3), 2003; 'Responsibility and environmental governance', *Environmental Politics*, 13 (3), 2004; 'Revolution or passing fashion? Reassessing the precautionary principle', *International Journal of Risk Assessment and Management*, forthcoming.

Michael Power is Professor of Accounting and Research Theme Director of the ESRC Centre for the Analysis of Risk and Regulation (CARR) at the London School of Economics, where he has worked since 1987. He was educated at St Edmund Hall, Oxford and at Girton College, Cambridge and is a Fellow of the Institute of Chartered Accountants in England and Wales (ICAEW) and an Associate member of the UK Chartered Institute of Taxation. He has also held visiting fellowships at the Institute for Advanced Study, Berlin and at All Souls College, Oxford (2000). He is a member of the risk management committee of the London School of Economics and, since May 2005, is a non-executive Director of St James's Place Capital plc, where he is Chair of the Risk Committee. His research and teaching focuses on regulation, accounting, auditing, internal control and risk management. His major work, *The Audit Society: Rituals of Verification* (Oxford University Press, 1999) has been translated into Italian, Japanese and French. His new monograph, *Organized Uncertainty: Designing a World of Risk Management*, was published by Oxford University Press in May 2007.

Linda Soneryd is Senior Research Fellow and Associate Professor in Sociology at Stockholm Centre for Organizational Research (Score). Her research interests are connected to risk regulation and experiments in public participation and deliberation in the fields of science and technology. She is currently interested in the genealogy of public participation methods (such as consensus conferences, citizen juries), how the methods are initiated and become established, the ideas and assumptions that underpin them, and how the ideas and organization of public participation change as the methods travel among different organizations. She has conducted empirical research on public consultations on nuclear waste siting, a dialogue project on mobile phones and health risks and on the ongoing debates about the co-existence between GM and conventional and organic farming. Soneryd has currently published in *Science, Technology & Human Values* and *Public Understanding of Science*.

Karin Svedberg Nilsson is Assistant Professor in the Department of Management and Organization at the Stockholm School of Economics and Senior Research Fellow at Stockholm Centre for Organizational Research (Score). Karin is interested in how boundaries, identities and accountabilities of organizations are being constructed – and why. She has previously published on these issues in relation to market reform, procurement and CSR. Another research interest is governance and control within and across organizations, in the form of rules, for example, or in the case of public–private partnerships.

Kristina Tamm Hallström is Senior Research Fellow at Stockholm Centre for Organizational Research (Score) and Lecturer in Management at the Stockholm School of Economics. Her research interests are in organization studies of rule-setting processes. She has published internationally on the establishment of legitimacy, and on power within international standard-setting processes, with investigations into such areas as financial accounting, quality management and corporate social responsibility. Her most recent book is *Organizing International Standardization* (Edward Elgar, 2004), and she and Magnus Boström are currently working on another book: *Hidden Power Struggles – The Cases of ISO, FSC and MSC* (preliminary title, Edward Elgar, 2009).

Renita Thedvall is Senior Research Fellow in Social Anthropology at Stockholm Centre for Organizational Research (Score), Stockholm University. Her research interests lie in policy processes, bureaucratic practices and organization studies. She has a particular interest in the construction of markets, social and working-life issues. Recent publications include her dissertation, *Eurocrats at Work. Negotiating Transparency in Postnational Employment Policy* (Stockholm Studies for Social Anthropology, 58, 2006) and chapters in *Observing Government Elites. Up Close and Personal*, edited by R.A.W. Rhodes, P. 't Hart and M. Noordegraaf (Palgrave Macmillan, 2007) and in *Transparency in a New Global Order: Unveiling Organizational Visions*, edited by Christina Garsten and Monica Lindh de Montoya (Edward Elgar Publishing, 2008).

Sander W.K. van den Burg is Senior Researcher at the Environmental Policy Group, Wageningen University. His research interests lie in the changing distribution of power and responsibilities between state, corporations, civil society and citizen-consumers, and the emergence of new arrangements for environmental governance. His PhD research, completed in 2006, focused on the changing role of information in environmental governance and featured case studies on energy monitoring, labelling and disclosure. His research interests have remained constant over time, and his current research

tackles them by analysing the changes in sustainable consumption policies, as part of the Contrast research project (www.contrast-research.nl) and by further research on disclosure schemes, in various national and international settings.
