**Brian BRIDGES** is a Professor and Head of the Department of Political Science at Lingnan University, Hong Kong. He teaches, writes and broadcasts on the politics and international relations of the Asian Pacific region. He served as the Founding President of the Asian Studies Association of Hong Kong from 2005 to 2007.
