**Angel Asensio** is a lecturer at the University Paris 13, and researcher at the CEPN (Univ. Paris 13-CNRS, France). He is a member of ADEK (Association pour le Développement des Études Keynésiennes). He has recently published research papers on Post Keynesian theory, monetary and fiscal policy interactions, international interdependence and economic policy coordination.

**Jörg Bibow** is Associate Professor of Economics at Skidmore College, New York, and Research Associate at the Levy Economics Institute, Annandale-on-Hudson, New York, USA. Previously he held lecturing positions at the University of Cambridge, Hamburg University, and at Franklin College, Switzerland. He holds a PhD degree in economics from the University of Cambridge. He is the author of *Keynes on Monetary Policy, Finance and Uncertainty* (Routledge, 2009). He has published numerous articles and co-authored volumes in Europe and the US on European integration, central banking and global finance, including *Euroland and the World Economy: Global Player or Global Drag?* (Palgrave, 2007).

**Robert Dimand** is Professor of Economics at Brock University, St. Catharines, Ontario, Canada. Educated at McGill and Yale universities, he has written *The Origins of the Keynesian Revolution* (Edward Elgar and Stanford University Press, 1988) and more than 60 journal articles, and has edited 10 books.

**Robert Guttman** is Professor of Economics at Hofstra University (New York) and, since 1993, also Visiting Professor at the Université Paris XIII (France). A specialist on monetary theory and financial instability, he has published widely in the United States, the European Union, and Latin America. Among his more noteworthy books are *How Credit-Money Shapes the Economy: The United States in a Global System* (M.E. Sharpe, 1994) and *Cybercash: The Coming Reign of Electronic Money* (Palgrave-Macmillan, 2003). His latest publication, co-authored with Dominique Plihon, is entitled 'Whither the euro?' for the Oxford University Press Handbook on Financial Crises.

**Eric Kam** is Associate Professor of Economics in the Department of Economics, Ryerson University, Toronto, Canada. He holds a PhD in

economics from York University, and has previously taught at Huron University College, University of Western Ontario. His main research interests are in the fields of monetary theory, international monetary theory, microeconomic foundations of macroeconomics and the history of economic thought. He is the author/co-author of 20 academic publications in journals including the *Journal of Post Keynesian Economics*, *Economics Bulletin*, *Economics Letters*, the *Journal of Economic Studies*, *Economia Informa* and *Greek Economic Review*.

**Robert Koehn** is Lecturer in Economics at Brock University, St. Catharines, Ontario, was educated at McMaster University and the University of Toronto, Canada. He teaches labor economics, regional economics, and money and banking, and has published in the *Atlantic Economic Journal*, the *Forum for Social Economics*, the *Journal of Economic Asymmetries*, and the *Journal of Economic Issues*.

**Marc Lavoie** is Professor of Economics in the Department of Economics at the University of Ottawa, Canada, where he started teaching in 1979. Besides having published over 175 papers in refereed journals and book chapters, he has written a number of books, among which *Foundations of Post-Keynesian Economic Analysis* (Edward Elgar, 1992), *Introduction to Post-Keynesian Economics* (Palgrave/Macmillan, 2006) (with French, Spanish, Japanese and Chinese versions), as well as *Monetary Economics: An Integrated Approach to Money, Income, Production and Wealth* (Palgrave/Macmillan, 2007) with Wynne Godley. With Mario Seccareccia, he co-edited *Central Banking in the Modern World: Alternative Perspectives* (Edward Elgar, 2004). With Gennaro Zezza, he is editing the *Selected Writings of Wynne Godley* (2012).

**Edwin Le Heron** is Professor in Economics at the Bordeaux Institute of Political Studies, France, and researcher at CED (Centre Émile Durkheim). He is also President of ADEK (French Association for the Development of Keynesian Studies), which gathers French economists interested in Keynes and in Post Keynesian works. His research interests are monetary policy, Post Keynesian monetary theory, SFC modeling and the history of economic thought.

**Noemi Levy-Orlik** received her PhD in economics from the Universidad Nacional Autónoma de México (UNAM), Mexico City, in 1999. She is a professor in the Economics Department at UNAM. Her areas of research are in monetary economics, with particular attention to development issues of Latin American countries, with specific emphasis on finance and financial institutions in developing countries. **Mario Seccareccia** is Professor of Economics at the University of Ottawa, Canada. He has also been a Visiting Professor at the University of Paris-Sud, the University of Bourgogne, and the National Autonomous University of Mexico, and a Lecturer at the Labour College of Canada, the Post Keynesian Summer School at the University of Missouri, and the Summer School of the Progressive Economics Forum in Canada. He has authored/co-authored or co-edited some 12 books or monographs, and some 90 scholarly articles and chapters of books in a wide variety of areas in economics, including monetary economics, macroeconomics, labor

economics, the history of economic thought and economic history. He is also the editor of the *International Journal of Political Economy* and has edited or co-edited over 20 special issues of the journal since 2004.

**Mark Setterfield** is Professor of Economics in the Department of Economics at Trinity College, Hartford, Connecticut, USA, Associate Member of the Cambridge Centre for Economic and Public Policy at Cambridge University (UK), and Senior Research Associate at the International Economic Policy Institute, Laurentian University (Canada). His main research interests are macrodynamics and Post-Keynesian economics. He is the author of *Rapid Growth and Relative Decline: Modelling Macroeconomic Dynamics with Hysteresis* (Macmillan, 1997), the editor (or co-editor) of five volumes of essays, and has published in a variety of journals including the *Cambridge Journal of Economics*, *European Economic Review*, the *Journal of Post Keynesian Economics*, and *The Manchester School*.

**John Smithin** is Professor of Economics in the Department of Economics and the Schulich School of Business, York University, Toronto, Canada. He holds a PhD from McMaster University, and has previously taught at the University of Calgary, and Lanchester Polytechnic (now Coventry University) in England. His main research interests are in the fields of monetary theory and the philosophy of money and finance. He is the author/editor (co-author/co-editor) of *Keynes and Public Policy after Fifty Years* (1988), *Macroeconomics after Thatcher and Reagan* (1990), *Economic Integration between Unequal Partners* (1994), *Macroeconomic Policy and the Future of Capitalism* (1996), *Money, Financial Institutions and Macroeconomics* (1997), *What is Money?* (2000), *Globalization and Economic Growth* (2002), *Controversies in Monetary Economics* (1994, 2003), *Fundamentals of Economics for Business* (2006, 2009), and *Money, Enterprise and Income Distribution* (2009). He is currently working on a new book of with the provisional title, *Essays in the Fundamental Theory of Monetary Economics and Macroeconomics*, which aims at a definitive treatment of the issues in the these fields.

**Domenica Tropeano** is Associate Professor of Economics at the faculty of Economics of the University of Macerata, Italy. She has an MA from the University of Warwick and a doctorate from the European University Institute. She has studied and published in the fields of history of economic thought and history of macroeconomics, and is currently working on the issue of macroeconomic policies and globalization.
