T. Alexander Aleinikoff is the United Nations Deputy High Commissioner for Refugees. Before assuming his current position, he served as Dean of the Law Center and Executive Vice-President for Law Center Affairs at Georgetown University. Mr. Aleinikoff has held positions in the United States (US) Government and as a Professor at the University of Michigan Law School. His scholarship has focused on immigration and refugee law and policy, transnational law and US constitutional law.

Idil Atak is Assistant Professor at Ryerson University's Department of Criminal Justice and Criminology. She received her Ph.D. from the Université de Montréal's Faculty of Law. She was a SSHRC postdoctoral fellow at the McGill Centre for Human Rights and Legal Pluralism.

Hemme Battjes is Professor of European Asylum Law at VU University Amsterdam. His publications include *European Asylum Law and International Law* (Martinus Nijhoff, 2006) and 'In Search of a Fair Balance: The Absolute Character of the Prohibition of Refoulement under Article 3 ECHR Reassessed' (*Leiden Journal of International Law*, 22(3) 2009, 583–621).

Céline Bauhoz is a research assistant at the Global Migration Centre (Graduate Institute of International and Development Studies, Geneva). She is also assistant editor of the *Refugee Survey Quarterly* (Oxford University Press) and is finishing her PhD thesis in international law at the Graduate Institute. She has been visiting researcher at Harvard Law School and she previously worked as teaching assistant at the Geneva Academy of International Humanitarian Law and Human Rights and as a consultant for international and non-governmental organizations (such as the United Nations High Commissioner for Refugees, the International Committee of the Red Cross and the Oslo Institute for Social Research). Her areas of interest include international refugee law, international humanitarian law and international human rights law.

Vincent Chetail is Professor of Public International Law at the Graduate Institute of International and Development Studies (Geneva) where he is also Director of the Global Migration Centre. He is a Board Member of the Geneva Academy of International Humanitarian Law and Human Rights and, from 2004 to 2012, was the Research Director of the Geneva Academy.

Professor Chetail is Editor-in-Chief of the *Refugee Survey Quarterly*, member of the founding editorial board of *Oxford Bibliographies in International Law* and General Editor of the series *Organisation internationale et relations internationales* (Bruylant, Brussels). He is also Senior Research Associate at the Refugee Law Initiative (University of London), as well as member of the Academic Network for Legal Studies on Immigration and Asylum in Europe, the Advisory Council of the Global Migration

Policy Associates and the General Assembly of the International Institute of Human Rights – Strasbourg.

Roberta Cohen is a specialist in human rights and humanitarian issues, with special emphasis on internally displaced persons. She is a Non-Resident Senior Fellow at the Brookings Institution, Senior Associate at Georgetown University's Institute for the Study of International Migration and Adjunct Associate Professor at American University's Washington College of Law. She co-founded the Brookings Project on Internal Displacement and co-directed it for more than a decade with the two Representatives of the United Nations Secretary-General on Internally Displaced Persons, Francis Deng and Walter Kälin. She co-authored the first major study on internal displacement, *Masses in Flight* (Brookings, 1998), and in 2004, together with Francis Deng, she won the Grawemeyer Award for Ideas Improving World Order. She has published more than 100 articles on human rights and humanitarian issues and has been a consultant to governments, international organizations and non-governmental organizations. She served as Deputy Assistant Secretary of State for Human Rights in the State Department and as Senior Adviser to the United States Delegation to the United Nations.

François Crépeau is Full Professor, holds the Hans and Tamar Oppenheimer Chair in Public International Law and is scientific Director of the Centre for Human Rights and Legal Pluralism, at the Faculty of Law of McGill University (Montreal, Canada). He is United Nations Special Rapporteur on the Human Rights of Migrants. He is Guest Professor at the Université catholique de Louvain (2010-13). He has given many conferences, published numerous articles, and written or directed five books. He heads the 'Mondialisation et droit international' collection at Éditions Bruylant-Larcier (Brussels). He is a member of several editorial boards: *Journal of Refugee Studies*, *International Journal of Refugee Law*, *Refugee*, *Droits fondamentaux*, *Refugee Law Reader*. He was a Fellow 2008-11 of the Pierre Elliott Trudeau Foundation.

Catherine Dauvergne holds the Canada Research Chair in Migration Law at the University of British Columbia. She researches in the areas of refugee, immigration and citizenship law. Her current project investigates why the Canadian Charter of Rights and Freedoms has failed non-citizens. Along with Jenni Millbank she is undertaking a global study of how consideration of gender has transformed refugee law.

Moetsi Duchatellier is a Haitian specialist in international human rights law. She is currently working as Human Rights Officer at the United Nations Office of the High Commissioner for Human Rights. She has been engaged on issues related to displacement since 2006, in particular by providing assistance to the mandate of the Representative of the United Nations Secretary General on the Human Rights of Internally Displaced Persons and participated in this capacity in the discussions leading to the adoption of the Kampala Convention.

Thomas Gammeltoft-Hansen is Senior Research Fellow at the Danish Institute for International Studies and external Lecturer in International Refugee Law at the

University of Copenhagen. He has held visiting fellowships at the University of Michigan Law School and the Centre for Human Rights and Global Justice at New York University and serves as a consultant to a number of international and non-governmental organizations. His most recent book is *Access to Asylum: International Refugee Law and the Globalization of Migration Control* (Cambridge, Cambridge University Press, 2011).

Geoff Gilbert is Professor of Law, Head of the School of Law and a member of the Human Rights Centre at the University of Essex (United Kingdom). He has been Editor-in-Chief of the *International Journal of Refugee Law* (Oxford University Press) since 2002. He has worked with the United Nations High Commissioner for Refugees, for which he was founding Director of Studies for the Thematic Refugees and Human Rights course from 2005–07. In addition to his academic work, Professor Gilbert has served in advisory and consultancy capacities to both governmental and non-governmental organizations in the promotion of human rights and refugee law.

Elsbeth Guild is a Jean Monnet Professor ad personam in Law at the Radboud University (Nijmegen, Netherlands) and Professor of Law at Queen Mary University of London. She is also a Senior Research Fellow at the Brussels-based think tank, the Centre for European Policy Studies. She is an internationally acknowledged expert in European free movement of persons, immigration and asylum law. She practised law in the United Kingdom for more than ten years before moving into academic life. She retains her affiliation as a partner at the London law firm Kingsley Napley.

Her most recent monograph, *Security and Migration in the 21st Century* (Cambridge, Polity, 2009), brings together much of her seminal work over the past ten years – examining from a socio-legal perspective the changing dynamic of migration and security. Elspeth has published widely in her field and is respected for her contribution to the academic and policy debates across the world. In 2008 Elspeth was awarded a Doctorate honoris causa by Lund University Sweden in recognition of her academic and policy activities in the field of European immigration and asylum law.

Elsbeth is also much engaged in policy development in the European Union (EU) and the Council of Europe. She has also been a special advisor to the House of Lords EU Committee in its inquiry into EU Economic Migration in 2005. She coordinates a network of experts in EU immigration law in the 27 Member States for the European Commission and coordinates the annual report for the Commission on the United Kingdom's implementation of its obligations in this area. She also wrote in 2009 a highly influential paper for the Council of Europe's Commissioner for Human Rights on the criminalization of migration in Europe.

Walter Kälin is Professor of Constitutional and International Law at the University of Bern (Switzerland) and Non-Resident Senior Fellow at the Brookings-LSE Project on Internal Displacement. From 2004 to 2010, he was the Representative of the United Nations Secretary-General on the Human Rights of Internally Displaced Persons and co-directed the (then) Brookings-Bern Project on Internal Displacement. He was previously a member of the United Nations Human Rights Committee (2003–08), and

the Special Rapporteur of the United Nations Commission on Human Rights on the Situation of Human Rights in Kuwait under Iraqi Occupation (1991–92).

Professor Kälin extensively published books and articles on international human rights law, international refugee law and internally displaced persons. One of his most recent books is *The Law of International Human Rights Protection* (co-authored with J. Künzli, Oxford, Oxford University Press, 2009).

Hélène Lambert is Professor of International law at the University of Westminster, London. Previously, she has held lectureships at Bristol (UWE), Exeter, and Brunel. She has also held a visiting fellowship at the Refugee Studies Centre (University of Oxford) in 1999. Hélène has been a regular consultant for the Council of Europe; she also served briefly as a Protection Officer for UNHCR (1996). Hélène has published numerous books and articles on refugee law and human rights, including *Seeking Asylum* (Martinus Nijhoff, 1995), *The Limits of Transnational Law* co-edited with G.S. Goodwin-Gill (Cambridge University Press, 2010) and *International Refugee Law* (ed.) (Ashgate, 2010). She has also co-authored a number of inter-disciplinary publications, including *International Law and International Relations* co-authored with D. Armstrong and T. Farrell (Cambridge University Press, 2007, now in its second edition 2012). Her latest book *The Global Reach of European Refugee Law*, co-edited with J. McAdam and M. Fullerton, was published by Cambridge University Press in 2013.

Stephen H. Legomsky is John S. Lehmann University Professor at Washington University School of Law and has been Visiting Professor in various universities, such as Oxford University, Cambridge University, as well as in the United States, Switzerland, Germany or Australia. Since October 2011, Professor Legomsky has been on leave, serving as Chief Counsel of United States Citizenship and Immigration Services (USCIS), US Department of Homeland Security.

Professor Legomsky has extensively published articles and books in the field of international immigration law, international refugee law and citizenship law and policy. Among his numerous publications, his latest book is the fifth edition of *Immigration and Refugee Law and Policy* (co-authored with C.M. Rodríguez, New York, Foundation Press, 2009).

Beth Lyon is Professor of Law, Farmworker Legal Aid Clinic Director, and Community Interpreter Internship Co-Director at the Villanova University School of Law. Her work centres on the intersection of human rights, labour and migration. She is also active in the international clinical legal education movement. Professor Lyon has contributed to numerous books, encyclopaedias and law review journals. She currently serves on the Boards of Directors of the Society of American Law Teachers, Latina/Latino Critical Legal Theory, Global Workers Justice Alliance, and Friends of Farmworkers. Professor Lyon is a member of the American Bar Association Language Access Project Advisory Group, and chairs the Pennsylvania Bar Association Civil and Equal Rights Committee Treaty Ratification Subcommittee.

Lori A. Nessel is Professor of Law and Director of the Center for Social Justice, Seton Hall University School of Law. Her research and teaching interests include international human rights law, international refugee law and policy, immigration law, the rule of law and access to justice. She is actively involved in diverse initiatives relating to international human rights law or the rule of law, such as the Haiti Rule of Law Project which she is directing.

Stephane Ojeda is Deputy Head of Operations for the Americas at the International Committee of the Red Cross (ICRC). He previously served as ICRC Diplomatic Adviser and was in charge of the ICRC's relations with the Council of Europe and the Organization for Security and Cooperation in Europe. He was also the ICRC Coordinator to the United Nations Human Rights Council and to the Office of the High Commissioner for Human Rights.

Overall, Stephane served the ICRC as a Legal Adviser for about ten years both at the ICRC headquarters in Geneva, and in the field (Israel/Occupied Territories; Lebanon; New York). He has provided numerous lectures on international humanitarian law in various settings (e.g. United States Naval War College in Newport; NATO school in Germany; Hebrew University in Jerusalem) and published several legal articles. He has also served the ICRC field operations as a Detention Delegate (Ethiopia; Israel; Guantanamo Bay). Before joining the ICRC in 1999, he worked for a humanitarian non-governmental organization in Mali and for the French Foreign Ministry in Iraq.

Helen O'Nions is a Senior Lecturer in Public Law at Nottingham Law School, Nottingham Trent University. She is Editor of the *Nottingham Law Journal* and has published widely in her two main fields of expertise: asylum policy and Roma rights. Helen is currently completing a monograph entitled *Asylum: A Right Denied* which is due to be published by Ashgate in 2014.

Catherine Phuong is a Human Rights Officer at the United Nations Office of the High Commissioner for Human Rights (OHCHR). She is currently the Coordinator of the Rule of Law Unit in the OHCHR Office in Cambodia. Previously, she was a Senior Lecturer in International Law at the University of Newcastle in the United Kingdom. Her main publication was *The International Protection of Internally Displaced Persons* (Cambridge, Cambridge University Press, 2005).

Ryszard Piotrowicz is Professor of Law at Aberystwyth University. He has also taught at Glasgow and Durham Universities and the University of Tasmania, where he was Dean of Law. He is an Alexander-von-Humboldt Research Fellow. His research focuses on international humanitarian law and migration law, in particular the law with regard to human trafficking. He has been a member of the European Commission's Group of Experts on Trafficking in Human Beings since 2008. In November 2012 he was elected to the Council of Europe's Group of Experts on Action against Trafficking in Human Beings (GRETA) for a four-year term, commencing 1 January 2013. He has acted as a consultant on migration issues to several international organizations and governments. He is the Book Reviews Editor for the *International Journal of Refugee Law*.

Justin Rhodes is J.D. 2012, University of Minnesota Law School; M.A. in Political Science 2013, University of Minnesota.

Peter J. Spiro is Charles Weiner Professor of Law at Temple University Law School, Philadelphia. He has published extensively on issues relating to immigration, citizenship, and international law in academic journals as well as such publications as *The New York Times*, *The Wall Street Journal*, and *Foreign Affairs*. He is formerly an attorney at the US Department of State, a member of the National Security Council staff, and a law clerk on the US Supreme Court. He is the author of *Beyond Citizenship: American Identity After Globalization* (Oxford University Press, 2008).

Hugo Storey is an Upper Tribunal Judge (Immigration and Asylum Chamber) (formerly Senior Immigration Judge of the Asylum and Immigration Tribunal) in the United Kingdom (UK). He is currently a member of the Chamber's Executive Committee and of its Reporting Committee. He also acts as coordinator of the Tribunal's country guidance work. He was formerly a law academic, and later an Honorary Research Fellow, at the University of Leeds. In an academic capacity he has published widely on human rights, refugee, international law and European law issues. He is one of the International Association of Refugee Law Judges' (IARLJ's) founding members and is currently a member of its Council, Rapporteur of its COI-CG (Country of Origin-Country Guidance) Working Party and an executive member of the IARLJ's European Chapter. He was one of the experts utilized by the European Commission when drafting the Refugee Qualification Directive (2004/83/EC) and, more recently, its 'recast'. He has been active in the training of judges doing asylum and immigration work inside and outside the UK. He and several other European judges are shortly to publish a '*Preliminary References to the Court of Justice of the European Union: A Note for National Judges Handling Asylum-Related Cases*, 2013'.

Joel P. Trachtman is Professor of International Law at The Fletcher School of Law and Diplomacy. He specializes in international economic law, including the law and economics of multilateral trade, regional integration, international regulatory cooperation, and international finance. Recent books include *The International Law of Economic Migration: Toward the Fourth Freedom* (Upjohn Institute, 2009); *Ruling the World: Constitutionalism, International Law, and Global Governance* (Cambridge University Press, 2009); *Developing Countries in the WTO Legal System* (Oxford University Press, 2009); *The Economic Structure of International Law* (Harvard University Press, 2008); and *International Law and International Politics* (Ashgate Press, 2008).

Wouter Vandenhoele teaches human rights and holds the UNICEF Chair in Children's Rights at University of Antwerp Law Research School (Belgium). He is the co-Director of the Law and Development Research Group and a founding member of the editorial board of *Human Rights & International Legal Discourse*. His research interests include economic, social and cultural rights, children's rights, and the relationship between human rights law and development (in particular the issue of extraterritorial obligations).

Jens Vedsted-Hansen is Professor at Aarhus University, School of Law, Denmark. He has held previous posts at the University of Aalborg, the Danish Centre for Human Rights, and the University of Copenhagen, Faculty of Law. He served as a member of the Danish Refugee Appeals Board from 1987 to 1994, and again from 2013. His research interests include international, European and Danish human rights law, immigration and asylum law, as well as administrative and constitutional law.

Annemarieke Vermeer-Künzli is Assistant Professor in Public International Law at the Amsterdam Center for International Law, University of Amsterdam. She has published widely on the topic of diplomatic protection in various leading international law journals. She also was the Dutch Country Correspondent in the EU CARE Project (www.careproject.eu). Her fields of interest include, besides diplomatic protection and consular assistance, the law of state responsibility in general, non-recognition, the law of treaties and the sources of international law.

Rebecca M.M. Wallace is Research Professor of International Human Rights and Justice, at The Robert Gordon University, Aberdeen, Scotland. She is also the Director of the Centre for Rural Childhood, Perth College, University of the Highlands and Islands, and Judge of the First Tier Immigration Tribunal. Professor Wallace has widely published on human rights law, and especially on the international protection afforded to asylum-seekers, women and children.

David Weissbrodt is Regents Professor and Fredrikson & Byron Professor of Law at the University of Minnesota. He has also been Visiting Professor in various universities around the world such as the Université Jean Moulin (Lyon, France), the Graduate Institute of International and Development Studies (Geneva, Switzerland), the Kellogg College (Oxford University, UK), the United Nations University in Tokyo (Japan) or the Monash University Law School in Melbourne (Australia). He established the University of Minnesota Human Rights Center and helped establish the University of Minnesota Human Rights Library online. From 1996 until 2003, Professor Weissbrodt served as a member of the United Nations Sub-Commission on the Promotion and Protection of Human Rights and, from 2000 until 2003, as United Nations Special Rapporteur on the rights of non-citizens.

Marjoleine Zieck is Professor of International Refugee Law and Vice Dean education at the Amsterdam Law School of the University of Amsterdam. She studied visual arts, philosophy, and public international law (the latter two at the University of Amsterdam) and acquired her Ph.D. degree *cum laude* with a thesis on voluntary repatriation of refugees. Her research focuses on the mandate of the United Nations High Commissioner for Refugees and durable solutions. She is also Professor of Public International Law at the Pakistan College of Law, Lahore.
