Kevin Caraher is Teaching Fellow at the Department of Social Policy and Social Work, University of York, UK. His teaching and research interests are focused on international and comparative social policy with particular interest in the political economy of welfare, historical institutionalism, and social security policies in East and South-East Asia.

Ho Mun Chan is Associate Professor of Philosophy in the Department of Public Policy, City University of Hong Kong, Hong Kong. His B.A and M.Phil. in philosophy are from the University of Hong Kong, his M.Sc. in knowledge-based systems from the University of Sussex, and his Ph.D. in philosophy and cognitive science from the University of Minnesota, USA. His publications have focused on comparative social and political philosophy, applied and comparative ethics, end-of-life decision making, and the problem of rationality. He is currently a member of the Clinical Ethics Committee of the Hospital Authority in Hong Kong and chairs its Working Group on Advance Directives. His articles have appeared in journals including *Bioethics* and *The Journal of Medicine and Philosophy*.

Kam Wah Chan is Associate Professor of the Department of Applied Social Sciences, Hong Kong Polytechnic University, Hong Kong. He teaches mainly social policy, and his research interests include Asian welfare policy, poverty, employment, housing studies, gender studies, men's studies, and race and ethnic studies. Some of his recent publications include *Women and Housing: An International Analysis* (co-edited, Routledge, 2011) and *The Crisis of Welfare in East Asia* (co-edited, Lexington, 2007).

Raymond K.H. Chan is Associate Professor at the Department of Applied Social Studies, City University of Hong Kong, Hong Kong and a Research Fellow at the Social Policy Research Centre, National Taiwan University, Taipei and the Centre for Economic and Social Studies in Asia, Yokohama National University, Yokohama, Japan. His current research interests include comparative social policy, risk and social policy, and labour and family policies. He is the co-editor of *Risk and Public Policy in East Asia* (with M. Takahashi and L.R. Wang, Ashgate, 2010). His articles have appeared in *Asian Journal of Political Science*, *Asian Journal of Social Science*, *Critical Social Policy*, *Journal of Asian Public Policy*, *Journal of Comparative Asian Development*, *International Social*

Work, International Journal of Social Welfare, Journal of Social Work, Social Indicators Research and Social Policy and Administration.

Yu-fang Chang was awarded an M.Phil. from Manchester Metropolitan University, UK and is currently Senior Lecturer at the Department of International Business Studies, National Chi Nan University, Taiwan. Her studies focus on social indicators and their implications for marketing, social enterprises and policy issues. She was involved in a research project on poverty reduction in Taiwan (UNRISD, 2009), and has published journal articles (e.g. in *Asia Pacific Journal of Social Work and Development*) and many book chapters in Chinese.

Young Jun Choi is Associate Professor in the Department of Public Administration at Korea University, South Korea. Prior to his current position, he worked at the University of Oxford as a departmental lecturer and the University of Bath as a lecturer. His research interests include welfare state theory, comparative public policy, comparative methods, and ageing and pensions. He has published articles in *Policy and Politics, Ageing and Society, International Journal of Social Welfare*, and other journals in the United States, China, Japan and Korea.

Ray Forrest is Professor of Housing and Urban Studies and Head of the Department of Public Policy at the City University of Hong Kong. He is also Professor Emeritus of Urban Studies at the University of Bristol. His recent publications include *Housing Markets and the Global Financial Crisis: The Uneven Impact on Households* (Edward Elgar, 2010) and *Young People and Housing: Transitions, Trajectories and Generational Fractures* (Routledge, 2012), both edited with Ngai Ming Yip. He is currently undertaking research on neighbourhood change in Vietnam, on the rehousing of rural villagers in Mainland China and on the housing aspirations and attitudes of young people in Hong Kong.

John Hudson is Deputy Head of the Department of Social Policy and Social Work at the University of York, UK. His research and teaching interests centre around comparative social policy analysis, the political economy of welfare and the policy-making process. He is co-author of *Understanding the Policy Process* (Policy Press, 2009) and *The Short Guide to Social Policy* (Policy Press, 2008). His research has appeared in a wide range of journals including *Critical Social Policy, Journal of European Social Policy, Journal of Social Policy, Policy and Politics, Social Policy and Administration* and *Social Policy and Society*.

Gyu-Jin Hwang is Senior Lecturer at the Department of Sociology and Social Policy, University of Sydney, Australia. He is the author

of *Pathways to State Welfare in Korea: Interests, Ideas and Institutions* (Ashgate, 2006) and the editor of *New Welfare States in East Asia: Global Challenges and Restructuring* (Edward Elgar, 2011). His publications have appeared in *Journal of Social Policy*, *Social Policy and Administration*, *Policy Studies*, *Social Policy and Society* and *Asian Journal of Social Science*.

Masami Iwata is Professor of Social Welfare at Japan Women's University in Tokyo, Japan. She is the leading scholar in the field of poverty and social exclusion in Japan and has published widely in the area of social policy. She is currently the President of the Japanese Society for the Study of Social Welfare. Her English publications include *Poverty and Social Welfare in Japan* (joint editor, Trans Pacific Press, 2008).

Misa Izuhara is Reader in Comparative Policy Research and the Head of the Centre for Urban and Public Policy Research at the School for Policy Studies, University of Bristol, UK. She has been undertaking research extensively both nationally and internationally in the areas of housing and social change, intergenerational relations, and comparative policy analysis between the East and the West. Her recent research projects include 'Housing Assets and Intergenerational Dynamics in East Asian Societies' (funded by the UK Economic and Social Research Council). She is the author of *Housing, Care and Inheritance* (Routledge, 2009) and the editor of *Ageing and Intergenerational Relations: Family Reciprocity from a Global Perspective* (Policy Press, 2010).

Dongchul Jung is a Ph.D. candidate in sociology at Yonsei University, South Korea. His dissertation examines the working poor in advanced capitalist countries in terms of labour market and social policies. He has published articles on welfare regimes in Asian countries (*Korean Journal of Sociology*) and the link between welfare and labour market policies in Asian countries (*New Welfare States in East Asia*).

Patricia Kennett is Reader in Comparative and International Policy Studies at the University of Bristol, UK. Her research interests involve exploring cross-nationally the interrelated dynamics of space, place, power and policy, and the processes and differentiated nature of inclusion and exclusion. Her particular geographical focus is on Europe and East Asia. She is currently leading an ESRC project on 'The Uneven Impact of the Economic Downturn on Cities and Households in Bristol and Liverpool', which follows the recent completion of a three-year qualitative research project on 'Governance and Citizenship in East Asia' (funded by the Hong Kong Polytechnic University, Hong Kong, China). Recent publications include *A Handbook of Comparative Social Policy*, 2nd edition (editor,

Edward Elgar, 2013) and an edited collection *Women and Housing: An International Analysis* (with Kam Wah Chan, Routledge, 2010), as well as journal articles on gender justice, and choreographies of governance and citizenship in East Asia.

Yeun-wen Ku is Professor at the Department of Social Work, National Taiwan University, and a co-founder and current President of the Taiwanese Association of Social Policy (TASP). He is one of the key members who founded the East Asian Social Policy (EASP) research network, established in January 2005 to facilitate research exchange and cooperation among East Asian social policy analysts, and was chair during 2011–12. He has written widely on welfare development and policy debates in Taiwan, extending to comparative study on East Asian welfare. He has published ten books and over 30 articles both in English and in Chinese. His English publications include the single-authored *Welfare Capitalism in Taiwan* (Macmillan, 1997), collected volumes such as *Welfare Capitalism in East Asia* (Palgrave, 2003) and *Social Cohesion in Greater China: Challenges for Social Policy and Governance* (Imperial College Press, 2010), and journal articles (*Social Policy and Administration*, *Social Policy and Society*).

Maggie Lau is Assistant Professor in the Department of Public Policy at the City University of Hong Kong. She obtained her Ph.D. from the University of York, UK. She has extensive research and teaching experience in development and policy studies, contemporary China studies, poverty and social exclusion, and children and young people's well-being, as well as adolescent health. Her publications have appeared in *Policy Studies* (2002), *Journal of Societal and Social Policy* (2005), *Nicotine and Tobacco Research* (2008), *Asia-Pacific Journal of Public Health* (2010), *Child Indicators Research* (2010, 2012), *Health Policy* (2010), *Journal of Asian Public Policy* (2010), *Children and Youth Service Review* (2011) and *Journal of Community Health* (2012).

Shuo Liu is Assistant Professor at the Department of Sociology, Hong Kong Shue Yan University. Her principal research interests include interpersonal relationships (*guanxi*) and the emerging middle class in contemporary China. Her Ph.D. thesis examined the formation process of the middle class in urban China by exploring their experiences of constructing an ideal domestic life. Her major publication is 'A Middle Class Community: Class Formation and the Building of a Moral Order' (co-authored with Tai-lok Lui, in *ShehuiXue Yanjiu*). Her current research focuses on professionals with a Mainland China background working and living in Hong Kong.

William Yat Wai Lo is Assistant Professor in the Department of International Education and Lifelong Learning, Hong Kong Institute of Education. He received his Ph.D. from the University of Bristol, and has worked as a researcher in Hong Kong and Britain. He has published articles in leading journals of educational studies such as *Comparative Education*, *Compare*, *Higher Education* and *Asia Pacific Journal of Education*. He is also the associate editor of *Journal of Asian Public Policy*. His main research interests include policy studies in education and educational development in East Asia.

Tai-lok Lui is Professor of Sociology at the University of Hong Kong. He is the co-author of *Hong Kong: Becoming a Chinese Global City*, *Hong Kong, China: Learning to Belong to a Nation* and *City-States in the Global Economy*. He also co-edited *The Dynamics of Social Movement in Hong Kong* and *Consuming Hong Kong*. He writes on the middle class in Hong Kong and Mainland China, civic organizations, social movements, colonialism, economic restructuring, and global cities. He is currently working on a textbook on Hong Kong society and a research project on historical sociology.

Kalyani K. Mehta is Associate Professor and the Head of the Gerontology Master's Programme at SIM University, Singapore. Her research interests include policies for an ageing population, family caregiving, intergenerational relationships, e-services for older people, and long-term care. Her recent co-edited publication is *Experiencing Grandparenthood: An Asian Perspective* (Springer, 2012).

Ka Ho Mok is Chair Professor of Comparative Policy at the Department of Asian and Policy Studies, concurrently Acting Vice President (Research and Development) and Associate Vice President (Research and International Exchange) of the Hong Kong Institute of Education (HKIED). Since 2010 he has been Changjiang Chair Professor, a highly distinguished national chair professorship conferred by the Ministry of Education, People's Republic of China, serving at Zhejiang University, China. He was elected as President of the East Asian Social Policy Research Network (EASP), a regional research consortium promoting social policy research in the Asia-Pacific region since July 2012, and he also serves as an executive member of the Asian Political and International Studies Association (APISA).

Lucille Lok-Sun Ngan is Honorary Lecturer of Sociology, University of Hong Kong and Affiliated Research Fellow, Department of Social Sciences, Hong Kong Institute of Education. Her research focuses on migration, the Chinese diaspora, transnationalism, ethnic and race relations, identities, life course, gender and family. She is currently

researching the migratory and educational experience of cross-border schoolchildren in Hong Kong. Her recent publications include *The Chinese Face in Australia* (with K.B. Chan, Springer, 2012), 'Decentered Transnational Linkages: Chinese Returned Migrants in Hong Kong', in *Transnational Migration Identifications in Asia: Living Intersections*, edited by C. Pluss and K.B. Chan (Springer, 2012), and 'An Outsider Is Always an Outsider: Migration, Social Policy and Social Exclusion in East Asia', with K.W. Chan (forthcoming).

Kinglun Ngok is the Pearl River Scholar Distinguished Professor of Social Policy at the School of Government and the Centre for Chinese Public Administration Research, Sun Yat-sen University, Guangzhou, China. His current research interests include social policy, social insurance, social management and social services. He is the founding director of the Institute for Social Policy at Sun Yat-sen University. He has authored and co-edited several books on Chinese social policy and numerous journal articles, including *Social Policy in China: Development and Wellbeing* (co-authored with C.W. Chan and D. Phillips, 2008), *Chinese Social Policy* (co-edited with C.W. Chan and K.Q. Han, 2009), *Welfare Reform in East Asia: Towards Workfare?* (co-edited with C.W. Chan, 2011) and *Public Services for Migrant Workers* (2012). He is also the editor-in-chief of *Chinese Public Policy Review*.

Chan-ung Park is Professor at the Department of Sociology, Yonsei University, South Korea. His research includes social policies, economic sociology and social networks. He has recently published articles on the Korean model of social enterprises (*Korean Journal of Sociology*), a comparative study of the link between welfare regimes and labour market policies in Asian countries (*Journal of Asian Public Policy*), a multi-level analysis of trust across countries (*Social Forces*) and a network analysis of global trade (*International Sociology*). He has also been working on the historical evolution of the FTA network and its effects on income inequality.

Richard Ronald is Associate Professor at the Centre for Urban Studies, University of Amsterdam, the Netherlands. He has published widely on housing and other urban issues in European and Asia-Pacific contexts. He holds a European Research Council independent researcher's grant and is currently coordinating a large-scale comparative project looking at the changing role of housing markets and family property wealth in welfare regime transformations. He is also the Editor-in-Chief of the *International Journal of Housing Policy*. Before coming to the Netherlands he was based at Kobe University in Japan, where he was the recipient of the Japan

Foundation Doctoral Fellowship and the Japan Society for the Promotion of Science Postdoctoral Fellowship.

Naoko Soma is Associate Professor at the International Graduate School of Social Sciences, Yokohama National University, Japan. Her research interests focus on comparative family policy, childcare policy, and the sociology of citizenship of women and children in East Asia. Her recent publications in English include 'Comparative Framework for Care Regime Analysis in East Asia' (*Journal of Comparative Social Welfare*, 27 (2), 2011) and 'Rebuilding the Family Unit or Defamilialization? The Politics of Family Policy for Social Risks in South Korea' (in R.K.H. Chan, M. Takahashi and L.L.-r. Wang (eds), *Risk and Public Policy in East Asia*, Ashgate, 2010).

Sirin Sung is Lecturer in Social Policy at the Queen's University Belfast, UK. Her main research interests include gender and social policy, gender and employment, work-life balance policies, and gender and benefits in both East Asian countries and the UK. She was awarded the Leverhulme Study Abroad Fellowship in 2010: the research focus was on 'Gender and Welfare State in the UK and US: Work-Family Balance Issues'. Her recent publications include 'Women Reconciling Paid and Unpaid Work in a Confucian Welfare State: The Case of South Korea' (in *Social Policy and Administration*, 2003) and a forthcoming book 'Gender and welfare state in East Asia' (with Gillian Pascall, Palgrave).

Shogo Takegawa is Professor in the Graduate School of Humanities and Sociology, Tokyo University, Japan. His research focuses on comparative social policy. He is author of 'Japan's Welfare-State Regime: Welfare Politics, Provider and Regulator' (*Development and Society*, 2005), 'International Circumstances as Factors in Building a Welfare State: Welfare Regimes in Europe, Japan and Korea' (*International Journal of Japanese Sociology*, 2009), 'Liberal Preferences and Conservative Policies: The Puzzling Size of Japan's Welfare State' (*Social Science Japan Journal*, 2010) and 'Workfare in Japan' (in C.K. Chan and K. Ngok, eds, *Welfare Reform in East Asia: Towards Workfare?*, Routledge, 2011).

Alan Walker FBA is Professor of Social Policy and Social Gerontology at the University of Sheffield, UK. He is currently Director of the New Dynamics of Ageing Programme (<http://www.newdynamics.group.shef.ac.uk/>) funded by the AHRC, BBSRC, EPSRC, ESRC and MRC. He has published more than 30 books, 200 reports and 300 scientific papers. Recent books include *Social Policy in Ageing Societies* (Palgrave, 2009), *Fighting Poverty, Inequality and Social Injustice* (Policy Press, 2011) and *Social Quality: From Theory to Indicators* (Palgrave, 2012). In 2007 he

was given a Lifetime Achievement Award by the Social Policy Association and the first Outstanding Achievement Award by the British Society of Gerontology.

Chack-kie Wong is Professor in the Social Work Department and also Associate Director of the Hong Kong Institute of Asia-Pacific Studies at the Chinese University of Hong Kong. His research interests and publications are in the areas of comparative social policy, welfare attitudes, poverty, and welfare reform issues. He has published substantially in scholarly journals and edited volumes, including *China's Urban Health Care Reform* (author, Lexington, 2006), *East Asian Welfare Regimes in Transition* (editor, Policy Press, 2005) and 'The Relationship between Social Policy and Economic Policy: Constructing the Public Burden of Welfare in China and the West' (*Development and Society*, 2009). Besides his academic work, he also volunteers in community and public services; he was formerly a vice-chairman of the Hong Kong Awards for Young People and a part-time member of the Central Policy Unit, the Hong Kong SAR Government, and is currently a Hong Kong member of Chongqing Committee of the People's Political Consultative Conference, People's Republic of China. He received a medal of honour in 2008 from the SAR Hong Kong Government for his advice on issues related to the livelihood of low-income people.

Linda Wong is Professor at the Department of Public Policy, City University of Hong Kong, Hong Kong, People's Republic of China. Her research interests span the fields of social welfare, comparative social policy and China studies. Among her works are *Marginalization and Social Welfare in China*, *Social Change and Social Policy in Contemporary China*, *The Market in Chinese Social Policy*, *Social Policy Reform in Hong Kong and Shanghai* and *Rural-Urban Migrant Workers in China: Issues and Social Protection* (in Chinese). Her articles have appeared in *Journal of Social Policy*, *Social Policy and Administration*, *Public Administration Review*, *International Migration Review*, *Journal of Contemporary China*, *Pacific Affairs*, *Asian Survey* and *Australian Journal of Public Administration*.

Junko Yamashita is Lecturer at the School of Sociology, Politics and International Studies, University of Bristol, UK. Her expertise is in comparative policy analysis of East Asian and European welfare states, especially in relation to care and gender. Her recent publications include 'Exploring the Impact of the Japanese Long-Term Care Insurance Act on the Gendered Stratification of the Care Labour Market' (in *Social Policy and Society*, 10 (4), 2011) and 'Citizen Participation or Low-Cost Care Providers? Welfare Nonprofit Organisations in Japan' (in *Social Science*

Japan Journal, **16** (1), 2013), and she is a co-editor of *Care, Cooperative Work and Unpaid Work: Unsettled Boundary of Labour* (with N. Nihei, Ōtsuki Shoten, in Japanese).
