Spyros Arvanitis is Senior Researcher at the KOF Swiss Economic Institute at the ETH Zurich. He is head of the research section Innovation Economics of the KOF. Arvanitis holds a doctoral degree in economics from the University of Zurich and a doctoral degree in chemistry from the ETH Zurich. He has served as expert in national and international advisory bodies on the evaluation of technology policy. His research interests cover several fields of industrial economics with a strong emphasis on empirical studies. He has published extensively on the economics of innovation, technology diffusion, determinants of firm performance, economics of market dynamics as well as the international competitiveness of firms and industries.

Barry Bozeman is Regent's Professor of Public Policy and Ander Crenshaw Chair at the University of Georgia, Athens, GA, USA. Bozeman also holds an appointment as Distinguished Adjunct Research Professor at Arizona State University's College of Public Affairs and Center for Science, Policy and Outcomes. Prior to joining the University of Georgia faculty, Bozeman was founding director of Georgia Tech's School of Public Policy and was Professor of Public Policy, Law and Engineering at Syracuse University's Maxwell School of Public Affairs where he founded the Center for Technology and Information Policy.

Bozeman's science and technology policy research focuses on research evaluation, technology development and transfer, and research collaboration. He also works in the field of public management and organization theory. Bozeman has authored or co-authored 16 books on science and technology policy or organization theory, including most recently *Rules and Red Tape* (with Mary K. Feeney), in 2011.

Bozeman is an elected fellow of the American Association for the Advancement of Science and of the National Academy of Public Administration. Bozeman is a member of many academic journals' editorial boards and is a co-editor of *Journal of Technology Transfer*. He is a winner of the American Society for Public Administration's Charles Levine award for lifetime contributions in research, teaching and service in public administration. In 2011, he was the inaugural winner of the University of Georgia's School of Public and International Affairs 'Best Researcher' award.

Sébastien Casault's expertise is in the application of real options for decision making in R&D. These activities include the development of Decision Support Tools for Canada's Ministry of Industry. Mr Casault holds a BSc in Physics with a specialization in Astrophysics from the University of Waterloo, an MSc in Physics from the University of Ottawa on modeling diffusion-related phenomena, and an MSc in Management from the University of Ottawa on the use of a Real Option pricing of government funding of R&D. Sébastien's research to date has resulted in a number of publications and a student research award from the American Association for the Advancement of Science (AAAS). Irwin Feller is Senior Visiting Scientist at the American Association for the Advancement of Science and Emeritus Professor of Economics at The Pennsylvania State University, University Park, PA, USA, where he served on the faculty for 39 years, including 24 years as director of the Institute for Policy Research and Evaluation. He has published extensively on the organization and assessment of government research and technology programs, the economics of research and development, the performance of research-intensive universities, and evaluation methodology. His current research interests include the design, governance and evaluation of national science systems, the adoption and impacts of performance measurement systems, and the role of institutions of higher education in technology-based economic development.

In the United States, Dr Feller has chaired and served on numerous review and advisory committees for the National Science Foundation, the US Department of Energy, and the National Academies National Research Council. He is co-editor of the NRC report, *A Strategy for Assessing Science* (2007). Internationally, he was a member of the expert panel that reviewed the European Commission's Framework VI program, he participated in

the OECD's review of Slovenia's national science programs, and has been a member of expert review panels in Sweden, France, Canada and Chile. He has also participated extensively in international conferences in Europe and Asia. He has a BBA in economics from the City University of New York and a PhD in economics from the University of Minnesota.

Michael P. Gallaher is the Director of RTI's Environmental, Technology and Energy Economics Program, Research Triangle Park, NC, USA. He has more than 10 years of experience leading projects for the National Institute of Standards and Technology (NIST), the US Environmental Protection Agency (EPA), and other federal agencies modeling the economic impact of new technologies. Dr Gallaher specializes in developing baseline/counterfactual scenarios from which incremental costs and benefits can be measured and has conducted both retrospective and prospective technology assessments. Most of the projects he has led have involved modeling the adoption of new technologies and assessing the barriers to adoption. Dr Gallaher has led over 30 economic impact assessments for agencies such as NIST, EPA, the National Science Foundation (NSF), and the National Telecommunications and Information Administration (NTIA), assessing the implications of technology adoption in the automotive, aerospace, computer hardware and software, chemical, iron and steel, and construction industries. Dr Gallaher has published books on the economics of cyber security and R&D in the service sector and has published articles in the *Journal of Technology Transfer*, *Environmental Sciences*, and the *Journal of Law and Policy for the Information Society*.

Denis O. Gray is Alumni Distinguished Graduate Professor, Psychology in the Public Interest Program, North Carolina State University. Dr Gray's research focuses on science, technology and innovation policy issues, particularly the outcomes and implications of cooperative research. For the past two decades he has led a unique, multi-faceted 'improvement-focused' evaluation of the National Science Foundation's (NSF) longest-running cooperative research center program, the Industry–University Cooperative Research Centers (IUCRC). His books include: *Cooperative Research Centers and Technical Innovation: Government Policies, Industry Strategies, and Organizational Dynamics* (co-editor); *Innovation U.: New University Roles in a Knowledge Economy* (co-author); *Managing the Industry/University Cooperative Research Center* (senior editor); and *Technological Innovation: Strategies for a New Partnership* (senior editor).

Aard J. Groen is Professor of Innovative Entrepreneurship and Scientific Director of NIKOS, the Dutch Institute for Knowledge Intensive

Entrepreneurship at the University of Twente, the Netherlands. Groen's research interest focuses on knowledge-intensive entrepreneurship in networks. NIKOS research contributes to the IGS, Institute for Innovation and Governance Studies, where Groen is leading the research on "Innovation & Entrepreneurship". He is widely published in journals including: *Technovation*, *Journal of Management*, *International Journal of Small Business*, and *Creativity and Innovation Management*. His focus is on entrepreneurship, marketing, university–industry interaction, and innovation and technology dynamics. Groen is also Head of Department. Groen received his Master's in public administration from the University of Twente, and his PhD in business administration from the University of Groningen.

Diana Hicks is Professor and Chair of the School of Public Policy, Georgia Institute of Technology, Atlanta, GA, USA. She obtained her DPhil in Science and Technology Policy Studies from SPRU, University of Sussex, UK. For almost 10 years she was on the faculty of SPRU. Between 1998 and 2003 she was the Senior Policy Analyst at CHI Research, Inc. where she conducted numerous policy analyses for government agencies based on empirical information in patent and paper databases. Her work has been supported by and has informed policy makers in the US, Europe and Japan. Professor Hicks has also taught at the Haas School of Business at the University of California, Berkeley, SPRU and worked at the National Institute of Science and Technology Policy (NISTEP) in Tokyo.

John E. Jankowski is Director of the Research & Development Statistics Program (RDS) within the National Science Foundation's National Center for Science & Engineering Statistics. As one of the Federal Government's 13 principal statistical agencies, NCSSES is mandated to provide a clearinghouse for the collection, interpretation and analysis of data on scientific and engineering resources and to serve as a source of information for policy formulation by the Federal Government. RDS has responsibility for eight repeating surveys on financial and physical resources related to the Nation's research and development (R&D) activities in the academic, government, industrial and non-profit sectors. Major recent survey design efforts have included a joint project between NCSSES and the Census Bureau to launch a new 40000-firm survey on Business R&D and Innovation, and the fielding of a greatly expanded Higher Education R&D survey sent to all research-performing colleges and universities in the US. Mr Jankowski has played a key role in the implementation of several major federal statistical R&D initiatives, including development of an R&D satellite account to the US System of National

Accounts; the collection of academic and biomedical cyberinfrastructure statistics; and conceptualization of the government's first data-linking project authorized under the Confidential Information Protection and Statistical Efficiency Act of 2002, the purpose of which is to track global R&D investments.

Mr Jankowski has been with NSF since 1987. He has authored numerous reports, articles and papers on science and technology issues. He is an acknowledged contributor to three of the OECD's international statistical manuals for collecting science and engineering data—on R&D (Frascati Manual), on globalization, and on intellectual property products, and is currently leading an international task force on business R&D and innovation surveys. Prior to joining NSF, Mr Jankowski was the Assistant Director for Strategic and Policy Analysis at the Distilled Spirits Council, and before that conducted economics research on energy and mineral issues at the non-profit organization, Resources for the Future. He holds degrees from Georgetown University and the Johns Hopkins' School for Advanced International Studies.

Gretchen B. Jordan is an independent consultant specializing in a systems view of innovation and program and evaluation design that considers the full range of research, development and market adoption initiatives and the logical connections among them. Until December 2011 she was a Principal Member of the Technical Staff with Sandia National Laboratories, Albuquerque, NM, USA, working with the US Department of Energy (DOE) Office of Energy Efficiency and Renewable Energy, and the DOE Office of Science, on evaluation and performance measurement and innovative methods of assessing the effectiveness of research organizations. She is co-editor of *Research Evaluation*, a Fellow of the American Association for the Advancement of Science, and co-founder and co-chair of the American Evaluation Association's Topical Interest Group on Research, Technology, and Development Evaluation. She has a PhD in Economics. Prior to joining Sandia in 1991, Dr Jordan was Chairman of the Business Administration Department at the College of Santa Fe and staff member of US Senator Pete V. Domenici and the Senate Budget Committee.

Gordon Kingsley is an Associate Professor and Director of Graduate Studies in the School of Public Policy at the Georgia Institute of Technology. Dr Kingsley's research examines the development, implementation, and evaluation of organizational partnerships across the public, private and non-profit sectors. Current research explores the impacts of partnership on the development and allocation of scientific

and technical human capital. This work is being conducted in three policy domains examining the following: 1) school-university partnerships aimed at improving math and science education; 2) public-private partnerships in state transportation agencies; and 3) the development of hybrid organizations and network organizations designed to simulate technology-led economic development. Dr Kingsley earned his PhD in Public Administration at the Maxwell School of Citizenship and Public Affairs at Syracuse University.

Albert N. Link is Professor of Economics at the University of North Carolina at Greensboro (UNCG), Greensboro, NC, USA. He received a BS degree in mathematics from the University of Richmond in 1971 and a PhD in economics from Tulane University in 1976. After receiving his PhD, he joined the economics faculty at Auburn University where he remained until 1982 when he joined the economics faculty at UNCG. While at UNCG he has served as Head of Department of Economics as well as Director of the MBA program. Professor Link's research focuses on innovation policy, academic entrepreneurship, and the economics of R&D. He is currently the Editor-in-Chief of the *Journal of Technology Transfer*.

Among his most recent books are: *Employment Growth from Public Support of Innovation in Small Firms* (2012), *Valuing an Entrepreneurial Enterprise* (2012), *Government as Entrepreneur* (2009), *Cyber Security: Economic Strategies and Public Policy Alternatives* (2008) and *Entrepreneurship, Innovation, and Technological Change* (2007). Other academic research has appeared in such journals as the *American Economic Review*, the *Journal of Political Economy*, the *Review of Economics and Statistics*, *Economica*, and *Research Policy*.

Much of Professor Link's research has been supported by funding organizations such as the National Science Foundation, the Organisation for Economic Co-operation and Development (OECD), the World Bank, and the science and technology ministries in several developed nations. Currently, Professor Link is serving as the vice-chairperson of the Innovation and Competitiveness Policies Committee of the United Nation's Economic Commission for Europe (UNECE) (2007–2012).

Jonathan D. Linton is the Power Corporation Professor for the Management of Technological Enterprises at the University of Ottawa, Canada. He holds a PhD in Management Science from the Schulich School of Business, York University and is a registered professional engineer. Linton's research focuses on operational concerns associated with emerging technologies and closed loop supply chains. He has published

over 100 articles in academic and trade publications, including articles in *IEEE Transactions on Engineering Management*, *Interfaces*, *Journal of Operations Management*, *Journal of Product Innovation Management*, *R&D Management*, *Nature Materials*, *Technological Forecasting and Social Change* and in a number of other refereed publications and books. Linton is the Editor-in-Chief of *Technovation*. He is on a number of editorial boards including *IEEE Transactions on Engineering Management* and *Technological Forecasting and Social Change*.

Ross J. Loomis is an economist in RTI's Global Climate Change and Environmental Sciences Division. He has experience analyzing and modeling markets for ecosystem services; valuing non-market goods; and conducting benefit–cost and economic impact analyses, advanced statistical and spatial analyses, and industry assessments for state, corporate, and federal clients, such as the US Environmental Protection Agency (EPA), the National Institute of Standards and Technology (NIST), and the National Park Service (NPS). He has conducted quantitative and qualitative research within the financial services industry, including developing equity screening tools, programming automated reports, and presenting industry and company analysis to investment professionals. With 15 years' experience in technology economics, public policy and regulatory impact analysis, and economic development, Mr O'Connor specializes in leading interdisciplinary teams in economics studies at the interface between technology and economic, environmental, energy, and/or public health imperatives. His core research practice consists of cost–benefit analysis, technology program evaluations, industry surveys,

Professor Scott's published research in academic journals has spanned five different decades and his research about the economics of technological change has been supported by the National Institute of Standards and Technology, the National Science Foundation, the National Academy of Sciences, the World Bank, the United Nations Development Programme, and the Organisation for Economic Co-operation and Development.

Patrick Thomas is Principal and Director of Analytics at 1790 Analytics LLC, Haddonfield, NJ, USA, which specializes in science and technology evaluation for large corporations, government agencies and investment institutions. He has published numerous articles on technology evaluation, both in scholarly journals and in popular science and business publications.
