**Jonathan V. Beaverstock** is Professor of Economic Geography at the University of Nottingham, UK. He completed his PhD at the University of Bristol and BA at the University of Wales, St David's University College, Lampeter. He is the author of over 100 journal articles, book chapters, published conference papers and proceedings, including three books (authored and edited), the latest being: *The Globalization of Advertising* (Routledge 2011). He has given considerable public service to the UK research councils and charities, and sits on the editorial boards of *Geoforum* and *Global Networks*. In 2006 he was bestowed an Honorary Professorship at the University of Otago, New Zealand, and has recently been appointed Visiting Professor at the University of Ghent, Belgium. Jonathan Beaverstock is currently one of the leading researchers on the subject of the global super rich.

**Sébastien Chauvin** is an Assistant Professor of Sociology at the University of Amsterdam, the Netherlands, a researcher at the Amsterdam Institute for Social Science Research (AISSR), the Netherlands, and an Associate Researcher with the *Institut de Recherche Interdisciplinaire sur les Enjeux Sociaux* (IRIS), France. He has published books and articles on the sociology of work and employment (*Les agences de la précarité. Journaliers à Chicago*, Paris: Le Seuil 2010), social capital and the upper class, migration and ethnic studies, and the sociology of gender and sexuality (*Introduction aux gender studies. Manuel des études sur le genre*, Brussels: De Boeck, with L. Bereni, A. Jaunait and A. Revillard).

**Bruno Cousin** is an Assistant Professor of Sociology at the University of Lille 1, France, a researcher at the *Centre Lillois d'Études et de Recherches Sociologiques et Économiques* (Lille 1/CNRS), France, and an affiliate with the *Groupe de Sociologie Politique et Morale* at EHESS, France. He is the author of peer-reviewed articles and book chapters on urban segregation, social capital, upper-classes sociability, the refusal of social or ethnic mix, and the sociology of intellectuals. Currently, he is also Vice President of the French Sociological Association, in charge of international relations.

**Melanie Fasche** is a geographer based in Berlin and affiliated as external PhD candidate in Urban and Regional Economic Studies at HafenCity

University Hamburg, Germany. She has worked in Berlin as a freelance consultant in public policy projects with a focus on creative industries and arts and has been Visiting Lecturer in Urban Studies at Free University Berlin, Germany. Previously she has held fellowships at Columbia University, US, Technical University Berlin, Germany, Institute of Regional and Structural Planning (IRS), Erkner/Berlin, Germany, and University of New South Wales, Australia. Her diploma thesis 'Glocalization, gentrification and creative business services: a case study of Newtown, Sydney' was honoured with the Young Researchers Award by the German-speaking Association for Australian Studies (*Gesellschaft für Australienstudien e. V.*). Fasche is currently finishing her dissertation on the value-making process of contemporary visual art.

**Sarah J.E. Hall** is an Associate Professor in Economic Geography at the University of Nottingham, UK. She completed her PhD at the University of Bristol, UK, and BA at Cambridge University, UK. She is the author of over 30 journal articles, book chapters and practitioner orientated research reports. Her research interests centre on financial elites with particular interests in: their reproduction through business education; global elite labour markets and working practices; and their consumption of financial services through wealth management. Her research has been funded by the Economic and Social Research Council, The Nuffield Foundation and The British Academy. She serves on the ESRC Peer Review College and has acted as editor for several special issues of social science journals.

**Iain Hay** is Matthew Flinders Distinguished Professor of Human Geography at Flinders University, Australia. He completed his PhD at the University of Washington, US, as a Fulbright Scholar and more recently received a LittD from the University of Canterbury, NZ, for 20-plus years of post-doctoral work on geographies of domination and oppression. He is author or editor of ten books including *Money, Medicine and Malpractice in American Society* (Praeger 1992) and *Qualitative Research Methods in Human Geography* (3rd edn Oxford 2010); is General Editor of Springer's 'International Handbooks of Human Geography' series; and has had editorial roles with journals that include *Applied Geography*, *Ethics, Place and Environment* and *Social and Cultural Geography*. In 2006, Hay received the Prime Minister's Award for Australian University Teacher of the Year. He is immediate past President of the Institute of Australian Geographers.

**Pauline McGuirk** is Professor of Human Geography and Director of the Centre for Urban and Regional Studies at the University of Newcastle, Australia. She completed her PhD at Trinity College Dublin, Ireland. Her research interests are in urban political geography and she has published

widely on urban governance, its geographies and its changing forms. Her recent work has involved critical investigations of transformations in Sydney's governance as it has emerged as a global city-region, and on new forms of governance associated with the emergence of residential master-planned estates. McGuirk has been a Visiting Fellow at the University of Glasgow, UK, Durham University, UK, Bristol University, UK, University of British Columbia, Canada and Trinity College Dublin. She serves on the editorial boards of *Progress in Human Geography*, *Irish Geography*, *Geography Compass* and *Geographical Research*. She is a Fellow of the Institute of Australian Geographers and of the Geographical Society of New South Wales.

**Phil McManus** is an Associate Professor in the School of Geosciences, The University of Sydney, Australia. After completing qualifications in urban planning at Curtin University, Australia, and environmental studies at York University, Canada, he completed his PhD in geography at the University of Bristol, UK. He is author or editor of four books, notably *Vortex Cities to Sustainable Cities* (UNSW 2005) and, with John Connell, *Rural Revival?* (Ashgate 2011). He has published numerous refereed journal articles on a range of urban, environmental and animal related issues. His co-authored book *The Global Horseracing Industry: Social, Economic, Environmental and Ethical Perspectives* (Routledge) is due for release in early 2013. McManus is President of the Institute of Australian Geographers.

**Laurence Murphy** is Professor of Property at the University of Auckland, New Zealand. He completed his PhD in geography at Trinity College Dublin, Ireland. He has published on homeownership, mortgage securitization, commercial property development, entrepreneurial urban governance and gentrification. He is on the editorial boards of the *International Journal of Housing Markets and Analysis* and the *Pacific Rim Property Research Journal*. In 2009 he was a Visiting Professor at Trinity College Dublin and in 2010 he was appointed a Fellow of the Royal Institution of Chartered Surveyors.

**Chris Paris** is Emeritus Professor at the University of Ulster, UK and was Professor of Housing Studies at the University of Ulster from 1992 to 2008. He has held visiting professorships at Royal Melbourne Institute of Technology, Australia, and Hong Kong University, in Hong Kong, and visiting fellowships in many other universities including Cambridge and Oxford in the UK, and the Australian National University, La Trobe, Flinders and Queensland University of Technology in Australia. Paris has wide international experience of scholarly research as well as applied

research for government, statutory agencies and the private sector. His current research includes multiple homeownership in affluent societies and housing issues of ageing populations. Paris is author/co-author/editor of over 30 books, monographs and research reports on housing, planning and urban policy and over 100 journal publications. His most recent book, *Affluence, Mobility and Second Home Ownership*, was published in 2011 in the Routledge Housing and Society series.

**Choon-Piew Pow** is an Associate Professor in the Department of Geography at the National University of Singapore, in Singapore. His research focuses on the critical geographies of the urban built environment and interrogating the complex inter-relationship between urban forms and the social-spatial reproduction of urban life in Asian cities. His ongoing research project examines the planning discourses and practices revolving around the contested notions of 'urban sustainability' and the construction of 'eco-cities' in China. He is the author of the book *Gated Communities in China: Class, Privilege and the Moral Politics of the Good Life* published by Routledge in 2009.

**Susan M. Roberts** is Professor of Geography at the University of Kentucky, US. She is also a member of the Committee on Social Theory at the University of Kentucky. Her PhD is from Syracuse University, US. She has interests in political and economic geography, and in the political economy of inequality and development. She has published on global finance, the geopolitics of globalization, and the politics of non-governmental organizations in Mexico. She is co-author of *Economic Geography: Places, Networks, Flows*, with Andrew Wood (Routledge 2010). In 2006 she was awarded the Sturgill Prize for contributions to graduate education at the University of Kentucky. More recently she was named as the 2012–13 Fulbright University of Turku (Finland) Scholar.

**Richard H. Schein** is Professor of Geography at the University of Kentucky, US, where he also has affiliated appointments in American Studies, Historic Preservation, and the Committee on Social Theory. He writes about American cultural landscapes, with special attention to their historical development and imbrications with questions of race, cultural and social (re)production, democratic process and social justice. In 2011 he was named Distinguished Historical Geographer by the Association of American Geographers and *Historical Geography* and in 2012–13 he held the Fulbright Bicentennial Chair in American Studies at the University of Helsinki, Finland.

**John Rennie Short** is Professor of Public Policy at the University of Maryland Baltimore County (UMBC), US, and prior to this was Professor

of Geography at Syracuse University, US. From 1978 to 1990 he was Lecturer at the University of Reading, UK. He has held visiting appointments as Senior Research Fellow at the Australian National University, Australia, as the Erasmus Professor at Groningen University, the Netherlands, and as the Leverhulme Visiting Professor at Loughborough University, UK. Among his research fellowships are the Vietor Fellowship at Yale University, US, the Dibner Fellowship at the Smithsonian Institution, US, the Kono Fellowship at the Huntington Library, US, and the Andrew Mellon Fellowship at the American Philosophical Library, US.

His main research interests are in urban issues, environmental concerns and cartographic representation. Recent books include *Korea: A Cartographic History* (2012), *Globalization, Modernity and The City* (2012), *Cities and Suburbs* (2010), and *Cartographic Encounters* (2009). He is a founding co-editor of the journal *Society and Space*, founding editor of the book series *Space, Place and Society*, and founding co-editor of the *Critical Introduction to Urbanism* book series.

**Thomas Wainwright** completed his first degree at the University of Leicester, UK, and holds an MSc from the University of Nottingham, UK. Wainwright completed his ESRC-funded PhD in 2009 (University of Nottingham) where he investigated the UK mortgage market, wholesale banking, asset management and the unfolding of the credit crunch within the financial services sector. He then worked at the University of Nottingham as a Research Assistant on projects that examined wholesale-retail bank linkages and wealth management and subsequently as a Postdoctoral Researcher at the Small Business Research Centre (SBRC) at Kingston University, UK. He is currently at Southampton Management School, University of Southampton, UK. His research examines the effects of the credit crunch on small businesses and how older people are turning to 'older entrepreneurship' as a strategy to manage their financial needs in later life.

**Kathryn Wilkins** recently completed a PhD in historical geography at Durham University, UK. Her PhD combined an historical case-study with contemporary mobilities theory to investigate the importance of movement and networking to the existence of the London Season in the nineteenth century, and the impact this period had on the physical character of London's West End. She is the author of several journal articles and contributions to edited collections.

**Michael Woods** is Professor of Human Geography and Director of the Institute of Geography and Earth Sciences at the Aberystwyth University,

UK. His research focuses on rural geography and political geography, including work on rural elites and changing power structures, and, currently, on globalization and the emergent 'global countryside'. He is editor of the *Journal of Rural Studies* and author of several books including *Rural* (Routledge 2011), *Rural Geography* (Sage 2005) and *Contesting Rurality: Politics in the British Countryside* (Ashgate 2005).
