**Dr Ziliang Deng**, PhD (Nottingham), is Assistant Professor of International Business at Renmin University of China. **Professor Seamus Grimes** is Emeritus Professor of Economic Geography at the Whitaker Institute, National University of Ireland, Galway. He obtained his PhD at the University of New South Wales, and spent many years teaching geography at the National University of Ireland, Galway. His research focuses on multinational foreign investment in Ireland and China, with his current work looking at foreign R&D investment in China within the context of the new indigenous innovation policy. He has published widely in international journals.

**Professor Michael Keane** is Principal Research fellow at the Australian Research Council Centre of Excellence for Creative Industries and Innovation (CCI), Queensland University of Technology, Brisbane. He publishes and researches in China's innovation economy, international intellectual property discourses, and Chinese culture and history. He serves as the general editor of the *WIPO Journal* published by the World Intellectual Property Organization (WIPO). Professor Yu has spoken at events organised by WIPO, the International Telecommunication Union, the UN Conference on Trade and Development (UNCTAD), the UN Educational, Scientific and Cultural Organization (UNESCO), the Chinese, US and EU governments and at leading research institutions from around the world. His lectures and presentations have spanned more than 25 countries on six continents, and his publications have appeared in Chinese and English and have been translated into Arabic, French, Hausa, Japanese, Persian, Portuguese, Spanish and Vietnamese.

**Dr Zhang Zhicheng**, PhD in Law (Peking University), joined China's State Intellectual Property Office (SIPO) in 1995. He was also a Visiting

Scholar in the School of Law, University of Washington (2001). He assumed his present position as Deputy Director General of the Protection and Coordination Department in 2011 and Deputy Director of the Intellectual Property Development & Research Center in April 2013.
