May Fong Cheong is Professorial Visiting Fellow at the Faculty of Law, University of New South Wales. She was formerly Professor and Dean of the Faculty of Law, University of Malaya in Kuala Lumpur, Malaysia. She was called to the Malaysian Bar in 1986 and practiced for nearly three years before joining academia. Dr Cheong obtained her Bachelor of Laws from the University of Malaya, a postgraduate Diploma in Shariah Law and Practice from the International Islamic University Malaysia, Master of Laws from the National University of Singapore and Doctor of Philosophy from the University of Sydney. Her areas of specialization are contract law and competition law. In the area of contract law, she completed her PhD thesis on unfair contracts and has published three books and various articles, focusing particularly on the legal position in Malaysia. In the area of competition law, she has written on the Malaysian Competition Act 2010 as well as on the electricity, water services and telecommunications industries in Malaysia. Dr Cheong's current research interests are on Malaysian and Australian contract law and Asian competition and consumer law.

Allan Fels AO is Dean of the Australia and New Zealand School of Government (ANZSOG). He was Chairman of the Australian Competition and Consumer Commission (1995 to 2003), the Trade Practices Commission (1991 to 1995) and the Prices Surveillance Authority (1989 to 1992). He was co-chair of the OECD Trade and Competition Committee from 1996 to 2003. Professor Fels was Director of the Graduate School of Management of Monash University, and Professor of Administration at Monash University (1984 to 1991). He is currently the Chairman of the National Mental Health Commission and the Victorian Government's Taxi Industry Inquiry. He will be the Commissioner, Victorian Government Fire Services Levy Monitor. He is Chair of Visy Australasia's Governance Board, and of its Competition Law Compliance Committee and a consultant to Arnold Bloch Leibler. Professor Fels is Program Director of ANZSOG's China Advanced Leadership Program (CALP), Co-director of the UCAS Centre for Competition Law and Co-editor of the China Competition Bulletin. Professor Fels is also Chairman of the Haven Foundation. He was awarded the Order of

Australia in 2001. Professor Fels has a PhD in Economics from Duke University and degrees in Law and Economics from the University of Western Australia.

David Fruitman has had extensive competition experience working at two of Canada's leading competition law firms from 1996 to 2004 when he resigned his partnership and began backpacking. David is currently based in Phnom Penh, Cambodia and, since November 2006, has worked with DFDL, a leading regional law firm with offices or affiliates in eight countries. David is currently Regional Competition Counsel and Senior Advisor with DFDL. In this role, David has assisted clients with respect to competition law in Cambodia, Laos, Thailand and Vietnam. David has also written with respect to competition law and policy in the region in various electronic and print publications and has spoken on these matters at conferences and other venues in Cambodia, Thailand and Vietnam. David received his BA (economics) from the University of Toronto in 1996 and his JD from the University of Toronto Law School in 1995. She practiced as a solicitor in competition and commercial law for many years prior to joining UNSW. She advised on many major mergers, advised government bodies and state-owned enterprises, and other clients across a number of industries on the full range of competition law issues including compliance and dealing with Australian Competition and Consumer Commission. Deborah has a particular interest in the competition laws of China, Hong Kong and Singapore, and has spent time researching and teaching in a number of Asian jurisdictions. She teaches Asian Competition Law at UNSW. She is a member of the Association of Competition Law Academics (ASCOLA), the Asian Competition Forum and Asian Competition Law and Economic Law Centre at the Hong Kong Polytechnic University. Deborah is the author of many books, book chapters and journal articles, including several books in multi editions on Australian competition law, consumer protection and sports law, and editor of the Australian and New Zealand Sports Law Journal. body advising the Minister in Australia). She is a regular presenter at conferences in Australia and overseas.

Jaemin Lee is currently Professor of Law at the School of Law, Hanyang University in Seoul, Korea. He has been nominated as national panelist in the Korea–EU Free Trade Agreement (FTA) dispute settlement roster, the Korea–Chile FTA dispute settlement roster, and the WTO national panelist roster.

Yin Harn Lee is a PhD candidate at the Faculty of Law, University of Cambridge. She graduated with an LLB (Hons) (with distinction) from the University of Malaya, Kuala Lumpur, and subsequently obtained an LL.M. from the University of Cambridge. She is an Advocate and Solicitor of the High Court of Malaya, and has worked as a researcher and tutor in various areas of law. In 2002 Ian was recruited by the Singapore Ministry of Trade and Industry to advise on the policy, design, drafting and implementation of Singapore's new competition law. He subsequently became the first Chief Economist with the Singaporean Competition Commission. Ian has held visiting appointments at Oxford and the Graduate School of Business at the University of Chicago. He has appeared in Court many times as an expert witness in major competition law litigation in both Australia and New Zealand. He has a PhD in Economics and an LLB (Hons 1) both from the Australian National University and is admitted as a Legal Practitioner in the Australian Capital Territory. In 2011 he published *ASEAN Competition Law* (with Kala Anandarajah), LexisNexis and *Intellectual Property, Competition Law and Economics in Asia*, Hart Publishing, Oxford.

Pradeep S. He was a Fulbright grantee scholar at George Washington University Law School, Washington, DC (2009–10). He is a member of the Advisory Board of the *Antitrust Bulletin*, as well as a member of the Academic Society for Competition Law (ASCOLA), the Asian Competition Forum (ACF), and Asian Competition Association (ACA).

Sakda Thanitcul is Professor of Law and Dean at Chulalongkorn University Faculty of Law.
