Joel Andreas, Associate Professor of Sociology at Johns Hopkins University, Baltimore, US, studies political contention and social change in contemporary China. His recent book, *Rise of the Red Engineers: The Cultural Revolution and the Origins of China's New Class* (Stanford University Press, 2009), analyses the contentious process through which old and new elites coalesced during the decades following the 1949 Communist Revolution. He is currently investigating changing labour relations in Chinese factories between 1949 and the present.

Beatriz Carrillo is a Lecturer in the China Studies Centre and the Department of Sociology and Social Policy at the University of Sydney, Australia. She undertakes research on social change in China, especially at the local level. Her research concentrates on rural–urban migration and welfare issues. She is the author of *Small Town China* (Routledge, 2011) and, with Jane Duckett, *China's Changing Welfare Mix* (Routledge, 2011).

Anita Chan is a Research Professor at the China Research Centre of the University of Technology, Sydney, Australia. She has published widely on Chinese labour issues, rural China, Chinese youth and comparative labour. She is the author of *China's Workers Under Assault* (M.E. Sharpe, 2001), co-author of *Chen Village: Revolution to Globalization* (University of California Press, 2009), editor of *Walmart in China* (Cornell University Press, 2011) and editor of *Labour in Vietnam* (ISEAS Publishing, 2011). Her current research project is on the industrial relations of China's auto industry.

David S.G. Goodman is Academic Director of the China Studies Centre, University of Sydney, Australia, where he is also Professor of Chinese Politics. His research concentrates on social and political change in China since the beginning of the twentieth century, especially at the local level. He is the editor of the *New Rich in China* (Routledge, 2008) and the author of *Class and Social Stratification in China* (Polity Press, 2012).

Parry P. Leung is a Lecturer at the Community College of City University of Hong Kong. His research interests include the Chinese working class,

labour disputes and social movement. He is currently a PhD candidate at Hong Kong University of Science and Technology researching the strikes and struggles of peasant workers in South China.

Jack Linchuan Qiu is Associate Professor at the School of Journalism and Communication, the Chinese University of Hong Kong. He researches on information and communication technologies (ICTs), class, globalization and social change.

Kaxton Siu is a doctoral candidate at the Department of Political and Social Change at the Australian National University, Acton, ACT. He conducts comparative labour research on the garment industry in China and Vietnam. He has published on labour and youth issues in *Critical Asian Studies* and *Youth & Society*. His most recent book in Chinese is *Stay Left: Class Politics in China and Hong Kong in the Twenty First Century* (2011).

Alvin Y. So is a Chair Professor at the Division of Social Science at Hong Kong University of Science and Technology. His research interests include development, class conflict and historical changes. He is the author of *Hong Kong's Embattled Democracy* (Johns Hopkins University Press, 1999), the editor of *China's Developmental Miracle* (M.E. Sharpe, 2003) and co-editor of *The Handbook of Contemporary China* (World Scientific, 2011).

Luigi Tomba is a political scientist and an Associate Director of the Australian Centre on China in the World, Australian National University, Acton, ACT. His recent research interests have been China's social stratification, the middle classes, housing, urbanization and urban governance. He is currently involved in three separate projects on social change and urbanization in the Pearl River Delta funded by the Australian Research Council and the German Research Foundation. He is, since 2005, the co-editor of *The China Journal*.

Jonathan Unger, a sociologist, is a Professor in the Australian National University's Political and Social Change Department and is Director of the ANU's Contemporary China Centre, Acton, ACT. He has published more than a dozen books about China, including *Education Under Mao: Class and Competition in Canton Schools* (Columbia University Press, 1982), *The Transformation of Rural China* (M.E. Sharpe, 2002) and, as co-author with Richard Madsen and Anita Chan, *Chen Village: Revolution to Globalization* (University of California Press, 2009). He co-edited *The China Journal*, one of the two pre-eminent journals in the field, for 18 years from 1987 to 2005.

Hongzhe Wang is a PhD candidate in the School of Journalism and Communication, the Chinese University of Hong Kong. He received his MA in Mass Communication at Peking University, Beijing. His research interests include culture space, class and the history of new media.
