Ira Belkin is Executive Officer at the US-Asia Law Institute, School of Law. Prior to joining NYU's US-Asia Law Institute in September 2012, he worked on law and rights issues from the Foundation's Beijing office where his grant making supported Chinese institutions working to build the Chinese legal system, to strengthen the rule of law and to enhance the protection of citizens' rights. Before coming to the Foundation in 2007, Ira combined a career as an American lawyer and federal prosecutor with a deep interest in China, and spent seven years working to promote the rule of law in China. His appointments included two tours at the US Embassy in Beijing and a year as a fellow at the Yale Law School China Law Center. Previously, he was a federal prosecutor in Providence, RI, where he was chief of the criminal division, and in Brooklyn, NY, where he was deputy chief of the general crimes unit. Before attending law school, Ira taught Chinese language at Middlebury College. He has lectured extensively in Chinese to Chinese audiences on the US criminal justice system and to American audiences on the Chinese legal reform movement. He has a JD from New York University School of Law, a master's degree in Chinese studies from Seton Hall University and a bachelor's degree from SUNY Albany.

Sarah Biddulph is Associate Professor and Reader in the Law School, University of Melbourne, Australia where she teaches and researches in the area of Chinese law. Her work focuses on contemporary Chinese administrative law, criminal procedure, labour, comparative law and the law regulating social and economic rights. Her recent publications include; *Legal Reform and Administrative Detention Powers in China* (Cambridge University Press, 2007) and she was co-editor of *Examining Practice Interrogating Theory: Comparative Legal Studies in Asia* (Brill, 2008). She has been working on a project with Associate Professor Sean Cooney and Associate Professor Zhu Ying looking at the regulatory responses to wages arrears in China. She currently holds a research fellowship from the ARC to work on the recent reforms to the police administrative detention powers in China. This project includes an examination of reforms to compulsory detention for treatment of drug-dependent people.

Chen Guangzhong is Professor of Law at the China University of Political Science and Law, Beijing, China, and is one of the doyens of procedural law studies in China. He is Professor of Law, former President of China University of Political Science and Law, where he was also supervisor for PhD candidates. He is Honorary President of the Criminal Procedure Law Research Association and Vice President of the China Law Society. Professor Chen graduated from Peking University with a degree in law in 1952. He is Member of the PRC State Council's Degree Conferring Committee Peer Review Group (Law), Member of the PRC Supreme People's Procuratorate and PRC Supreme People's Court Academic Advisory Committees, and holds visiting and honorary professorships at a number of distinguished Chinese universities. Professor Chen's teaching and research interests mainly include the judicial and legal system, criminal procedure, and evidence. He held a leading position in an academic circle advocating for reform of the Criminal Procedure Law in China in 1996. Professor Chen has undertaken various projects at international, national and ministerial level and published many books and journal articles on the revision of criminal procedure law, evidence, the implementation of the criminal procedure law, non-prosecution mechanisms, and compulsory measures, as well as the issue of ratification and implementation of the International Covenant on Civil and Political Rights.

Chen Weidong is Professor of Law at Renmin University of China Law School, Beijing, China, where he is Director of the Procedural Law Teaching and Research Center, Executive Director of the Research Center for Criminal Jurisprudence, and Academic Supervisor for PhD candidates. His research interests and teaching mainly focus on criminal procedure law, evidence, the legal profession, sentencing procedure, fighting against torture, bail and the judicial system. Professor Chen is Vice President of the Criminal Procedure Law Research Association of the China Law Society, member of the PRC Supreme People's Procuratorate Advisory Committee and legal advisor to a number of Chinese justice institutions at the provincial or municipal level. He has undertaken a number of important research projects sponsored at international, national and ministerial level, including a research project on the construction of efficient and authoritative socialist judicial system.

Jerome A. Cohen is Professor of Law and Co-Director of the US-Asia Law Institute, New York University School of Law, where he has been a professor since 1990. He is a leading American expert on Asian law. A pioneer in the field, he began studying Chinese criminal law in the early 1960s and from 1964 to 1979 introduced the teaching of Asian law into the curriculum of Harvard Law School, where he served as Jeremiah Smith Professor

and Associate Dean. In addition to his responsibilities at NYU, he served for several years as CV Starr Senior Fellow and Director of Asia Studies at the Council on Foreign Relations, where he currently is an Adjunct Senior Fellow. He retired from the partnership of Paul, Weiss, Rifkind, Wharton & Garrison LLP at the end of 2000. He also continues to serve as an arbitrator in many Asian legal disputes. Professor Cohen has published several books on Chinese law, including *The Criminal Process in the People's Republic of China, 1949–63*. Today, he continues his research and writing on Asian law, specifically focusing on criminal justice reform, dispute resolution, human rights and the role of international law. Outside academia, he has served in government from 1958 to 1959. He has also testified at many congressional hearings on China. He is a Phi Beta Kappa graduate of Yale College (BA 1951). He was a Fulbright Scholar in France 1951–52 and graduated from Yale Law School in 1955. He was Law Secretary to Chief Justice Earl Warren of the United States Supreme Court in the 1955 Term and Law Secretary to Justice Felix Frankfurter of the Supreme Court in the 1956 Term.

Ian Dobinson is Senior Lecturer in the Law Faculty at the University of Technology, Sydney, Australia. Prior to this he was an associate professor at the School of Law, City University of Hong Kong (1989–2002). He received his BA/LLB from the University of New South Wales and LLM from the University of Sydney. He has written, researched and taught extensively in the areas of criminal law and criminal justice. During his 13 years in Hong Kong, he developed a keen interest in Chinese Criminal Law, completing his LLM thesis on this topic in 2001. Since arriving at UTS, he has continued both his research and teaching links with Hong Kong and China.

Fu Hualing is Professor of Law, Faculty of Law, University of Hong Kong, Hong Kong SAR where he is Director of the Centre for Comparative and Public Law. He received his LLB at Southwestern University of Political Science and Law, Chongqing, China (1983); MA at the University of Toronto, Canada (1988); and Doctor of Jurisprudence at Osgoode Hall Law School, York University, Toronto, Canada (1993). Before joining the University of Hong Kong, he was Assistant Professor at Southwestern University of Political Science and Law and Assistant Professor, City University of Hong Kong. His research interests include constitutional law and human rights, with a special focus on the criminal justice system and media law in China, corruption, and legal relations between Hong Kong and Mainland China. He has published widely in both local and international journals. He is also the China Law editor for *Hong Kong Law Journal*.

He Jiahong is Professor of Law and Director of the Institute of Evidence Law, the School of Law, Renmin University of China. He was conferred the degree of Doctor of Juridical Science (SJD) by Northwestern University, USA, in 1993. His research interests include evidence law, criminal investigation, criminal procedure and comparative study of criminal justice systems. He served as Deputy Director (part-time) of the Department of Anti-dereliction and Infringement on Human Rights, the Supreme People's Procuratorate from 2006 to 2008. His work includes three series and 15 volumes.

He Ran is Lecturer at the College of Humanities and Law, North China University of Technology, Beijing, a position she assumed in 2010. She teaches courses on economic law, competition law, company law and legal negotiation. Her research interests focus on economic law, competition law and criminal justice. She obtained her BEc and PhD degrees from China Renmin University in 2005 and 2010 respectively. In addition, she obtained an LLM degree from the City University of Hong Kong in 2007. Her recent representative publications include 'The Perception that the US Helps China's Anti-corruption Efforts is a Misunderstanding' (*Legal Daily*), 'Evidentiary Issues in Wrongful Conviction Cases' (*Tribune of Political Science and Law*) and 'Admission Fee Paid to a Supermarket Does Not Constitute Commercial Bribery' (*People's Procuratorial Bimonthly*). Her current research project is on the role of judicial precedents in the process of establishing the rule of law.

Jiang Jue is a PhD candidate in the Faculty of Law, Chinese University of Hong Kong, Hong Kong SAR. She holds an LLM degree from CUHK Faculty of Law and an LLB degree from the Southwest University of Political Science and Law in Chongqing, China. Her doctoral dissertation is on the topic of 'Criminal Reconciliation in the People's Republic of China'.

Lan Rongjie is Lecturer at Zhejiang University Guanghua Law School, Hangzhou, China. Before taking up this post, he received SJD from Temple University USA 2010 and Sichuan University in 2008. His research interests and teaching mainly focus on judicial system, criminal procedure, and clinic education. In his spare time, he also engages in some legal aid or lawyering services.

Stanley B. Lubman is Distinguished Lecturer Emeritus, Senior Fellow of the Miller Institute for Global Challenges and the Law, University of California at Berkeley, USA. He has specialised on China as a scholar and as a practising lawyer for more than 40 years. He first taught at Boalt from 1967 to 1974, and returned in 2002. In the meantime, he taught

at Stanford, Columbia, Harvard, the University of Heidelberg, and the SOAS of the University of London. He has advised American, European and Japanese clients on China since 1972 on a wide range of matters, and also represented clients in disputes arbitrated by the China International Economic and Trade Arbitration Commission in Beijing. From 1978 to 1997 he headed the China practices at two major San Francisco law firms and a large English firm of solicitors. Since 1997 he has devoted his time to scholarly research, teaching and non-profit activities. He is advisor on China legal projects to the Asia Foundation and worked on a number of law reform projects in China related to administrative procedure and revision of China's land law. He was trained as a China specialist in the United States and in Hong Kong for four years (1963–67). He has an AB degree from Columbia College and LLB, LLM, and JSD degrees from the Columbia Law School. He has also studied at the University of Paris. His writings on Chinese law and related subjects have been widely published and include *China's Legal Reforms* (1996); *Bird in a Cage: Legal Reform in China after Mao* (2000); and *Engaging the Law in China: State, Society, and Possibilities for Justice* (co-editor, 2005).

Ma Jinghua is Associate Professor of Law, Sichuan University School of Law. He received his LLB from Southwest University of Political Science and Law in 1989 and his LLM from Sichuan University Faculty of Law in 1999. He has held appointments at Sichuan Police College, receiving an exceptional promotion to associate professor in 2003, and has taught at Sichuan University Faculty of Law since 2005. His research interests are in the areas of procedural law and criminal justice.

Mike McConville is Research Professor, Centre for Rights and Justice, Faculty of Law, The Chinese University of Hong Kong, Hong Kong SAR. He is a leading socio-legal scholar specialising in empirical research. He was the Director of the Legal Research Institute (1988–97), Reader in Law (1988–89), Chairman of the School of Law (1993–2001), Professor of Law (1989–2005) at the University of Warwick, UK, and Walter E Meyer Professor at New York University (1984–85). He has researched and written on such topics as police interrogation, legal aid and assistance, plea bargaining, trial by jury, the working practices of estate agents, and legal history. He has undertaken advisory work in countries undergoing major social transition such as Latvia, Malawi, Turkey, and Peru. The projects he has completed are: *An Empirical Study of the Criminal Justice System in China*, *The Birth of the Modern Criminal Justice System in New York City*; *The Corroboration of Confessions in Criminal Cases*; *Negotiated Justice*; *Custodial Legal Advice and the Right to Silence*; *The Defence Work of Solicitors in Criminal Cases*; *Community Policing and*

Neighbourhood Watch; Police and Prosecutorial Discretion; Pre-trial Proceedings and the Prosecution Process; The Importance of Confession Evidence in Crown Court Cases; The Outcome of Contested Trials in the Crown Court; Plea Settlements in the Crown Court; Black Defendants and Criminal Justice; Human Rights in Turkey and Jury Trials and the Origins of Plea Bargaining.

Stacy Ann Mosher is a New York-based translator and editor with a special focus on China's social and political issues, including most recently, Yang Jisheng's *Tombstone: The Great Chinese Famine 1958–1962* (FSG, 2012).

Elisa Nesossi is Post-doctoral Fellow, College of Asia and the Pacific, Australian National University, Canberra, Australia. Prior to joining ANU, she was a senior teaching fellow at SOAS (School of Oriental and African Studies, University of London), and worked at the Rights Practice as a researcher. She has a PhD in law and her research interests are China's criminal justice system and its relationship with international human rights standards. In particular, she is actively working on the protection of criminal suspects' rights at the pre-trial stage of the criminal process with specific reference to pre-trial detention.

Eva Pils is Associate Professor, Centre for Rights and Justice, Faculty of Law, The Chinese University of Hong Kong, Hong Kong SAR. She studied in Heidelberg, London and Beijing, and holds a PhD in law from the University of London. Prior to joining CUHK Faculty of Law, she held part-time teaching and visiting positions at Cornell Law School, New York University School of Law, and University College London. Her scholarship focuses on human rights and China, with publications addressing the role and situation of Chinese human rights defenders, property law and land rights in China, the status of migrant workers, the Chinese petitioning system and conceptions of justice in China. She is the current director of the CUHK Centre for Rights and Justice and a Non-resident Senior Research Fellow of the US-Asia Law Institute at New York University.

Joshua D. Rosenzweig is a PhD Candidate, Centre for East Asian Studies, Chinese University of Hong Kong, Hong Kong SAR. Prior to joining the Centre for East Asian Studies, he worked with Dui Hua Foundation, overseeing the Foundation's research activities while heading up the Foundation's office in Hong Kong. After joining Dui Hua in 2002, he developed Dui Hua's comprehensive database of information about Chinese political and religious prisoners. A graduate of the University of California at Berkeley (MA, CPhil in Modern Chinese History) and Swarthmore College (BA in Asian Studies with highest honours), he is

fluent in Mandarin Chinese and has extensive research experience in Chinese archives and libraries.

Flora Sapio is Research Assistant Professor, Faculty of Law, Chinese University of Hong Kong, Hong Kong SAR. She received her MA Degree in 2000 at the Università degli Studi di Napoli L'Orientale, Italy, and her PhD in China Studies in 2004 at the Università la Sapienza, Rome, Italy. She was a post-doctoral researcher at Lund University, Sweden (2004–06). She is currently a research fellow at the Centre for Advanced Studies on Contemporary China (Turin, Italy) a Visiting Professor at the Julius-Maximilians Universität, Würzburg, Germany, and a Visiting Scholar at the Centre for Rights and Justice at the Faculty of Law of the Chinese University of Hong Kong in 2011–12. Her main research interests are criminal justice, administrative detention, extra-legal violence and coercion. She is among the founding members of the European China Law Studies Association.

Thomas Stutsman is Robert L Bernstein Fellow in International Human Rights, Vera Institute of Justice and Visiting Scholar, Harvard Law School, USA. He holds a JD from Yale Law School, an LLM from Sichuan University Law School, and a BA from Minnesota State University. He provides general support for the Vera Institute of Justice's work on Chinese criminal justice reform. He has conducted research on a range of issues related to the Chinese criminal justice system. He has held positions related to Chinese law at the Congressional-Executive Commission on China, Harvard Law School, the Vera Institute of Justice, the Yale China Law Center, and several other institutions.

Teng Biao is Lecturer at China University of Political Science and Law, Visiting Scholar at the Centre for Rights and Justice, CUHK Faculty of Law and Director of China Against Death Penalty, Beijing, China. He holds a PhD from Peking University Law School. In 2003, he was one of the 'Three Doctors of Law' who complained to the National People's Congress about unconstitutional detentions of internal migrants in the widely known 'Sun Zhigang Case'. Since then, he has provided counsel in numerous other human rights cases, including those of rural rights advocate Chen Guangcheng, rights defender Hu Jia, the religious freedom case of Wang Bo, and numerous death penalty cases. He has also co-founded two groups that have combined research with work on human rights cases: 'Open Constitution Initiative' (Gongmeng) and 'China Against Death Penalty'.

Yu-Jie Chen is a JSD candidate and a US-Asia Law Institute Research Fellow (on leave) at New York University School of Law, New York, USA. Her research areas include legal institutions and law reforms in

Taiwan and China with a focus on criminal justice and human rights. Prior to joining the Institute, she was the 2009 Robert L Bernstein Fellow in International Human Rights of NYU School of Law. Under the Fellowship, she worked on research and advocacy concerning human rights in China and the UN human rights regime. She received her LLM from NYU School of Law, where her focus was international law. She is a Taiwan lawyer.

Zhiyuan Guo is Associate Professor of Law, China University of Political Science and Law, Beijing, China, where she specialises in criminal procedure, evidence, and human rights. She is an adjunct research fellow at the Center for Criminal Law and Justice, CUPL and a Non-resident Senior Research Fellow at US-Asia Law Institute, New York University School of Law. She was appointed as Kwuanghai Visiting Scholar for 2008–09. She is a Phi Beta Kappa graduate of China University of Political Science and Law in Beijing (1997) and also received her LLM and PhD degrees in criminal procedure from the China University of Political Science and Law in 2000 and 2003 respectively. She has published extensively in journals such as *China Legal Science*, *Comparative Law Review* and *China Criminal Law Journal*. Her current research focuses on medical examinations in capital cases and criminal proceedings for death penalty cases.

Zuo Weimin is Professor of Law, Deputy Dean, School of Postgraduate Studies, Sichuan University, Chengdu, China. One of the top ten Chinese Young Jurists in 2004, he is currently Deputy Dean of Postgraduate Studies, Supervisor for PhD candidates, and Director of China Judicial Reform Research Center at Sichuan University. He received his LLB, LLM, and PhD degrees from Southwest University of Politics and Law (Chongqing) in 1988, 1995 and 1999 respectively. He is Visiting Scholar at several renowned overseas universities. He has undertaken a number of important research projects at the national or ministerial level in China. His research interests include criminal procedure, evidence, judicial reform and the court system. He has published more than ten books and 100 articles.
