**Bo Zhiyue** is Director of the New Zealand Contemporary China Research Centre and Professor of Political Science at Victoria University of Wellington, New Zealand. His research interests include China's elite politics, Chinese provincial leaders, central–local relations, cross-strait relations, Sino–US relations, international relations theories and global governance. He is the author of a trilogy on China's elite politics, including *Chinese Provincial Leaders: Economic Performance and Political Mobility since 1949* (2002), *China's Elite Politics: Political Transition and Power Balancing* (2007) and *China's Elite Politics: Governance and Democratization* (2010).

**Shaun Breslin** is Professor of Politics and International Studies at the University of Warwick, UK, where he is also Director of the Centre for the Study of Globalisation and Regionalisation. He is an Associate Fellow of the Chatham House Asia Programme, and co-editor of the *Pacific Review*. His research focuses on the international political economy and international relations of contemporary China, with a side interest in the comparative study of regional integration processes.

**Kerry Brown** is Director of the China Studies Centre, University of Sydney, Australia, where he is also Professor of Chinese Politics.

**Alberto Camarena** is currently a lecturer at the Panamerican Institute Business School (IPADE) and the Universidad Iberoamericana, both in Mexico City. His main research interests are the international relations of the Asia-Pacific, China–Southeast Asia relations and Chinese nationalism.

**Carolyn Cartier** is Professor of Human Geography and China Studies at the University of Technology, Sydney, Australia. She works on comparative analysis of changes to the administrative divisions in China.

**Chen Gang** is Research Fellow at the East Asian Institute, National University of Singapore. His research focuses on China's environmental policies, and he provides consultancy for the Singapore government on environmental and energy issues in East Asia. He is the author of *China's Climate Policy* (2012).

**Minglu Chen** is a lecturer in the China Studies Centre and the Department of Government and International Relations at the University of Sydney, Australia. Her research concentrates on social and political change in China, especially the interaction between entrepreneurs and the state. She is the author of *Tiger Girls: Women and Enterprises in the People's Republic of China* (2011).

**John A. Donaldson** is Associate Professor of Political Science at Singapore Management University. His research focuses on China's regional development issues. He serves as a Senior Research Fellow with the Lien Centre for Social Innovation, working with the Singapore Management University Change Lab to research and design

innovative solutions to unmet needs in vulnerable communities in Singapore. He is the author of *Small Works: Poverty and Economic Development in Southwestern China* (2011).

**Jörn Dosch** holds the Chair of International Politics and Development Cooperation and is Head of the Department of Political and Administrative Sciences at the University of Rostock, Germany. He is also Adjunct Professor at Monash University, Sunway Campus, Malaysia. He has published widely on the international politics of the Asia-Pacific region, the foreign policies of Asian nations including China, and the Association of Southeast Asian Nations (ASEAN), and is co-editor of the journal *International Quarterly for Asian Studies*.

**Jane Duckett** is Edward Caird Chair of Politics and Director of the Scottish Centre for China Research at the University of Glasgow, UK. Her research interests are in contemporary Chinese governance and politics, particularly social and health policy. Her publications include *The Entrepreneurial State in China* (1998), *The Chinese State's Retreat from Health: Policy and the Politics of Retrenchment* (paperback 2013), and (with Beatriz Carrillo) *China's Changing Welfare Mix: Local Perspectives* (2011).

**Bates Gill** is Chief Executive Officer and Professor of Politics at the United States Studies Centre at the University of Sydney, Australia. He formerly led the Stockholm International Peace Research Institute as well as Asia-focused policy research programmes at the Brookings Institution and the Center for Strategic and International Studies in Washington, DC. He is the author, co-author or editor of a large number of publications, including *Rising Star: China's New Security Diplomacy* (2010).

**David S.G. Goodman** is Professor and Head of the Department of China Studies at Xi'an Jiaotong-Liverpool University, Suzhou, China, and Professor in the School of Social and Behavioural Sciences at Nanjing University, China. His recent research has focused on issues of class and the formation of elites in China, and he is the author of *Class in Contemporary China* (2014).

**Yingjie Guo** is Professor of Chinese Studies at the University of Sydney, Australia. His research interests include class discourses in the People's Republic of China and cultural nationalism in the post-Mao era. He is currently working on two volumes, *Handbook of Class and Stratification in the People's Republic of China* and *Local Elites in Post-Mao China*.

**Jennifer Y.J. Hsu** is Assistant Professor in the Department of Political Science at the University of Alberta, Canada. She is currently researching the internationalization of Chinese non-governmental organizations (NGOs) and their role in international development.

**Hu De** is a lecturer in the School of Urban and Regional Science at East China Normal University in Shanghai, China. He writes on China's spatial economic development and is the author of *The Spatial Process of Power and Regional Economic Development* (2011).

**You Ji** is Professor of International Relations in the Department of Government and Public Administration at the University of Macau. He is author of three books, including *The Armed Forces of China* and *China's Enterprise Reform*.

**Kazuko Kojima** is an Associate Professor, Faculty of Law, Keio University, Japan. Her research focuses on Chinese politics and social organizations. **Fengliang Li** is an Associate Professor of the Economics of Education, the Institute of Education, Tsinghua University, China. He has published extensively in both Chinese and international journals, especially on issues concerning the graduate labour market in China.

**Linda Chelan Li** is Professor of Political Science at the Department of Public Policy and Associate Provost (Strategic Planning) at the City University of Hong Kong. Her research on China covers topics of central–local relations, politics of public finance, government reforms, policy implementation, law and reform, and institutional change processes. She is the editor of *Good Governance in Asia* (2015) and the author of *Rural Tax Reform in China* (2012).

**W. John Morgan** is United Nations Educational, Scientific and Cultural Organization (UNESCO) Chair of Political Economy and Education, School of Education; Senior Fellow, the China Policy Institute, University of Nottingham, UK; and Honorary Professor, School of Social Sciences, Cardiff University, UK. His current research is on post-school education and economic and social change in the BRICS countries (Brazil, Russia, India, China, South Africa), especially China and Russia. He is the editor (with B. Wu) of *Higher Education Reform in China: Beyond the Expansion* (2011 and 2013) and of *Chinese Higher Education Reform and Social Justice* (2015). He is a Fellow of the Royal Society of Arts, the Royal Anthropological Institute and the Learned Society of Wales.

**Barry Naughton** is Professor of Chinese Economy at the University of California, San Diego, USA. His work concentrates on issues relating to industry, trade, finance and China's transition to a market economy.

**Jean C. Oi** is the William Haas Professor in Chinese Politics in the Department of Political Science and a Senior Fellow of the Freeman Spogli Institute for International Studies at Stanford University, USA. She directs the Stanford China Program and is the founding Lee Shau Kee Director of Stanford's Center at Peking University, China. Current writing projects include the politics of corporate restructuring, as well as the challenges of governance in China's rapid urbanization. Most recently she has been doing fieldwork on the organization of rural communities and the provision of public goods, especially affordable housing. She also continues her research on rural finance and local governance in China.

**Lynette H. Ong** is Associate Professor in the Department of Political Science, and Asian Institute, Munk School of Global Affairs, at the University of Toronto, Canada. She is

the author of *Prosper or Perish: Credit and Fiscal Systems in Rural China* (2012). Her research interests are authoritarian politics, social mobilization and the political economy of development.

**James Reilly** is a senior lecturer in the Department of Government and International Relations at the University of Sydney, Australia. He is the author of *Strong Society, Smart State: The Rise of Public Opinion in China's Japan Policy* (2012), and the co-editor of *Australia and China at 40* (2012). He previously served as the East Asia Representative of the American Friends Service Committee (AFSC) in China from 2001 to 2008.

**Shogo Suzuki** is a Senior Lecturer in the Department of Politics at the University of Manchester, UK. His work concentrates on Chinese and Japanese foreign policy, and Sino-Japanese relations.

**Wang Guohui** is an Associate Professor at Yantai University, China, and a postdoctoral researcher in the Center for Comparative Politics and Economics at the Central Compilation and Translation Bureau. He is author of *Tamed Village Democracy: Elections, Governance and Clientelism in a Contemporary Chinese Village* (2014).

**Wang Zheng** is an Associate Professor of Women's Studies and History and Associate Research Scientist of the Institute for Research on Women and Gender at University of Michigan, USA. Wang Zheng's publications concern feminism in China, in terms of both its historical development and its contemporary activism, and changing gender discourses in China's socio-economic, political and cultural transformations of the past century. Her recent research projects deal with gender and socialist state formation in the Mao era, and contemporary feminist activism in China in a global context. An academic activist, Wang Zheng is a founding member of the diaspora organization, Chinese Society for Women's Studies. She is the founder and co-director of the UM-Fudan Joint Institute for Gender Studies at Fudan University, Shanghai, China.

**Yan Xu** is a doctoral student in political science at the University of Chicago, USA.

**Dali L. Yang** is the William Claude Reavis Professor in the Department of Political Science at the University of Chicago, USA and the founding Faculty Director of the University of Chicago Center in Beijing, China. His current research is focused on the politics of China's development, particularly risk regulation and governance, and state–society relations.

**Xiaowei Zang** is Chair Professor and Dean of the College of Liberal Arts and Social Sciences at City University of Hong Kong. **Zheng Yongnian** is Professor and Director of East Asian Institute, National University of Singapore. He is the editor of *China: An International Journal* and *East Asian Policy*.
