**Candida G. Brush** holds the Franklin W. Olin Chair in Entrepreneurship, and is Division Chair for Entrepreneurship at Babson College, Boston, USA. A Research Director of the Arthur M. Blank Center for Entrepreneurship, Professor Brush holds an honorary doctorate in business and economics from Jonkoping University, Sweden, and is a visiting adjunct at the Nordlands University Graduate School of Business in Bodø, Norway. She is co-founder of the Diana Project, and recipient of the International Entrepreneurship Research Award for her pioneering work on women's entrepreneurship. She has published more than 120 scholarly articles and serves on several editorial review boards.

**Janice Byrne** is Assistant Professor at IÉSEG School of Management, Paris, France. Her research interests include entrepreneurship, gender, training and development. Her PhD comprised four papers looking at entrepreneurship education and training for women, corporate managers and engineers. Dr Byrne has published her research in the *Academy of Management Learning and Education*, and *Industry and Higher Education*, as well as in numerous book chapters.

**Stephanie Chasserio** is Associate Professor at the Department of Management, Leadership and Organization, SKEMA Business School, Lille, France. She holds a PhD from University of Québec at Montréal, Canada. Her dissertation was on work–family practices and policies in new economy firms. Currently, she works on topics such as women entrepreneurship, well-being at work, psychosocial risk and fairness in management.

**Susan Coleman** is a Professor of Finance at the University of Hartford, in West Hartford, Connecticut, USA. He was previously Dean of Queen's University Management School, Belfast, UK, has held chairs at Edinburgh, Aberdeen and Ulster, and visiting positions in China, Australia and the USA. His research focuses on the dynamics and impact of the entrepreneurial process, and he has published eight books and over 150 scholarly articles. He is founding co-editor of *Venture Capital: An International Journal of Entrepreneurial Finance*, and sits on several editorial review boards.

**Colette Henry** is Head of Department of Business Studies at Dundalk Institute of Technology, Ireland and Adjunct Professor of Entrepreneurship

at Tromsø University Business School, Norway. Prior to this, Colette held the Norbrook Chair in Business and Enterprise at the Royal Veterinary College (RVC), University of London, UK, and was President of the Institute for Small Business and Entrepreneurship (ISBE), UK. Colette is also founding editor of the *International Journal of Gender and Entrepreneurship*, and has published widely on entrepreneurship education and training, programme evaluation, gender, the creative industries, and women and veterinary business.

**Kathryn Ibata-Arens** is Director of Global Asian Studies and Associate Professor of Political Economy at DePaul University, USA. She specializes in high technology policy and the Japanese political economy. Her current work is on biomedical entrepreneurship and 'networked technonationalism' in Asia. Her book *Innovation and Entrepreneurship in Japan: Politics, Organizations and High Technology Firms* (2005) analysed strategic networks of high-technology firms and regional economies in Kyoto, Osaka and Tokyo.
