**Rick Aalbers** is an assistant professor in Strategy at the Department of Business Administration of the Radboud University Nijmegen, The Netherlands. He won the 2012 Richard Beckhard Memorial Prize for the most outstanding *MIT Sloan Management Review* article on planned change and organizational development published in the previous year.

**Morris Altman** is a former visiting scholar at Cornell, Duke, Hebrew and Stanford Universities, and currently Elected Visiting Fellow at St. Edmund's College, Cambridge University. Morris is Dean and Head, Newcastle Business School, and Professor of Behaviour and Institutional Economics, University of Newcastle, Australia and was Head of the School of Economics and Finance and Professor of Behavioural and Institutional Economics, Victoria University of Wellington, New Zealand and is Professor Emeritus, University of Saskatchewan, Canada. He was President of the Society for Advancement of Behavioral Economics from 2003 to 2006 and President of the Association for Social Economics in 2009. Altman is co-editor of the *Review of Behavioral Economics* and was former editor of the *Journal of Socio-Economics* and former associate editor of the *Journal of Economic Psychology*. He has published over 100 refereed papers on behavioral economics, economic history and empirical macroeconomics and five books in economic theory and public policy and has made well over 200 international presentations on these subjects. He earned his PhD in economics from McGill University in 1984.

**David B. Audretsch** is Director of the Research Group on Entrepreneurship, Growth and Public Policy at the Max Planck Institute of Economics, Germany. He also serves as Distinguished Professor and Ameritech

Chair of Economic Development at Indiana University, USA, and is a Research Fellow of the Centre for Economic Policy Research, London. His research has focused on the links between entrepreneurship, government policy, innovation, economic development and global competitiveness. His most recent book, *The Entrepreneurial Society*, was published by Oxford University Press in 2007. He was awarded the 2001 International Award for Entrepreneurship and Small Business Research by the Swedish Foundation for Small Business Research.

**Pranab Bardhan** is Professor of Graduate School in the Department of Economics at the University of California at Berkeley, USA, and co-chair of the MacArthur Foundation-funded Network on the Effects of Inequality on Economic Performance. He has authored or edited in all 26 books, including *Awakening Giants, Feet of Clay: Assessing the Economic Rise of China and India* (Princeton University Press, 2013), *Scarcity, Conflicts, and Cooperation* (MIT Press, 2004) and *International Trade, Growth, and Development* (Blackwell, 2003). He was chief editor of the *Journal of Development Economics* from 1985 to 2003.

**Paul D. Bush** is Professor Emeritus of Economics, California State University, Fresno, USA. He is a past president of both the Association for Evolutionary Economics and the Association for Institutional Thought, and an honorary lifetime member of the European Association for Evolutionary Political Economy. He has served as a referee for the *Journal of Economics Issues* intermittently since the 1980s, and he is a lifetime member of the International Advisory Board of the *Journal of Institutional Economics*. His research and writing have focused on the theory of institutional change and the pragmatic instrumentalist foundations of original institutional economics (OIE). He received the Veblen-Commons Award in 2009.

**José Castro Caldas** is a researcher at Centre for Social Studies (CES) of Coimbra University, Portugal. Previously he was an assistant professor at ISCTE-IUL, Lisbon. He was educated at the Technical University of Lisbon (Master in Operations Research and Artificial Intelligence in 1992) and ISCTE-IUL (PhD in Economics in 2000). He has done research, and taught and published in multi-agent simulation applied to economics and the history and epistemology of economics. Currently he is engaged in the Observatory on Crisis and Alternatives of CES, devoted to the study of the causes and consequences of the crisis in Portugal and the design of policy alternatives to austerity and internal devaluation.

He is primarily interested in the political economy of the small firm with special reference to the UK and the EU, and the relationship between SME policy and globalization. From this perspective he has also examined issues relating to risk, social capital and the role of the international in French regulation theory. He received his PhD in Economics from the University of Massachusetts, USA and his MA degree in Industrial Relations from Warwick University, UK. His books include *The Economist's Oath* (Oxford University Press, 2011) and *Global Economy, Global Justice: Theoretical Objections and Policy Alternatives to Neoliberalism* (Routledge, 2000), and he is the co-editor with Deirdre McCloskey of the *Oxford Handbook of Professional Economic Ethics* (Oxford University Press, 2015). **Ashwini Deshpande** is Professor of Economics at the Delhi School of Economics, University of Delhi, India. Her PhD and early publications have been on the international debt crisis of the 1980s. Subsequently, she has been working on the economics of discrimination and affirmative action issues, with a focus on caste and gender in India, as well as on aspects of the Chinese economy: poverty, inequality, regional disparities and gender discrimination. She received the EXIM Bank Award for outstanding dissertation (now called the IERA Award) in 1994, and the 2007 VKRV Rao Award for Indian economists under 45.

**Wilfred Dolfsma** is Professor of Strategy and Innovation at the University of Groningen School of Economics and Business, The Netherlands. He studied Economics and Philosophy, and holds a PhD in the former from Erasmus University. He has published in, *inter alia*, the *Journal of Product Innovation Management*, *Research Policy*, *Journal of Business Ethics*, *Journal of Evolutionary Economics*, the *Journal of Economic Issues*, the *British Journal of Management*, *Technological Forecasting and Social Change* and *Technovation*. **Sheila C. Dow** is Emeritus Professor of Economics at the University of Stirling in Scotland and Adjunct Professor of Economics at the University of Victoria in Canada. Her main research interests lie in the history and methodology of economic thought and the theory of money, banking and monetary policy. Her most recent book is *Foundations for New Economic Thinking* (Palgrave Macmillan, 2012). She is co-editor of the WEA's online journal, *Economic Thought*, and co-convenor of SCEME. Past roles include Chair of the International Network for Economic Method and special adviser on monetary policy to the UK Treasury Select Committee.

**Deborah M. Figart** is Professor of Education and Economics at the Richard Stockton College of New Jersey, USA. She is co-author of *Living Wages, Equal Wages: Gender and Labor Market Policies in the United States*, with Ellen Mutari and Marilyn Power (Routledge, 2002). Her new book is *Just One More Hand: Life in the Casino Economy* (2015), with Ellen Mutari. She is a former president of the Association for Social Economics and served as co-editor of the *Review of Social Economy* from 2005 to 2013.

**David George** is Professor of Economics at La Salle University, USA and is the author of *Preference Pollution: How Markets Create the Desires We Dislike* (University of Michigan Press, 2001). His recent papers have covered such diverse topics as the effect of market values on higher education, the role of introspection in the economic discovery process, and a critical examination of Amartya Sen's analysis of free choice. Long-term plans are for a book that continues his earlier study of the rhetorical practices of economists. He has been a member of the Association for Social Economics for over 30 years and served as its president in 2005.

**Ilene Grabel** is Professor of International Finance at the Josef Korbel School of International Studies at the University of Denver, USA. Grabel has worked as a consultant to UNDP, UNCTAD/G24, and UNU-WIDER.
