Thomas Beschorner is Professor of Business Ethics and Director of the Institute for Business Ethics at the University of St. Gallen, Switzerland. In 2001 he finished his PhD at the Max Weber Center for Advanced Cultural and Social Studies at the University of Erfurt (Germany) and became Assistant Professor at the University of Oldenburg (Germany) as well as fellow at McGill University and the University of Montréal in Canada. In 2007 he became Associate Professor at the University of Montréal (DAAD visiting professorship). He joined the University of St. Gallen in 2011. Beschorner is trained as an economist and social scientist. His main research interests are business ethics and cultural studies, especially theories of action and institutional theories.

David Bevan has a PhD in Management (Social Accounting and Accountability) and postgraduate degrees in Managing Change, and in Adult Education. He had 25 years' experience in finance, IT and organizational change management consulting prior to joining King's College London in 2002. A regular co-author with Pat Werhane, Professor Bevan's teaching and research draws on strands of continental and process philosophy and applies these to strategy, marketing, human resource management, and ethics. He has been on the faculty at universities and business schools in London, Paris, Brussels and Shanghai. He is a Senior Wicklander Fellow at the Institute for Business and Professional Ethics, DePaul University, Chicago.

George G. Brenkert, PhD, is Professor Emeritus of Business Ethics at the McDonough School of Business at Georgetown University, Washington, DC. He is former President of the Society for Business Ethics, past Editor-in-Chief of *Business Ethics Quarterly*, and co-founder of the Capital Area Business Ethics Network, an association of ethics officers from profit, non-profit and governmental organizations in the Washington, DC area. Among his publications are *Marketing Ethics* (Blackwell), *The Oxford Handbook of Business Ethics* (Oxford University Press), and *Corporate Integrity and Accountability* (Sage). He has published numerous articles on business ethics and corporate social responsibility. He is a co-founder of the TransAtlantic Business Ethics Conference.

Joanne B. Ciulla is Professor and Coston Family Chair in Leadership and Ethics at the Jepson School of Leadership Studies, University of Richmond, USA and Visiting Professor at Nyenrode Business University, the Netherlands. With a PhD in philosophy, she has published extensively on leadership ethics and business ethics. Her recent books include *Ethics, The Heart of Leadership* (Praeger), and she co-authored *Honest Work: A Business Ethics Reader* (Oxford University Press) and *Leadership Ethics* (Sage). She is President of the International Society of Business, Economics, and Ethics, and former President of the Society for Business Ethics.

Georges Enderle is the John T. Ryan Jr. Professor of International Business Ethics at Mendoza College of Business, University of Notre Dame (Indiana, USA), and former President of the International Society of Business, Economics, and Ethics (2001–04). Educated in philosophy, theology, economics and business ethics, he has extensive research and teaching experiences in Europe (1983–92), the United States (since 1992), and China (since 1994). He has authored and edited 18 books and over 140 articles. He conducts research on the ethics of globalization, wealth creation, business and human rights, corporate responsibilities of large and small companies, with a view on developments in China.

Nien-hê Hsieh is an Associate Professor of Business Administration in the General Management Unit at Harvard Business School, Boston, USA. His research concerns ethical issues in business and the responsibilities of global business leaders. He examines whether and how managers ought to be guided not only by considerations of economic efficiency, but also by values such as freedom and fairness and respect for basic rights. He joined the Harvard faculty from The Wharton School of the University of Pennsylvania, where he was an Associate Professor of Legal Studies and Business Ethics and served as co-director of the Wharton Ethics Program.

Knut J. Ims is Professor of Business Ethics in the Department of Strategy and Management at the Norwegian School of Economics in Bergen, Norway. He has a PhD from The School of Economics and Legal Science, Gothenburg University, Sweden, and teaches business ethics at Bachelor's, Master's and PhD levels. He is member of the business ethics faculty of the CEMS – The Global Alliance in Management Education. Some of his recent publications are: 'Personal responsibility for the greater good' (with L.J.T. Pedersen), in K.J. Ims and L.J.T. Pedersen (eds) (2015), *Business and the Greater Good. Rethinking Business Ethics in an Age of Crisis*; 'Product as process – commodities

in mechanic and organic ontology' (with L.J.T. Pedersen and L. Zsolnai), *Ecological Economics* (2015); 'Deep ecology and personal responsibility', in L. Zsolnai (ed.) (2015), *The Spiritual Dimension of Business Ethics and Sustainability*.

Daryl Koehn is the Wicklander Chair of Business Ethics and Managing Director of the Institute of Business and Professional Ethics (IBPE) at DePaul University in Chicago. She has published widely in the fields of ethics and corporate governance. Her monographs include *The Ground of Professional Ethics*; *The Nature of Evil*; *Rethinking Feminist Ethics*; *Local Insights, Global Ethics*; and *Living with the Dragon: Thinking and Acting Ethically in a World of Unintended Consequences*. Edited volumes include *Corporate Governance: Ethics Across the Board* and *Aesthetics and Business Ethics*. In addition, she has published scores of articles in the *Harvard Business Review*, *Business Ethics Quarterly*, *Journal of Business Ethics* and numerous other journals. She consults regularly with major corporations and has served on a major corporation's compliance committee. She has been profiled in *Time* magazine and has appeared often on National Public Radio, PBS TV stations and other venues.

Martin Kolmar is Professor of Applied Microeconomics (since 2006) and Director of the Institute of Economics (FGN) in the School of Economics and Political Science at the University of St. Gallen, Switzerland. He holds a PhD in Economics (1997) and Dr. habil. in Economics (2002). His Chair of Applied Microeconomics provides consulting services to firms, associations, foundations and governmental actors on questions of general economic policy, tax policy and regional economic policy, as well as competition policy.

Gene R. Laczniak is the Sanders Professor Emeritus of Business at Marquette University (Milwaukee, WI, USA). He currently serves as the President of the Macromarketing Society, an international group of scholars researching the interactions of markets and marketing with society (macromarketing.org). Laczniak has co-authored five books on marketing ethics (with P.E. Murphy) and has published numerous scholarly articles in academic journals such as the *Journal of Public Policy & Marketing*, the *Journal of Macromarketing* and the *Journal of Business Ethics*. In 2012, he received a Lifetime Achievement Award from the AMA Marketing & Society Special Interest Group for his scholarly contributions to the field.

Christoph Luetge holds the Peter Löscher Chair of Business Ethics at the Technical University of Munich. He has written and edited a number

of books including *Order Ethics or Moral Surplus: What Holds a Society Together?* (Lexington), *Experimental Ethics* (co-editor, Palgrave) and *Handbook of the Philosophical Foundations of Business Ethics* (editor, Springer). He has published numerous articles on various aspects of business ethics, general ethics, political philosophy and philosophy of economics. He has a particular interest both in experimental studies as well as in the role of competition for ethics. He founded the Munich Lecture in Business Ethics series and serves as a member of the Ethics Advisory Board of the European Medical Information Framework and of the Advisory Council of the Bavarian School of Public Policy.

Patrick E. Murphy is Professor of Marketing at the Mendoza College of Business at the University of Notre Dame, USA. He is a past Chair of the Department of Marketing and was a Fulbright Scholar at University College Cork in Ireland and University of Lille 2 in France. He specializes in business and marketing ethics. His work has appeared in leading ethics and marketing journals. His articles have won awards from three academic journals. In 2011, he received the Lifetime Achievement Award from the Marketing and Society Special Interest Group of the American Marketing Association. Professor Murphy holds a BBA from Notre Dame, an MBA from Bradley and a PhD from Houston.

Eleanor O'Higgins is on the faculty of the School of Business at the University College Dublin and an Associate at the London School of Economics. She specializes in teaching, research and publications on business ethics, corporate governance, corporate social responsibility and strategic and public management. She is the author of numerous papers in academic and professional journals, newspaper articles, book chapters and case studies. Eleanor serves on the editorial boards of several international management, ethics and corporate governance journals. She carries out a range of national and international teaching and speaking assignments. She is a member of the Business Ethics and of the Public Management & Governance interfaculty groups of the Community of European Management Schools (CEMS).

Peter John Opio, PhD, is visiting Professor at the Mendoza College of Business, University of Notre Dame, USA, and holds joint appointments as Professor and Director of Research at Mount Kenya University (Nairobi) and Professor of Management at Victoria University (Kampala, Uganda). He is former Deputy Vice Chancellor at Kampala International University and a founding member of the Business Ethics Network Africa. Contemporary Africa); ‘Corporate governance, dual language reporting and timeliness of annual reports on the Nairobi Stock Exchange’ (*Research in Accounting in Emerging Economies*, Vol. 8). His main research interests are ethical leadership, well-being and strategy.

Michael A. Santoro is Professor of Management and Global Business at Rutgers Business School Newark and New Brunswick, New Jersey, USA. He holds a law degree from New York University and a PhD in Public Policy from Harvard University. He was a Fulbright Fellow at the University of Hong Kong and has been a visiting faculty member at the University of Zurich, the Shanghai Institute of Finance and the University of Notre Dame. He serves on the editorial boards of *Business Ethics Quarterly* and the *Journal of Human Rights*, and he is the founding co-editor of the *Business and Human Rights Journal*. His most recent book is *Wall Street Values: Business Ethics and the Global Financial Crisis* (Cambridge University Press).

Nicholas J.C. Santos, SJ, is an Assistant Professor of Marketing at Marquette University (Milwaukee, WI, USA). His major area of research deals with ethical marketing to the impoverished market. He and Gene Lacznik have published several major articles in this stream of research. After his PhD, he spent three years at Santa Clara University, California, as a visiting scholar and post-doctoral fellow in the Markkula Center for Applied Ethics. He has been involved with ‘Step Up Silicon Valley’, a Catholic Charities-initiated campaign to end poverty in Silicon Valley, serving as the chair of the incomes issues group and then as the co-chair of the incubation committee.

Antonio Tencati is Associate Professor of Management in the Department of Economics and Management, University of Brescia, Italy. Between 2005 and 2012 he was Assistant Professor of Management and Corporate Social Responsibility in the Department of Management and Technology, Bocconi University, Milan, Italy, with which he continues to collaborate. He is a member of the Business Ethics Faculty Group of the CEMS (Community of European Management Schools – The Global Alliance in Management Education). His research areas include business and society, management of sustainability and corporate social responsibility, environmental management, innovation and operations management. Werhane is founding editor of the *Business Ethics Quarterly*, a Rockefeller Fellow at Dartmouth, Visiting Professor at the University of Cambridge, and Erskine Visiting Fellow at the University of Canterbury, UK. In 2008 she was listed as one of the 100 most influential people in business ethics by *Ethisphere Magazine*. She has authored or edited over 25 books including *Profitable Partnerships for Poverty Alleviation* (Routledge) with Laura Hartman, Dennis Moberg and Scott Kelley. Her latest book, with Laura Hartman, Crina Archer, Elaine Englehardt and Michael Pritchard, is *Obstacles to Ethical Decision-Making* (Cambridge University Press).

Laszlo Zsolnai is Professor and Director of the Business Ethics Center, Corvinus University of Budapest, Hungary. He is President of the European SPES Institute in Leuven, Belgium. He serves as Chairman of the Business Ethics Faculty Group of the CEMS – The Global Alliance in Management Education.
