Dr. Huiyao Wang is the Founder and President of the Center for China and Globalization (CCG), the largest Chinese independent think tank that makes into the world's top 100 think tanks of the 2017 Global Go To Think Tank Index Report. He is the Dean of Institute of Research of Southwestern University of Finance and Economics in China. The Chinese Premier appointed Dr. Wang as a Counselor of China State Council, China's cabinet. He is also a member of the Expert Committee of Overseas Chinese Affairs Office of the State Council, the Vice Chairman of China Western (Overseas) Returned Scholars Association, the Vice Chairman of China Association for International Economic Cooperation Association of the Ministry of Commerce and the Vice Chairman of China Talent Society under the Ministry of Human Resources and Social Security.

Dr. Wang used to work with the Chinese Ministry of Foreign Economic Relations and Trade and also served as the Chief Economic Representative of Quebec Government office in Hong Kong and greater China region. Dr. Wang is currently on the Migration Advisory Board of the International Organization of Migration (IOM) of the United Nations. He is also a member of Yale University Asia Development, a member of the Advisory Board of Ivey Business School in Asia and a steering committee member of Metropolis International Network.

Dr. Wang pursued his graduate studies at University of Windsor, University of Western Ontario and University of Manchester, and obtained his MBA and PhD degrees in international management. He became a Senior Fellow at Harvard Kennedy School and was a visiting fellow at Brookings Institution. He has published over 60 books and more than 100 articles and papers in both Chinese and English on globalization, global migration, One Belt One Road, China outbound investment, Chinese diasporas and Chinese think tanks. His English publications include *Globalizing China: The Influence, Strategies and Successes of Chinese Returnees* (author, Emerald, 2012); *Reverse Migration in Contemporary China* (Palgrave Macmillan, 2016); *Entrepreneur and Talent Management from a Global Perspective: Global Returnees* (co-editor, Edward Elgar, 2016); and *China Goes Global: How China's Overseas Investment is Transforming Its Business Enterprises* (Palgrave Macmillan, 2016).

Dr. Lu (Mabel) Miao is a think tank founder and a social entrepreneur. She is the Co-founder and Secretary General of the Center for China and Globalization (CCG), the largest Chinese social think tank with nearly 100 full-time researchers and staff. As a leader for the Chinese think tank, Dr. Miao has led the CCG and seen it ranked as one of the world's top 50 independent think tanks in the Global Go To Think Tank Index by the University of Pennsylvania Think Tank and Civil Society Program (TTCSP). TTCSP also ranked CCG as the sixth top think tank in China and number one independent think tank in the country in 2017.

Dr. Miao is currently a member of the B20 Business Council. She is also the Deputy Director of the International Writing Center of Beijing Normal University. She helped

Mo Yan, the first Chinese Nobel Laureate in Literature to found this center and it has become the hub for international famous Nobel Laureates and well-known scholars to meet and exchange ideas in China.

Dr. Miao got her PhD degree in Contemporary Chinese Studies from Beijing Normal University and was a visiting scholar at New York University and Harvard University. She is a co-author of many Chinese Social Science Academy Blue Books on global education and talent development and also on China's going global and international relations. Her latest English publications include *International Migration of China: Status, Policy and Social Responses to the Globalization of Migration* (Springer, 2017) and *China Goes Global: How China's Overseas Investment is Transforming Its Business Enterprises* (co-author, Palgrave Macmillan, 2016).

Gérald Arboit is a Senior Researcher in the French Centre for Intelligence Studies. His fields of research concern intelligence studies in general, viewed as part of International Relations and participating in leader's information. Gérald Arboit specializes in French and European (Britain, Italy, Luxembourg) intelligence services. He is the author of more than 11 books and 200 articles. Gérald Arboit has a PhD in Contemporary International History (Strasbourg, 1999) and a Habilitation à Diriger des Recherches in French Intelligence History.

Leigh R. Baker is from Griffith Business School, Australia. Leigh's wide range of careers span almost 50 years in management, strategic consulting, entrepreneurship and business development in the public and private sectors and the military, both in the Asia Pacific region and globally. He has been doing business in China for more than 20 years including eight years living and working there in operational and strategic roles in Oracle, and in management consulting, executive coaching and leadership development roles in his own Beijing-based company.

Julien Chaisse is a Law Professor at the Chinese University of Hong Kong (CUHK), and an award-winning scholar of international law with a special focus on the regulation and development of economic globalization. His teaching and research include international trade/investment law, international taxation, law of natural resources, and Internet law. Prior to joining CUHK in 2009, Dr. Chaisse was a senior research fellow at the World Trade Institute (Switzerland). He also held an appointment as lecturer at elite school Sciences Po Aix (France) and served as a diplomat at the Embassy of France in New Delhi (India).

Giles Chance is a Professor at the Guanghua School of Management at Peking University. He is a leading expert on Chinese business and on China's new role in the world. Before founding Evolution Securities China he helped foreign companies develop their businesses in China. He is an adjunct professor at the Tuck School of Business, Dartmouth College. His book *China and the Credit Crisis: The Emergence of a New World Order* was published by John Wiley in 2010. The Chinese edition was published by CITIC Press under the title *Zhongguo Zhunbei Haole Ma?* Since 2010 he has written numerous articles on Chinese politics and economics for *Qinqi Guangsha Bao* (Economic Observer Newspaper), the *Financial Times*, and *China Daily*.

Yun-han Chu is a Distinguished Research Fellow of the Institute of Political Science at Academia Sinica and Professor of Political Science at National Taiwan University.

Thomas W. Cline is a Professor of Marketing and Statistics in the Alex G. McKenna School of Business, Economics, and Government at Saint Vincent College and Adjunct Professor of Marketing at the University of Pittsburgh's Katz Graduate School of Business. Dr. Cline has published numerous articles in academic journals, including the *Journal of Advertising*, *Journal of Consumer Psychology*, *Journal of Economic Psychology*, *Psychology & Marketing*, and *Journal of Marketing Communications*. Dr. Cline and his colleagues won the 2003 Young Contributors Award for best paper in the *Journal of Consumer Psychology*. Dr. Cline is co-author of *Consumer Behavior*, a 2011 South-Western/Cengage Learning textbook.

Enrique de Diego is an Invited Professor of Strategic Planning at the University of Navarra, Center for Globalization and Strategy, IESE Barcelona and a Consultant at Bain & Company.

Tony Fang is the Stephen Jarislowsky Chair in Economic and Cultural Transformation at Memorial University of Newfoundland and an adjunct Professor with the University of Toronto and Monash University. Currently he holds the J. Robert Beyster Faculty Fellowship at Rutgers University and sits on a World Bank's Expert Advisory Committee on Migration and Development. Prior to joining Memorial, he was the Director of the Master of International Business Program at Monash University in Melbourne, Australia. He served as the President of the Chinese Economists Society (2012–13) and the Domain Leader at CERIS, Ontario Metropolis Centre (2009–12).

Yi Feng is the Luther Lee Jr. Memorial Chair in Government at Claremont Graduate University (CGU). At CGU he has also served as provost and vice president for academic affairs (2006–11) and as dean of the Division of Politics & Economics (2003–2006). His research areas are international political economy, public policy analysis, and quantitative methodology.

Bai Gao is a Professor of Sociology of Duke University and PhD of Princeton University 1994. Mr. Gao conducts two ongoing projects. One is to study how the dollar's key currency status and the US role as the major liquidity supplier in the postwar period have affected US domestic political economy and how such impacts have led to the skyrocketing federal debt, a fiat economy and high unemployment rate. The other is to study how the changing international environments have changed the Chinese perception of geography and pushed it to a new development strategy of Eurasian continental economic integration.

Zhijun Gao is a fifth-year PhD candidate at Claremont Graduate University (CGU), majoring in global political economy and development economics. He has completed several joint projects as a research assistant with faculty members and colleagues in the past four years. His research topics include China's official corruption, China's contracts in Asia and Latin America, and a comparison between the US and China's economic influence in Latin America. He has also worked as a teaching assistant for international political economy, political economy of China, political economy of international development, and game theory.

Yafei He is the Co-Chair of the Center for China and Globalization (CCG), former Vice Minister of Foreign Affairs of China and former Chinese Government Coordinator for the G20.

His research area covers elite sociology and international relations, orient/occident, reproduction and connections of the elites in the United States and the Middle East, study of politicians, entrepreneurs and military national and international networks. Ideologies, frames of references and comparative conceptions and values, interaction of Muslim and Arab minorities in the West with their environment and with the Middle East are also his interests.

Wei Li is a Professor who focuses on Asian American Studies and Geography, holding a joint appointment at the School of Social Transformation and the School of Geographic Sciences and Urban Planning at Arizona State University. She served as the Fulbright Visiting Research Chair in Ethnicity and Multicultural Citizenship at Queen's University, Canada (2006–2007) and a Senior Fulbright Scholar to India (2016–17). She is a member of the inaugural class of the National Asia Research Associates with the National Bureau of Asian Research and Woodrow Wilson International Center for Scholars (2010–11) and the North American Director for the International Society of Studying Chinese Overseas.

Bo Liang is an Assistant Professor of Marketing at the Alex G. McKenna School of Business, Economics, and Government at Saint Vincent College. She earned a PhD in Business Administration from the University of Utah, and an MBA from Clemson University. Her primary research areas include consumer online behaviors, Internet marketing, social marketing, and corporate branding. Her work has been published in the *Journal of Consumer Behavior*, *Journal of Medical Internet Research*, and the *International Journal of Nonprofit and Voluntary Sector Marketing*. Prior to her academic career, Dr. Liang worked in the areas of marketing and business research in both China and the United States.

Guoyong Liang is an Economic Affairs Officer at the Investment and Enterprise Division of United Nations Conference on Trade and Development. He has been one of main authors of the annual World Investment Report since 2005. Mr. Liang earned his PhD in International Business from Rotterdam School of Management, Erasmus University. He taught at Shanghai University of Finance and Economics from 1998 to 2001, and also had years of managerial experience in China's financial and Information and Communication Technologies sectors.

Dickie Liang-Hong Ke is an accomplished technology executive, entrepreneur and investor, with 30 years of advisory, investment, global management, and engineering experience in digital healthcare, fintech and insurtech, digital media and advertising, e-commerce, telecommunications, and enabling technologies such as machine learning, big data analytics, blockchain, IoT, cloud computing, and mobile Internet. Mr. Ke has been advising multinational corporations on China entry strategy, and Chinese companies on global strategy. He was also a Sloan Fellow at London Business School, with an MS in Leadership and Strategy.

Lucia Lo is a Professor Emerita and Senior Scholar in the Graduate Program in Geography at York University. Her research interests include intellectual migration and the global race for talents; immigration and settlement; ethnic economy, entrepreneurship, and consumer behavior; and Chinese diaspora.

Jie Lu is Associate Professor of Political Science at American University. Dr. Lu studies local governance, the political economy of institutional change, public opinion, and political participation. His regional expertise focuses on the Greater China Region and East Asia. His work has appeared in *Comparative Political Studies*, *Comparative Politics*, *Political Psychology*, *Politics & Society*, *Political Communication*, *Journal of Democracy*, and other journals. He is the author of *Varieties of Governance in China: Migration and Institutional Change in Chinese Villages* (Oxford University Press, 2015).

Joergen Oerstroem Moeller is a Visiting Senior Fellow at ISEAS Yusof Ishak Institute, Singapore. He earned his Master of Economics from University of Copenhagen in 1968, and served the Royal Danish Foreign Ministry from 1968 to 2005, of which 1989–97 was as State-Secretary and 1997–2005 as Ambassador in Asia. His recent books include: *The Veil of Circumstance* (ISEAS, 2016) and *How Asia Can Shape the World* (ISEAS, 2011). He has also contributed numerous articles for journals, newspapers, and websites. He is also adjunct professor in Singapore Management University and Copenhagen Business School, honorary alumnus of University of Copenhagen.

Manuel Pinho is an Adjunct Professor and Senior Research Scholar of Columbia University and a guest professor and Top Overseas Teacher of Beijing Foreign Studies University.

Fei Qin's research focuses on transnational entrepreneurship and global value chains. She looks into how social processes and institutions shape work organization, entrepreneurial processes, and innovation capabilities in the context of globalization. She has also researched into management systems, particularly human resource systems, in global value chains. She has led research projects in America, Asia, and Europe on the subjects of entrepreneurship and global business networks. Her research has appeared in top entrepreneurship, innovation, and labor/human resource journals. She is a recipient of the Emerald Citations of Excellence Award.

Gary Quinlivan is a Professor of Economics and Dean of the Alex G. McKenna School of Business, Economics, and Government at Saint Vincent College. Dr. Quinlivan received his PhD in economics at the University of Albany, has co-edited or authored seven books, six monographs and has written numerous articles in the areas of international trade, public finance and international finance. He was a Fulbright Scholar at Shandong

University in China from 1988 to 1989. During the summer of 2005, Dr. Quinlivan received an International Business Fellowship from the University of Pittsburgh, for a ten-day seminar in Russia, Bulgaria, and Czech Republic.

Stan Shih (Chinese: Shī Zhènróng) is the Founder, President, and Chairman of Acer Inc. In 1976, after receiving Bachelor's and Master's degrees in electronic engineering from National Chiao Tung University, Mr. Shih founded Multitech with his wife Carolyn Yeh and five partners. He chaired Multitech through to 1987, when the company was renamed Acer, continuing as Acer chairman until his retirement in late 2004, when Acer had grown to a billion-dollar worldwide brand from a tiny startup. Now he remains active in charity work during his retirement, including serving as a special representative of President Chen Shui-bian to the APEC Australia 2007. In November 2013, Mr. Shih returned to Acer after being reinstated as president and chairman.

Rajkumar Singh is a Professor for the last 18 years and presently Head of the P.G. Department of Political Science, B.N. Mandal University, West Campus, Saharsa (Bihar), India. In addition to 15 books published so far there are over 125 articles to his credit, of which more than 40 are from foreign countries such as the United States, Russia, Australia, Canada, Pakistan, Armenia, China, United Kingdom, Surinam, and Romania. His recent books include *Challenges of Contemporary India-Polity, Justice, Education, Empowerment and Judiciary* (2016, New Delhi) and *Tireless Border Diplomacy of India with China and Pakistan* (2016, New Delhi).
