Laura Alfaro is the Warren Albert Professor at Harvard Business School, USA in the Business, Government, and International Economy Unit. She was Minister of National Planning and Economic Policy in Costa Rica from 2010 to 2012. She is also a Research Associate with the National Bureau of Economic Research, member of the Latin-American Financial Regulatory Committee (Comité Latinoamericano de Asuntos Financieros, CLAAF), Faculty Associate at Harvard's Weatherhead Center for International Affairs, and member of the David Rockefeller Center for Latin American Studies (DRCLAS)'s policy committee. She is the author of multiple articles published in leading academic journals, and of Harvard Business School cases related to the field of international economics and in particular international capital flows, foreign direct investment, and sovereign debt.

Scott L. Baier is Professor and Department Chair of the John E. Walker Department of Economics at Clemson University, USA. His research interests include international trade and economic growth. From 2007 to 2008, he served on the President's Council of Economic Advisers. More recently, he has worked with the United States International Trade Commission and the Congressional Budget Office.

Kristian Behrens holds the Canada Research Chair in Regional Impacts of Globalization and is Professor at Université du Québec à Montréal (UQAM), Canada. His main fields of research are in urban and regional economics, economic geography, and international trade. He has published widely, with papers in the *Journal of Political Economy*, the *Economic Journal*, the *International Economic Review*, and the *Review of Economics and Statistics*. He is a Research Fellow of the Centre for Economic Policy Research (CEPR), London, UK and an Academic Advisor of the Center for Market Studies and Spatial Economics (CMSSE), Higher School of Economics, Russia.

Bruce A. Blonigen is the Dean for Faculty and Operations for the College of Arts and Sciences at the University of Oregon, USA and is the Philip H. Knight Professor of Social Sciences. He is also a Research Associate with the National Bureau of Economic Research. His research focuses on empirically examining international trade issues from a microeconomic and political economy perspective, especially with respect to multinational corporations and international trade policies.

Bernardo S. Blum is an Associate Professor of Business Economics at the Rotman School of Management, University of Toronto, Canada. He has published extensively in the area of international trade, including works on trade intermediaries, the determinants of income inequality, and the costs of international trade. He has also published in the area of urban economics. His research in this area includes works on the effect of urban agglomeration on the productivities of workers' skills.

W. Mark Brown is the Chief of Urban and Regional Economic Analysis in the Economic Analysis Division of Statistics Canada. He earned his doctorate in geography from

McMaster University in 1999 and taught at McGill University before taking his current position. His research focuses on identifying the factors associated with urban and regional economic growth. His research has been funded by the Canada–U.S. Fulbright Foundation and the Social Sciences and Humanities Research Council, among other granting bodies, and has been published in numerous peer-reviewed journals, including the *Journal of Economic Geography* and the *Journal of Regional Science*.

Jerónimo Carballo is an Assistant Professor in the Department of Economics at the University of Colorado Boulder, USA. His primary research interest is international trade with a special emphasis on firms' decisions under uncertainty, how firms organize trade across countries, and exploring trade cost using micro-data. His research has been published in several journals, such as the *Journal of International Economics* and the *Journal of Development Economics*.

Young-Tae Chang is Inha Fellow Professor (University Chair Professor) at Graduate School of Logistics and also at Asia Pacific School of Logistics, Inha University, South Korea. He has published over 70 papers in refereed citation journals, mostly in the areas of maritime transportation and logistics. He has conducted various research on maritime and multi-modal transportation, marine policy, and socio-economic analysis on ocean-related projects as principal investigator or co-principal investigator over 60 international and domestic projects.

Maggie Xiaoyang Chen is a Professor of Economics and International Affairs at George Washington University, USA. Her areas of research expertise include multinational firms, international trade, and regional trade agreements, and her work in these areas has appeared in leading academic journals. She worked as an Economist for the World Bank in 2011–2012 and has worked as a Senior Consultant for various divisions of the World Bank and the International Finance Corporation since 2003. She currently serves as a Trade Policy Expert at the Congressional Budget Office and a Co-editor at *Economic Inquiry*.

Sebastian Claro is Deputy Governor of the Central Bank of Chile, where he has served as a board member since 2007. He is also Associate Professor of Economics at Pontificia Universidad Católica de Chile, where he teaches courses on international macroeconomics and international trade. He has published extensively on international trade and China's economic transformation.

James J. Corbett is a Professor in the School of Marine Science and Policy, College of Earth, Ocean, and Environment at the University of Delaware, USA. His research is focused on technology policy innovation for twenty-first-century freight systems, with a particular emphasis on international shipping and coastal marine policy. He was a lead author of seminal studies evaluating international shipping's role in use of technology to meet stewardship goals.

Jelena Damnjanović is Professor of International Business and Director of the Novi Sad School of Business, Serbia. Her principal interests are in the area of international business and globalization. As an invited speaker she taught at the University of Geneva and participated in conferences in Europe and Asia. She is the author of four books and a number of articles, including the entry on “Globalization” in the *Palgrave Encyclopedia of Strategic Management*.

Federico J. Díez is an Economist in the research department of the Federal Reserve Bank of Boston, USA. His research interests include international trade and macroeconomics, multinational firms, offshoring, outsourcing, trade policy, and open-economy macroeconomics.

Peter H. Egger has been a Professor of Applied Economics in the Department of Management, Technology and Economics at ETH Zurich, Switzerland since 2009. In the same year, he became Head of the Division of Structural Change and Innovation at KOF. His research focus is on applied and theoretical panel econometrics (time-invariant variables, long- and short-run estimates, spatial econometrics), applied and theoretical international and regional economics (outsourcing, multinational firms, trade volumes, economic integration, new economic geography), industrial organization, and multinational firms.

Lixian Fan is an Associate Professor at Shanghai University, China. She received her PhD in logistics and maritime studies from the Hong Kong Polytechnic University in 2011. Her current research interest includes shipping and port management, international logistics, ship flag choice, and ship investment behavior.

Holger Görg is Director of the Kiel Centre for Globalization and Head of the Global Division of Labour research area at the Kiel Institute for the World Economy. He is also Professor of International Economics at Christian-Albrechts-Universität zu Kiel, Germany. His research interests include the activities of multinational firms, international outsourcing, exporting, and micro-level panel data econometrics.

Aoife Hanley is a Senior Researcher of the Knowledge Creation and Growth research area at the Kiel Institute for the World Economy and a Principal Investigator at the Kiel Centre for Globalization. She is also a Professor of Applied Economics of the Firm at Christian-Albrechts-Universität zu Kiel, Germany. Her research interests include innovation, international outsourcing, internationalization of the firm, and firm-level productivity.

Javier D. Ho has worked with the Panama Canal Authority since 2000 in the Executive Vice Presidency for Planning and Business Development. He is a specialist for the dry bulk segment of the Panama Canal, whose responsibilities include the short- and long-term traffic forecast for the Authority, including forecasts related to grains, iron ore, and coal. As part of his job assignments, he monitors and analyzes events in the grain markets that could have an impact on the Canal's traffic. Previously he taught the principles of macroeconomics, Spanish and business anthropology at Wayne State University for about three years.

Ignatius J. Horstmann is an Emeritus Professor of Business Economics at the Rotman School of Management, University of Toronto, Canada. He is also co-director of the Rotman Institute for International Business. He has published extensively in the areas of international trade and industrial organization. His research includes works on the multinational firm, trade policy with imperfect competition, trade intermediaries, bargaining and negotiations, firm organization, and advertising.

Miroslav N. Jovanović lectures in international economics at the Global Studies Institute, University of Geneva, Switzerland. He worked for almost three decades at the UN. At the

UN, he was the Secretary of the Group of Experts on Euro-Asian Transport Links. He taught in a number of countries and is the author or editor of 25 volumes and a number of articles on economic integration, globalization, and spatial location of economic activity. He is the winner of the Daeyang Prize for the best article (“Is globalisation taking us for a ride?”) published in the *Journal of Economic Integration* in 2010.

Amanda Kerr is an Assistant Professor at the University of Evansville, USA. Her research interests include economic growth and development, labor economics, and microeconomics. She completed her PhD at Clemson University and has been a short-term consultant for the World Bank.

Michael O. Moore is Professor of Economics and International Affairs at George Washington University, USA. His research focus is on the economics of the WTO system,

US trade policy, the political economy of trade, and the intersection of international trade rules and climate change policy. He has served as Director of George Washington University's Institute for International Economic Policy and Associate Dean of the Elliott School. He was on the President's Council of Economic Advisers from 2002 to 2003 and was a Consultant for the World Bank and various US government agencies, including the Department of State and Department of Commerce.

Jesse Mora is an Assistant Professor of Economics at Occidental College, USA. His research interests are international trade, development economics, and applied micro-economics, with a current focus on the effect of export failure on domestic market performance.

Jovan Njegić is a Professor of Finance at the Novi Sad School of Business, Serbia for undergraduate and postgraduate studies. Eddy Van de Voorde is Full Professor at the Faculty of Applied Economics, University of Antwerp, Belgium. He is also a Professor at the Technical University of Delft, the Netherlands, and a visiting professor at various universities, including Lisbon, Bari, City, University of London, and MIT. His research is in transport economics and modeling, particularly in the field of modeling freight transport. In 2005, in Genoa, he was awarded a prestigious international prize, the Premio Internazionale delle Comunicazioni Cristoforo Colombo, for his scientific research in the field of maritime economics.

He previously worked for the Ministry of the Economy of the Province of Buenos Aires and was advisor at the MERCOSUR Commission of the National Representatives Chamber in Argentina. Wesley W. Wilson is a Professor of Economics at the University of Oregon, USA.
