Johan Adriaensen is a Postdoctoral Researcher at Maastricht University and research coordinator of the Centre for European Research in Maastricht (CERiM) – Jean Monnet Centre of Excellence. He completed his PhD at the University of Leuven and has been a guest professor at the University of Antwerp. His research interests encompass international political economy, institutions of the European Union and the scholarship on teaching and learning. He is the author of *National Administrations in EU Trade Negotiations* (Palgrave 2016) and has recently co-edited (with Tom Delreux) a volume on the *Principal-Agent Model in EU Politics* (Palgrave 2017).

Leïla Choukroune is Professor of International Law and Director of the Thematic Initiative in Democratic Citizenship at the University of Portsmouth (UK). She was previously Director of the Centre for Social Sciences and Humanities (CSH), New Delhi, India, the French National Research Centre (CNRS) Unit on South Asia. Her research focuses on the interactions between trade, investment and human rights and is applied to emerging countries, China and India in particular. She has published numerous scientific articles and authored several books including *Judging the State in International Trade and Investment Law* (2016) and *Indian Modernities* (2017). She is the Editor of the Springer book series International Law and the Global South, and a member of the Editorial Board of *China Perspectives* and *Perspectives Chinoises*.

Philippe De Lombaerde is Associate Professor of International Economics at Neoma Business School (Reims – Rouen – Paris) and Associate Senior Research Fellow at the United Nations University (UNU-CRIS) in Bruges. Previously, he worked as Associate Director and Research Fellow at UNU-CRIS, Associate Professor of International Economics at the Universidad Nacional de Colombia (Bogotá), Researcher and Lecturer at the University of Antwerp, and as Researcher at the National Institute of Development Administration (NIDA) (Bangkok), among other appointments. He has published widely on economic, political and legal aspects of regional economic integration, international trade and investment, monitoring tools and indicators, Latin American and Southeast Asian regionalism, EU external economic relations, comparative regionalism, and globalization and regionalization indicators. Recently edited volumes include: *Regionalism* (Sage, 2013, four volumes, with F. Söderbaum) and *Indicator-based Monitoring of Regional Economic Integration* (Springer, 2017, with E. Saucedo).

Ferdi De Ville is Assistant Professor in European Politics at the Centre for EU Studies, Ghent University. His research focuses on European political economy, and the politics of EU trade in particular, and has appeared in numerous journals including *New Political Economy*, *Comparative European Politics* and *Journal of European Integration*. He is the co-author of *TTIP: The Truth about the Transatlantic Trade and Investment Partnership* (Polity Press, 2016).

Matthew Eagleton-Pierce is a Senior Lecturer in International Political Economy at the School of Oriental and African Studies (SOAS), University of London. He previously taught at the University of Oxford, the London School of Economics and the University of Exeter. His research interests fall within the broad area of political economy, particularly: (1) the history and contemporary forms of neoliberalism; and (2) the politics of world trade. He has published over 250 journal articles and 25 books – recent titles include *Frittering Away Food Security* (2017) and *Biotechnology Regulation and Trade* (2017). He is Editor of the *Journal of International Law and Trade Policy*.

Sangeeta Khorana is Professor of Economics at Bournemouth University (UK). She specializes in international trade and trade regulation issues. In her current position as Professor, she leads research on EU trade policy and the economics and political economy of trade agreements. She is also an expert on relations between the EU and India, and between the EU and emerging economies. She has published books, book chapters and written many articles on bilateral trade issues. Dr Khorana has a PhD from the University of St Gallen, and a summa cum laude Masters degree from the Berne University in Switzerland.

Ludger Kühnhardt is Director at the Center for European Integration Studies (ZEI) at Bonn University and Professor of Political Science at Bonn University. He has extensive political and academic consultancy experience. In 2004, he was awarded the European Science Prize of the European Cultural Foundation.

Deborah Martens is a Doctoral Researcher at the Centre for EU Studies at Ghent University, with a grant from the Special Research Fund. She works on the interdisciplinary research project ‘When EU trade politics and farm economics meet’ with Annelien Gansemans, from the department of agricultural economics, on the impact of EU trade on social development in Latin America. Her research focuses on linking the macro level of EU politics and trade agreements as well as the meso-level of Corporate Social Responsibility (CSR) strategies of (European) firms to the micro-level of the life on the ground in the agricultural sector, more particularly in the pineapple plantations in Central America. She also teaches an intensive course on EU Fair Trade policy.

Peg Murray-Evans is a Research Associate in the Department of Politics at the University of York. Her research focuses on the role of ideas and institutions in international politics, with a particular emphasis on trade and development politics in southern Africa. Peg has recently published work in *Third World Quarterly*, *The Round Table* and (with Tony Heron) the *European Journal of International Relations*.
