**Hassan Bougrine** holds a PhD from the University of Ottawa and has been teaching at Laurentian University for 30 years where he has also served as the Chair of the Economics Department. He has been a Visiting Professor to many universities in Latin America, Europe and Africa. He also acted as a consultant to the Canadian International Development Agency and the International Development Research Centre in the 1990s. He has published widely on issues of money, finance, public policy and the economics of development. His most recent book is *The Creation of Wealth and Poverty: Means and Ways* (Routledge 2017). In addition to several edited books, his peer-reviewed articles have been published in journals such as the *International Journal of Political Economy*, *Review of Keynesian Economics*, *Journal of Post Keynesian Economics*, *International Review of Applied Economics*, *Journal of Economic Development*, *Canadian Journal of Regional Science*, *Journal of European Integration* and *Critique Économique*.

**James K. Galbraith** holds the Lloyd M. Bentsen Jr. Chair in Government/Business Relations at the LBJ School of Public Affairs and a professorship in Government at The University of Texas at Austin. He was executive director of the Joint Economic Committee of the US Congress in the early 1980s. He chaired the board of Economists for Peace and Security (1996–2016) and directs the University of Texas Inequality Project. He is a managing editor of *Structural Change and Economic Dynamics*. From 1993 to 1997, he served as chief technical adviser to China's State Planning Commission for macroeconomic reform, and in 2016 he advised the presidential campaign of Senator Bernie Sanders. In 2014 he was co-winner of the Leontief Prize. He holds honorary degrees from the Université Pierre Mendès-France in Grenoble and from the Plekhanov University of Economics in Moscow. His latest books are *Welcome to the Poisoned Chalice: The Destruction of Greece and the Future of Europe* (2016), *Inequality: What Everyone Needs to Know* (2016), *The End of Normal* (2014) and *Inequality and Instability* (2012).

**Brian K. MacLean** is Professor of Economics at Laurentian University in Sudbury, Ontario, where he has been Chair of the Department of

Economics for two terms and Director of the Institute for Northern Ontario Research and Development. He speaks Japanese as a second language and has been a visiting professor at Hokkaido University in Sapporo, Japan, and at Saitama University, just outside of Tokyo, where he returns each year to deliver lectures. He has co-authored four editions of an introductory macroeconomics textbook, edited *Out of Control? Canada in an Unstable Financial World* (Lorimer 1999), co-edited *The Unemployment Crisis: All for Nought?* (McGill-Queen's 1996), and has published in the *Cambridge Journal of Economics*, *International Journal of Political Economy*, *Review of Income and Wealth*, *Canadian Business Economics* and other journals and in edited volumes. He has served on the Executive of the Canadian Economics Association, as the CEA liaison with the Canadian Women Economists Network, and as webmaster and Steering Committee member of the Progressive Economics Forum.

**J.W. Mason** is Assistant Professor of Economics at John Jay College, CUNY and a Fellow at the Roosevelt Institute. His research focuses on the history and political economy of money and credit, including the evolution of household debt, public-sector balance sheets and the changing role of financial markets in business investment. He also works on the history of economic thought, particularly the development of macroeconomics over the twentieth century. His PhD in economics is from the University of Massachusetts at Amherst, and his BA is from the University of Chicago. He has published articles in *American Economic Journal: Macroeconomics*, *Metroeconomica*, *Journal of Post Keynesian Economics*, *Review of Keynesian Economics* and *Rethinking Marxism*, among other journals. In addition to his scholarly work, he has done policy work for the New York Working Families Party, the New York City Independent Budget Office, and the AFL-CIO, and has published popular articles in *The Nation*, *In These Times*, *The American Prospect*, *The Baffler*, *Jacobin* and *The New Inquiry*, among other venues. **Lars Osberg** is McCulloch Professor of Economics at Dalhousie University, Halifax. Born in Ottawa, Ontario, he attended Queen's University, Kingston and the London School of Economics and Political Science before working for the Tanzania Sisal Corporation and going to Yale University for his PhD. He has had visiting positions at New York University and the universities of Cambridge, Sydney, New South Wales, Essex and Queensland, as well as at Research on Poverty Alleviation (REPOA), Dar es Salaam, at the Indira Gandhi Institute for Development Research, Mumbai, at the Organisation for Economic Co-operation and Development (OECD), Paris, and at The Institute for New Economic

Thinking, Oxford. His first book was *Economic Inequality in Canada* (1981) and the most recent is *The Age of Increasing Inequality* (2018). Inbetween, there have been nine other books, four editions of an introductory economics textbook and numerous refereed articles. His current research emphasizes the measurement and implications of increasing inequality, poverty, economic insecurity, inequality of opportunity and economic well-being. He was President of the Canadian Economics Association in 1999–2000.

**Louis-Philippe Rochon** is Professor of Economics at Laurentian University, Canada. He obtained his doctorate from the New School for Social Research in 1998. He is currently co-editor of the *Review of Political Economy* and is the founder and past editor (now emeritus) of the *Review of Keynesian Economics*. He is the author of over 125 articles in peer-reviewed journals and books and has written or edited 26 books. He is on the editorial board of *Ola Financiera*, *International Journal of Political Economy*, the *European Journal of Economics and Economic Policies: Intervention*, and *Problemas del Desarrollo*, *Cuestiones Económicas* and *Credit and Money*. He has been a visiting scholar or professor in Australia, Brazil, France, Italy, Mexico, Poland, South Africa and the United States, and has further lectured in China, Colombia, Ecuador, Italy, Japan, Kyrgyzstan and Peru.

**Malcolm Sawyer** is Emeritus Professor of Economics, University of Leeds. He was the lead coordinator for the EU-funded 8 million euro, 15 partner, five-year project on Financialisation Economy Society and Sustainable Development ([www.fessud.eu](http://www.fessud.eu)). He established and was Managing Editor of *International Review of Applied Economics* for over 30 years, and has served on a range of editorial boards. He is the editor of the book series *New Directions in Modern Economics* (Edward Elgar) and co-edits (with Philip Arestis) the annual series *International Papers in Political Economy* (published by Palgrave Macmillan). He is the author of 12 books (the most recent being *Can the Euro survive?*, from Polity Press). He has edited or co-edited over 30 books. He has also published over 100 papers in refereed journals on a wide range of topics and recently including papers on financialization and impacts of the financial sector on economic and social performance, the political economy of the eurozone and its failing, fiscal policies and alternatives to austerity, alternative monetary policies, public–private partnerships.

**Mario Seccareccia** is Emeritus Professor of Economics, University of Ottawa, in Canada where for 40 years, from 1978 to 2018, he taught macroeconomics, monetary theory, labour economics, history of economic

thought, and economic history – areas in which he has also published extensively. He has published over 100 academic articles in scientific refereed journals or chapters of books and has authored or edited a dozen books and monographs. He has also edited or co-edited some 40 special issues of journals. Some of these publications are of an interdisciplinary nature and cover many areas of political economy. He has been a visiting professor in a number of universities in France (Université de Bourgogne, Université de Grenoble, Université Paris 13 and Université Paris-Sud) and in Mexico (Universidad Nacional Autónoma de México), and he participates regularly in policy debate in both Europe and North America. Since 2004, he has been editor of the *International Journal of Political Economy*, an interdisciplinary journal published by Taylor & Francis and largely focused on policy questions of national and international scope.

**Sunanda Sen** is an economist and a former Professor at the Jawaharlal Nehru University of New Delhi. She has been a National Fellow of the Indian Council of Social Science, a Research Associate at the Levy Institute in New York, Joan Robinson Memorial Lecturer at Faculty of Economics, Cambridge University, and a life member of Clare Hall, Cambridge University. She has also been consulted by various United Nations organizations, and is engaged in research on development, economic history, international finance and gender studies. She has authored or edited 11 books, including *The Changing Face of Imperialism: Colonialism to Contemporary Capitalism* (Routledge 2018), *Dominant Finance and Stagnant Economies* (OUP 2014), *Development on Trial* (Orient BlackSwan 2014), *Unfreedom and Waged Work: Labour in India's Manufacturing Industry* (Sage India 2009), *Globalisation and Development* (National Book Trust Delhi 2007), *Global Finance at Risk* (Palgrave Macmillan 2003 and OUP 2004) and *Colonies and Empire: India 1890–1914* (Orient Longmans 1992). Her published papers include at least 60 or more articles in scholarly journals and edited volumes.

**Jan Toporowski** is Professor of Economics and Finance at SOAS, University of London, Visiting Professor of Economics at the University of Bergamo, Italy, and Professor of Economics and Finance at the International University College, Turin, Italy. After studying economics at Birkbeck College, University of London, and the University of Birmingham, he worked in fund management and international banking. He has published widely on money, finance and economic development, and is the author of a two-volume biography of Michał Kalecki.

**Matías Vernengo** is Professor of Economics at Bucknell University. He was formerly Senior Research Manager at the Central Bank of Argentina

(BCRA), Associate Professor of Economics at the University of Utah, and Assistant Professor at Kalamazoo College and the Federal University of Rio de Janeiro (UFRJ). He has been an external consultant to several United Nations organizations such as the Economic Commission for Latin America and the Caribbean (ECLAC), the International Labour Organization (ILO), the United Nations Conference on Trade and Development (UNCTAD) and the United Nations Development Programme (UNDP), and has five edited books, one authored book and more than 50 articles published in scientific peer-reviewed journals. He specializes in macroeconomic issues for developing countries, in particular Latin America, international political economy and the history of economic ideas. He is also the co-editor of the *Review of Keynesian Economics* (ROKE) and co-editor in chief of *The New Palgrave Dictionary of Economics*.
