Luis Ballesteros is Assistant Professor of Global Strategy at the George Washington University School of Business. His research centers on the individual and institutional drivers of organizational decision making and the economic consequences of firm strategy. He has focused on organizational choices during episodes of exogenous uncertainty and risk shocks and the consequences of such choices for firm performance and economic welfare. Prior to joining academia, he worked with financial derivatives for two private banks and with policy instruments to finance catastrophic risk for two multilateral agencies.

Harry Barkema is Professor of Management at the London School of Economics (LSE). His current research and teaching focus on (social) entrepreneurship trajectories in incubators in South Asia (India, Bangladesh), West (Nigeria), East (Kenya) and Southern (South) Africa. He is the founder and Director of the LSE's Innovation Co-Creation Lab (which creates and shares evidence-based knowledge, globally, on how to design, improve/learn and scale up social enterprises/social businesses/non-governmental organizations (NGOs)). He is also the founder and Director of the LSE's Masters program on Social Innovation and Entrepreneurship. He has given numerous design/field workshops for new social enterprises/social businesses/NGOs in South Asia, Africa and South America. He also recently edited (with Xiao-Ping Chen, Gerry George, Yadong Luo, Anne Tsui) the *Academy of Management Journal's* first special issue on theories from Asia. Previously, he has published extensively on organizational learning and international acquisitions of multinational corporations, and served in various roles in the Academy of Management: (first European) Associate Editor (twice), Board of Governors, and other.

Julie Battilana is the Joseph C. Wilson Professor of Business Administration in the Organizational Behavior unit at Harvard Business School and the Alan L. Gleitsman Professor of Social Innovation at Harvard Kennedy School, where she is also the founder and faculty chair of the Social Innovation and Change Initiative. Her research examines the processes by which organizations and individuals initiate and implement social changes that diverge from the taken-for-granted norms in society. She received a joint PhD in Organizational Behavior from INSEAD and in Management and Economics from Ecole Normale Supérieure de Cachan.

Marya Besharov is Associate Professor of Organizational Behavior at the ILR School at Cornell University. She earned her PhD in Organizational Behavior from Harvard University. An organizational theorist with a background in organizational sociology, she studies how organizations and their leaders sustain competing goals. Much of her research focuses on hybrid organizations such as social enterprises and mission-driven businesses that seek to address deeply rooted societal challenges while also making a financial profit. Besharov's work has been published in journals such as the *Academy of Management Journal*, *Academy of Management Review*, *Administrative Science Quarterly*, *Business Ethics Quarterly*, *Academy of Management Learning and Education*, *Research in Organizational*

Behavior and Research in the Sociology of Organizations. She is currently an Associate Editor for the *Academy of Management Annals*, and serves on the editorial boards of the *Academy of Management Journal*, *Administrative Science Quarterly* and *Organization Science*.

Yasser Bhatti conducts research in the fields of innovation, entrepreneurship and strategy with a focus on innovation under constraints, the localization and globalization of innovation, and the role of emerging market economies and situated actors (such as social entrepreneurs) in emerging trends in innovation, particularly frugal and reverse innovation. He originally trained as a mechanical engineer at the University of Oklahoma and received postgraduate Computer Science and Management degrees from the Georgia Institute of Technology. Subsequently, he trained as a social scientist in Management Studies at the University of Oxford, jointly at Said Business School and Green Templeton College. Christian Busch is Clinical Assistant Professor at New York University (NYU), where he leads the Center for Global Affairs' Global Economy concentration. He teaches on alternative growth strategies, purpose-driven leadership, impact entrepreneurship, social innovation, and emerging markets at NYU and at the London School of Economics (LSE). His most recent book *Frugal Innovation: How to Do More With Less* was published in February 2015 and won the CMI's Management Book of the Year Award 2016.

Jeffrey A. Robinson (PhD) is an award-winning business school professor, international speaker and entrepreneur. Since 2008, he has been a leading faculty member at Rutgers Business School where he is Associate Professor of Management and Entrepreneurship and the Academic Director of the Center for Urban Entrepreneurship & Economic Development.
