Harrison Kofi Belley is currently the acting Head of Department of the Governance Studies Department of the Evangelical Presbyterian University College (EPUC), Ho, Ghana, and in the final phase of a PhD programme at the Institute of African Studies, University of Ghana, Legon. He has been a governance and parliamentary advocate for several years and has worked with a number of NGOs in Ghana and beyond. He earlier worked as a research officer at the Office of Parliament, and previously served as a programmes officer at the Ghana Center for Democratic Development (CDD-Ghana), a democracy promotion think-tank.

Katja Biedenkopf is Assistant Professor at the Katholieke Universiteit (KU) Leuven, Belgium. Her research centres on climate and environmental policy. Dr Biedenkopf has conducted research on the external effects of European Union environmental policy on the United States, China and South Korea, in particular in the areas of electronic waste, chemicals and climate policy. She has also worked on questions regarding climate diplomacy, global environmental governance, the diffusion of greenhouse gas emissions trading and policy entrepreneurship. Previously, Dr Biedenkopf worked as an Assistant Professor at the University of Amsterdam, the Netherlands; as a postdoctoral fellow at the Free University of Berlin, Germany; and as a doctoral research fellow at the Vrije Universiteit Brussels, Belgium.

Thomas Christiansen holds a Chair in European Institutional Politics in the Department of Political Science at Maastricht University, the Netherlands, and is also Professor at the LUISS Università Guido Carli, Rome, Italy. He is executive editor of the *Journal of European Integration*; co-editor (with Sophie Vanhoonacker) of the 'European Administration Governance' book series at Palgrave Macmillan; and Convenor of the Standing Group on the European Union of the European Consortium of Political Research (ECPR). He has published widely on different aspects of European integration. *The European Union and China* (co-authored with Emil Kirchner and Uwe Wissenbach) was published by Palgrave Macmillan in 2019.

Agnieszka Cianciara, PhD, holds a double MA degree: in Political Sciences from Warsaw University, and in European Political and Administrative Studies from the College of Europe in Bruges. She received a PhD from

the Institute of Political Studies Polish Academy of Sciences (2010), where she is currently working as Associate Professor. She has (co-)authored three monographs and over 30 articles in peer-reviewed journals (*Journal of European Integration*, *Southeast European and Black Sea Studies*, *Perspectives on European Politics and Society* and *Yearbook of Polish European Studies*, among others) and edited volumes (published notably by Routledge, Nomos Baden-Baden, Editions Themis Montreal and Republic of Letters Dordrecht).

Ian Cooper is a Research Fellow at the Brexit Research and Policy Institute at Dublin City University, Ireland. He holds a PhD in Political Science from Yale University. He has previously held academic positions in the UK, Norway and Canada, and most recently he was a Jean Monnet Fellow at the EUI in Florence. He studies questions related to democracy and constitutionalism in the European Union, with a particular focus on the role of national parliaments. His work has appeared in the *Journal of European Public Policy*, *West European Politics*, and the *Journal of Common Market Studies*. He is currently writing a book making the argument that national parliaments should be understood as a 'virtual third chamber' within the political system of the EU.

Robert M. Cutler is Senior Researcher at the Institute of European, Russian and Eurasian Studies, Carleton University, Canada. He was educated at the Massachusetts Institute of Technology (BSc) and the University of Michigan (PhD), and has held research fellowships at the University of Geneva, Moscow University, Columbia University and University of Nantes, amongst others. During a dozen years exclusively in Canadian, Swiss and American universities, he taught 14 different subjects, at all levels from introductory undergraduate courses to graduate research seminars, in international relations, comparative politics and political philosophy. He has discovered and published archival primary sources relative to the life and thought of the nineteenth-century Russian anarchist Mikhail Bakunin. After the end of the Cold War, he expanded into policy analysis and consulting, developing a specialization in the international geo-economics of energy security. He has published over 70 refereed academic and policy-review articles and book chapters, for example in *European Security*, *Global Governance*, *International Affairs*, *International Organization*, *International Studies Quarterly*, *Journal of International Affairs*, *Journal of International Organizations Studies*, *Kybernetes*, *Soviet Studies*, *Studia Diplomatica* and *World Politics*, including a number of works on IPIs co-authored with Alexander von Lingen, as well as many hundreds of shorter analyses, situation reports, op-ed opinions and media interviews, and a monograph and two edited books. He executed the

organizational design for the Consultative Assembly of Parliamentarians for the International Criminal Court and the Rule of Law. His 2001 book chapter, the fruit of a research fellowship from the World Society Foundation (Zurich), was the first comprehensive and systematic study of IPIs worldwide, and founded the field of comparative IPI studies.

Sarah Delputte is a Post-Doctoral Assistant at the Centre for EU Studies (CEUS) and a Lecturer in the Department of Political Science at Ghent University, Belgium. Her primary research focus is on the EU's development policy. In particular, she concentrates on the EU's coordinator role in development policy, on the Europeanization of Member States' aid policies and, more recently, on the interaction between the EU's development and climate change policies. In addition, she has been working on the parliamentary dimension of EU cooperation with African, Caribbean and Pacific (ACP) countries. She obtained her PhD in EU Studies and Development Studies from Ghent University and the University of Antwerp respectively in 2013. Her doctoral dissertation focused on EU coordination in development cooperation, and she conducted field research in Tanzania, Zambia, Burkina Faso and Senegal. She has published in various edited volumes and international journals, including the *European Journal of Development Research*, *Development Policy Review*, *European Foreign Affairs Review*, and *European Politics and Society*. She gained practical experience on EU politics during an internship in the European Commission (2009), and was a visiting scholar at the University of Ghana Business School in Accra (2015).

Ipek Demirsu is a post-doctoral researcher in a joint project conducted by Sabancı University, Istanbul, Turkey, and KU Leuven entitled 'Assessing interdependence between the European Union and Turkey: policies and cooperation in regional and global governance'. She earned her PhD in Political Science at Sabancı University, where she has worked as a teaching assistant. She is the author of the book *Counter-terrorism and the Prospects of Human Rights: Securitizing Difference and Dissent*, published by Palgrave Macmillan. Her research interests include human rights, security studies, migration studies, democracy and pluralism.

Daan Fonck is a Doctoral Research Fellow of the Leuven International and European Studies (LINES) Institute at KU Leuven, Belgium. His PhD research focuses on the parliamentary diplomacy of the European Parliament. His research interests include EU foreign policy and the European Parliament, and parliamentary control on foreign and security policy, and his work has been published in *Cooperation and Conflict*, *Parliamentary Affairs*, *Contemporary Security Policy* and *Journal of Common Market Studies*.

John Erik Fossum is Professor of Political Science at the ARENA Centre for European Studies, University of Oslo, Norway. He was formerly a Professor at the University of Bergen. In 2015 he was Visiting Professor at the Amsterdam Centre for Contemporary European Studies (ACCESS Europe), a Jean Monnet Centre of Excellence in Amsterdam. He has also been Visiting Professor at the University of Copenhagen; Toronto Munch Centre; the Institute for European Affairs, Dublin; the McGill Centre for the Study of Canada; and the University of British Columbia (UBC). He has taught MA and PhD courses in Sydney, Dublin, Bratislava, Lucerne, Bergen and Oslo. Professor Fossum is Project Coordinator for the H2020 project EU3D – Differentiation, Dominance, Democracy and was substitute coordinator for the EU-funded Citizenship and Democratic Legitimacy (CIDEL, 2002–05) and Reconstituting Democracy in Europe (RECON, 2007–11). He is President of the Norwegian Society for European Studies (ECSA Norway) and obtained a Jean Monnet Action, Lifelong Learning Programme. He is Vice-President of the Nordic Association for Canadian Studies (NACS). His main fields of interest include political theory, democracy and constitutionalism in the EU and Canada, Europeanization and transformation of the nation state. Recent books include: *Federal Challenges and Challenges to Federalism: Insights from the EU and Federal States* (London: Routledge 2017); *The European Union's Non-Members: Independence under Hegemony?* (London: Routledge, co-edited with E.O. Eriksen, 2015); and *Practices of Interparliamentary Coordination in International Politics* (co-edited with Ben Crum, 2013).

Diane Fromage is Assistant Professor of European Law at Maastricht University, the Netherlands. Previously, she was Assistant Professor of EU Law, University of Utrecht, and a Max Weber Postdoctoral Fellow (2014–15), Max Weber programme and Law Department, EUI. She holds a PhD in Law and in Institutions, Administrations and Regional Policies from the University of Pavia (Italy) and the Pompeu Fabra University of Barcelona, Spain (joint degree). Previously, she was an associate lecturer at the Catholic University of Lille and at Pompeu Fabra (where she also coordinated an EU ALFA project for the promotion of human rights in Latin America), and a research fellow at the Max Planck Institute for Comparative Public Law and International Law, Heidelberg (Germany). Her research focuses on national and regional parliaments in the European Union, and she has addressed this topic from both a national and a European perspective. On this topic she has authored ‘The Second Yellow Card on the EPPO Proposal: An Encouraging Development for Member State Parliaments?’ in the *Yearbook of European Law* (2016) and a monograph: *Les Parlements dans l’Union Européenne après le Traité de*

Lisbonne: La participation des parlements allemands, britanniques, espagnols, français et italiens (2015). Together with Kolja Raube, Fromage recently edited a special edition of *Politique Européenne* (2018) titled ‘Les parlements des États membres face au(x) défi(s) européen(s)’, for which they also authored the introductory article, ‘Les parlements des États membres dans une Union européenne en constante mutation’.

Maria Gianniou (PhD) is a Research Associate at Athens University of Economics and Business, Department of International and European Economic Relations, Greece. Her recent publications include: ‘The formation of the EU negotiating strategy at the UN: the case of human rights’, *Cambridge Review of International Affairs* (co-authored with I. Galariotis and I. Iakovidis, 2019) and, as co-author with Spyros Blavoukos, Dimitris Bourantonis and Ioannis Galariotis (2016), ‘The European Union’s visibility and coherence at the United Nations General Assembly’, *Global Affairs*, 2(1), 35–45.

Cosima Glahn has worked as a Research Fellow at the Institute for East European Studies of the Freie Universität Berlin, Germany, since October 2013. She holds a BA in Political Science from the University of Mannheim and an MA in International Studies/Peace and Conflict Studies from the TU Darmstadt and the Johann Wolfgang Goethe University Frankfurt/Main. During her MA studies she did an exchange semester at the University of Aberystwyth, Wales. She was a student research assistant at the Peace Research Institute Frankfurt (PRIF) and worked as a junior policy advisor at the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) from December 2012 until October 2013. Her main academic interests are, among others, the foreign policy and especially the neighbourhood policy of the European Union.

Magdalena Góra earned her MA in Political Science from Jagiellonian University, Poland, in 2000. Her PhD (2007) was on the relations between Poland and Israel after the Second World War. Since 2007, she has been a researcher at the university’s Institute of European Studies, primarily concentrating on the changes in foreign policy and international relations in Central and Eastern Europe in the context of European integration (in particular in the context of Common Foreign and Security Policy) as well as on collective identification changes in the European Union after enlargement and its influence on democracy in Europe. She has studied and worked at academic institutions in several countries (Poland, the UK, the USA, Sweden and Norway). Her recent publications include ‘Defenders of faith? Victims of secularisation? Polish politicians and religion in the European Parliament’, co-authored with K. Zielińska, in the

journal *Religion, State and Society* (2014). She has also co-edited *Collective Identity and Democracy in the Enlarging Europe* (with K. Zielińska and Z. Mach, 2012) and *Democracy, State and Society: European Integration in Central and Eastern Europe* (with K. Zielińska, 2011).

Afke Groen is a PhD candidate at the Department of Political Science at Maastricht University and the Amsterdam Institute for German Studies, the Netherlands. She holds an MSc in European Studies from Maastricht University and a BA in International Relations from the University of Groningen. She has previously been involved in various research projects about the role of national parliaments in the EU, including the Observatory of Parliaments after Lisbon (OPAL). Her PhD research focuses on inter-parliamentary cooperation in the EU, with a special focus on transnational relations between political parties.

Seda Gürkan is a Lecturer at the European Studies Institute of Free University of Brussels (Université libre de Bruxelles – ULB). She received her PhD in Political Science/International Relations from ULB and her MSc in European Studies from the London School of Economics (LSE). She was a resident research fellow at the Center for Transatlantic Relations, Paul H. Nitze School of Advanced International Studies (SAIS), Johns Hopkins University in Washington DC in 2012. She is also a graduate of the Diplomatic School of the Spanish Ministry of Foreign Affairs in Madrid. Previously, she worked at NATO Headquarters in Brussels in the cabinet of the Assistant Secretary General for Defence Investment (2006–12). There she worked on political-military affairs, and security and defence issues, including missile defence, cyber defence, counter-terrorism and NATO–EU relations. She offered senior courses on international relations and diplomacy at the NATO Defense College (Rome, Italy) and the NATO School in Oberammergau (Germany). Dr. Gürkan was a Robert Schuman Scholar at the European Parliament in 2003. She is a holder of a NATO research award and a Jean Monnet award granted by the European Commission. Her research interests include international institutions, Europeanization, foreign policy of Turkey and Turkey–EU relations.

Davor Jančić is Senior Researcher in EU Law at the T.M.C. Asser Instituut, The Hague, Netherlands. He was previously British Academy Newton Fellow at the Department of Law of the LSE and Political Science and Assistant Professor at Utrecht University Law School, Netherlands. He holds a PhD on national parliaments in the EU from Utrecht University. Dr Jančić has been a visiting scholar at Sciences Po Paris, LSE, the University of Lisbon and the Max Planck Institute for Comparative Public Law and International Law in Heidelberg. In 2011,

he won the Europe Award from the Montesquieu Institute, The Hague. His work has appeared in the *European Law Journal*, *Common Market Law Review*, *Columbia Journal of European Law*, *Cambridge Yearbook of European Legal Studies*, and *Journal of Common Market Studies*. He co-edited a special issue on Parliamentary Diplomacy in European and Global Perspectives with *The Hague Journal of Diplomacy* (2016), and he is the editor of *National Parliaments after the Lisbon Treaty and the Euro Crisis: Resilience or Resignation?* (OUP, 2017).

Tobias Lenz is Assistant Professor (Juniorprofessor) of Global Governance and Comparative Regionalism at the University of Göttingen and at the GIGA German Institute of Global and Area Studies, Hamburg. He was Max Weber Fellow at the European University Institute, Florence (2016–17) and holds a DPhil in International Relations and an MPhil in Politics, both from Oxford University. His research interests include international organizations, comparative regionalism, legitimacy and legitimation, and EU external relations. His work has appeared in journals such as *European Journal of International Relations*, *International Studies Quarterly*, *International Theory*, *Journal of European Public Policy*, *Review of International Organizations* and *Review of International Studies*, among others. He is the co-author of *Measuring International Authority: A Postfunctionalist Theory of Governance* (Oxford University Press, 2017) and of *A Theory of International Organization* (Oxford University Press, forthcoming in 2019).

Alexander von Lingen was born in Berlin and studied at the University of Bonn, University of Cologne and Osgood Hall Law School (Toronto). He holds degrees in Law and Economics. Following an internship at the European Commission's information service, he was admitted in 1973 to the European civil service. Working in the European Parliament (EP), his responsibilities included information and public relations, including in relation to the 1979 first direct elections. In 1990, he was assigned to the European Commission's Directorate General for External Relations, participating for a year in the initial negotiations with the former Communist countries of Eastern Europe. Returning to the EP, he established the documentation and analysis centre on Central and Eastern Europe and, as part of the pre-accession strategy, helped institutionalize relations with their parliaments through joint committees and delegations. As from 1996, he worked in the EP Presidency as head of the task force for cooperation with the parliaments of those accession and candidate countries, and subsequently in the College of Quaestors. He has lectured on European public affairs since the early 1990s at universities in the United States, Canada and future Member States. After over 30 years as an EU official, he became and remains founding chairman of EquipEuropa, a non-profit organization

conducting training for young lawyers, economists and journalists in European public affairs. With Robert M. Cutler he has co-authored numerous scientific and policy publications on parliamentary issues.

Christopher Lord is a Professor at the ARENA Centre for International Studies, University of Oslo. He is the author of several books and articles on legitimacy, democracy and the European Union – his main fields of academic interest and study. He has done considerable amounts of research and has published extensively on these topics. He has also worked on topics such as the history of British relations with the European Communities, EU foreign policy, political economy of monetary union and political parties in the EU.

Ana María Moure holds a PhD in European Law from the University of Alcalá, Spain/TU Dresden University, Germany and a master's (LLM) in European Union Law from the University of Leiden, Netherlands. She is Director of International Affairs and Associate Professor of the course Public International Law and the course on European Union Law and Latin American Integration at the Department of International Law, University of Chile. She has been Legal Advisor of the Inter-American Development Bank (IDB), the United Nations Development Program (UNDP) and the National Council for Children (SEGPRES).

Meltem Müftüler-Baç is Professor of International Relations and Jean Monnet Chair *ad personam* at Sabancı University, and was an Affiliate Professor at the University of Stockholm from 2013 to 2016. She received her PhD in Political Science from Temple University, USA in 1992. She worked previously at Temple University and Bilkent University (Turkey), and was a visiting professor at the University of Chicago. Professor Müftüler-Baç authored *Turkey's Relations with a Changing Europe* (Manchester University Press, 1997); *Turkey and the European Union Relations: Dilemmas, Opportunities and Constraints*, co-edited with Yannis Stivachtis (Lexington Books, 2008); and *Divergent Pathways: Turkey and the European Union* (Barbara Budrich, 2016). Her publications have appeared in *Journal of European Public Policy*, *Middle Eastern Studies*, *East European Quarterly*, *Journal of European Integration*, *South East European Politics and Society*, *Security Dialogue*, *International Studies Perspectives*, *Turkish Studies*, *Women's Studies International Forum*, *West European Politics*, *International Journal*, *Journal of Democracy*, *Journal of Language and Politics*, and *Asia-Europe Journal*. She participated in the F6 project 'Reconstituting Democracy in Europe' (2006–12), LISBOAN (2011–13), the FP7 project 'TRANSWORLD' (2012–15) and the FP7 project 'MAXCAP' (2013–16). She received two grants under the EU Jean Monnet Project (2002

and 2008), both for teaching politics of European integration. In 2011, she was granted a Jean Monnet Centre of Excellence. Her work is widely cited in Turkey–European Union relations, on EU enlargement, Turkish foreign policy and Turkish politics. Professor Müftüler-Baç holds two prestigious awards from the Turkish Academy of Sciences: Young Social Scientist Investigator Award (2002) and Distinguished Young Scientist Award (2003). She was awarded the Jean Monnet Professor *ad personam* title from the European Commission in 2004.

Gustavo G. Müller is a Senior Researcher at the Leuven Centre for Global Governance Studies and a Postdoctoral Fellow at the Centre for European Studies, KU Leuven, where he teaches the ‘Master of European Studies: Transnational and Global Perspectives’. He holds a double doctoral degree in Politics and International Studies from the University of Warwick (UK) and the Université libre de Bruxelles (Belgium). In 2011, he was awarded a European Commission Erasmus Mundus Doctoral Fellowship via the Globalization, Europe and Multilateralism (GEM) PhD School. His research interests include comparative regionalism, Europe–Latin America relations, legitimacy and global governance, world order and international relations, and regional security governance and its organizations.

Xavier Nuttin was Senior Asia Analyst in the Policy Unit of the Directorate General for External Relations of the European Parliament (EP) from June 2005 to March 2018. His main responsibility was to provide tailor-made political analysis of Asian countries and advice to the President of the EP and to parliamentary bodies such as the Foreign Affairs Committee and the Development Committee. In this capacity he has participated in many international conferences and workshops on Asian affairs, particularly in China and ASEAN countries (including in Myanmar), where his institutional knowledge of the EU institutions and EU policies regarding Asia has been particularly useful. He has written many papers for those events and contributed to two books: *Myanmar: Prospect for Change* (Select Publishing, Singapore, 2010) and *EU–ASEAN Relations in the 21st Century* (Palgrave Macmillan, 2012). Prior to holding this position, Xavier Nuttin had a career in international development and foreign relations. As an official of the European Commission from 1993, he was successively posted at its headquarters in Brussels, the EC Delegation to Thailand and then to the EC Delegation to Vietnam, where he further developed his interest in and knowledge of the political situation of Southeast Asia, including human rights and rule of law aspects. He was also based in Bangkok in the late seventies and early eighties working on education and health programmes in several countries in Asia for UNESCO, UNICEF

and the World Bank. He is now Senior Associate and Advisory Board Member of the European Institute for Asian Studies (EIAS), a think-tank based in Brussels.

Linda Oehman holds an MSc in Peace and Conflict Studies from Uppsala University, Sweden, where she specialized in security studies. She has been affiliated with, among others: the United Nations International Organization for Migration (IOM); the NATO Parliamentary Assembly in Brussels; and the Swedish Defence University in Stockholm, as well as the Center for Strategic and International Studies (CSIS) in Washington, DC.

Dirk Peters is a Senior Research Fellow at the Peace Research Institute Frankfurt (PRIF). His research focuses on the role of parliaments in EU and national security policies, and on wider questions of decision-making and legitimacy in international organizations. His articles have appeared in *Parliamentary Affairs*, *Armed Forces and Society* and the *Cambridge Review of International Affairs*, among others. He is the author of *Constrained Balancing: The EU's Security Policy* (Palgrave Macmillan, 2010) and the co-editor of *The Parliamentary Control of European Security Policy* (Arena, 2008).

Irina Petrova is a PhD fellow at the Leuven International and European Studies (LINES) Institute, Belgium. Her research concentrates on comparative analysis of the EU and Russia's power, foreign policy strategies and perceptions thereof in the Eastern Partnership countries. She holds degrees in Modern and Contemporary History from Bryansk State University (Russia) and Public Policy from the University of Erfurt (Germany). Previously Irina Petrova worked as an academic assistant in the programme 'Master of European Studies: transnational and global perspectives' at KU Leuven, a research assistant at the University of Kent and Adjunct Fellow at Vesalius College, VUB. She has also contributed to the Friedrich Ebert Shifting project 'Towards a new order: foreign policy tools of the EU and how to reshape them' and NGO, European Movement International project on 'Foreign affairs, enlargement and security policy'.

Kolja Raube is Assistant Professor for European Studies at KU Leuven, Senior Member of the Leuven Centre for Global Governance Studies and Member of the Leuven International and European Studies (LINES) Institute, Belgium. He is also Programme Coordinator of the 'Master of European Studies: transnational and global perspectives', KU Leuven. In addition, he is Adjunct Professor at the American University Washington DC (Brussels). He has been Visiting Professor at Kobe University, Japan, and Visiting Research Fellow at the EU Studies Centre at the University of Illinois at Urbana-Champaign. He has published widely on the European

Parliament in EU foreign policy and inter-parliamentary cooperation in the EU. His articles and chapters have appeared in the *British Journal of Politics and International Relations*, *Global Affairs*, *Politique Européenne*, *Cambridge Review of International Affairs*, the *Journal of European Integration*, *European Foreign Affairs Review*, the *Hague Journal of Diplomacy*, the *International Spectator* and the *Asia-Europe Journal* as well as through Oxford University Press, Palgrave, Routledge and Hart. He is the co-author of several in-depth studies, commissioned by the European Parliament, on the EU and international affairs. He has also appeared and testified in the Security Committee of the European Parliament.

Lorinc Redei joined the LBJ School of Public Affairs at the University of Texas, USA as a full-time lecturer in 2013. He had previously been Adjunct Professor at the LBJ School and at Southwestern University (also Texas). He earned his BA in Political Science from Middlebury College (Vermont), his MA in European Studies from the BMW Center for German and European Studies at the Edmund A. Walsh School of Foreign Service at Georgetown University (Washington DC), and his PhD in International Relations from Central European University in Budapest (Hungary). He also has policy experience within the institutions of the European Union: from 2005 to 2008, he worked as a Press Officer at the European Parliament, primarily focusing on the work of the Foreign Affairs Committee and the Parliament's relations with actors outside of the EU. He returned to Brussels in 2011 to handle the Hungarian-language press communications for the European Parliament during Hungary's six-month Presidency of the European Council. Dr Redei's research takes advantage of these experiences, focusing on the role of the European Parliament in the EU's foreign policy-making process, especially its parliamentary diplomacy. He also writes on the image of the EU as a normative power, the EU's contribution to the European security architecture, and various topics in transatlantic relations.

Guri Rosén is a Postdoctoral Fellow at the ARENA Centre for European Studies, University of Oslo and guest researcher at the Centre for European Research University of Gothenburg (CERGU), Sweden. Her research focuses on the European Parliament's role in EU external relations, EU interinstitutional relations, and the role of transparency and democracy in foreign policy. Zachary Selden is a Professor of Political Science at the University of Florida (USA). He was previously the Deputy Secretary General for Policy at the NATO Parliamentary Assembly based in Brussels from 2008 to 2011. He was the Director of the Defence and Security Committee of the NATO PA from 2003 to 2007.
