Kai Ambos holds, since May 2003, the Chair of Criminal Law, Criminal Procedure, Comparative Law, International Criminal Law and International Law at the Georg-August-University Göttingen, Germany. He served as a Judge at the Provincial Court (Landgericht) of Lower Saxony in Göttingen from 24 March 2006 to 7 February 2017 (from January 2015 to 30 September 2015 delegated to the Appeals Court (Oberlandesgericht) Braunschweig); with his appointment as Judge at the Kosovo Specialist Chambers (KSC), The Hague, on 7 February 2017 he took leave from this judicial position. On 6 December 2017 he was appointed Advisor (Amicus Curiae) to the Colombian Special Jurisdiction for Peace. He is also List Counsel at the International Criminal Court.

Since December 2013, Judge Ambos has also been Director of the Centro de Estudios de Derecho Penal y Procesal Penal Latinoamericano (CEDPAL) of Georg-August-Universität Göttingen. He serves as Editor-in-Chief of *Criminal Law Forum* (Springer, Society for the Reform of Criminal Law) and, in a different capacity, as a member of various editorial boards of national and international journals. He is general coordinator of the Anglo-German Dialogue on 'Core Concepts in Criminal Law and Justice' and general editor of the three volumes product of this dialogue to be published by Cambridge University Press. He was Senior Research Fellow, Institute for Advanced Studies, Hebrew University, Jerusalem; Fellow, Faculty of Law and Clare Hall College, University of Cambridge, UK; Plumer Fellow, St Anne's College and Visiting Fellow, Centre for Criminology, University of Oxford, UK; and, Visiting Professor in China, Italy, Israel, Latin America (Argentina, Brazil, Chile, Colombia, Ecuador, Mexico, Peru), Spain and the USA.

Roberta Arnold PhD (Bern), LL.M (Nottingham) is a qualified attorney (2009) in Switzerland and a retired specialist officer (Major) – examining military magistrate – of the Swiss Military Justice (2005–17). She specializes in international criminal law (ICL) and the laws of armed conflict (LOAC). She works as investigator-in-charge at the Federal Department of Justice and Police and as lecturer on 'Law and terrorism' and 'Criminal law' at the Universities of Lucerne and Zurich. As a freelance consultant she has been invited by various organizations (e.g. the ICRC, UNOG, the San Remo IHL, the TMC Asser Institute), universities (Stanford, Bristol, Liverpool, Trieste, Bern, Zurich, Webster University in Geneva) and military academies (Zurich, Shrivenham, Vienna), to lecture and train law enforcement authorities, military and civilian personnel and students, on IHL, ICL and gender related issues.

She has previously worked as Public Prosecutor in Canton Ticino (2015–17) and as legal adviser for the *Competence Centre for International Criminal Law* and the *Anti-Terrorism Division* of the Federal Attorney General's Office (2010–15). Between 2012–15 she was a researcher at the Chair of Strategic Studies of the Military Academy at ETH Zurich and the editor-in-chief of the *Military Law and the Law of War Review*.

After completing her PhD in 2004 on *The ICC as a New Instrument for the Repression of Terrorism* (Transnational Publishers/Brill) – which was awarded the Francis Lieber

Honourable Mention Award from ASIL and the Walther Hug Prize – she worked as LEGAD (Laws of Armed Conflict section, 2003–2005) and as POLAD (Arms Control and Disarmament Policy section, 2008–10) for the Federal Department of Defence.

A graduate from the University of Bern (1999), where she obtained her PhD in 2003, she holds an LLM in international criminal justice and armed conflict law from the University of Nottingham (2000). Her further studies include law at the University of Sheffield (1996–97) and Middle Eastern politics at Tel Aviv University (1998).

Her current focus of research is on counter-terrorism and its implications under criminal (procedural) law at domestic and international level.

Julie Atwell BA (Hons), LLB (University of Queensland), Master of International Law (Australian National University) was a member of the study group established by the International Civil Aviation Organization (ICAO) Secretariat concerning new and emerging threats to international civil aviation and was appointed Rapporteur on this issue by the Chairman of the ICAO Legal Committee in 2007. She was a Principal Legal Officer in the Office of International Law in the Australian Attorney-General's Department between 2000 and 2010. She was head of the Australian delegation to the diplomatic conference which adopted the Beijing Convention and the Protocol to the Convention for the Suppression of Unlawful Seizure of Aircraft in September 2010. She was also head of the Australian delegation for the Legal Committee meeting of the International Maritime Organization in May 2003.

Ilias Bantekas is Professor of International Law and Arbitration at the Hamad bin Khalifa University in Qatar and Senior Fellow at the Institute of Advanced Legal Studies of the University of London. He was a Professor of Law at Brunel University London from 2006–18. He has held appointments at several universities, including Harvard, Miami, Cleveland-State, SOAS (University of London), Trier, Cagliari and elsewhere. He frequently serves as arbitrator in international commercial disputes and has advised governments and international organizations in matters pertinent to international law and arbitration, including UNDP, UN Special Procedures, Council of Europe, IDEA and the European Union. In 2011 he was nominated by UNDP to co-author the Constitution of South Sudan and in 2015 he was a senior member of the Greek Parliament's Committee on the Truth of the Greek Debt. Major works include: *International Human Rights Law* (3rd edn, CUP, 2020, with L Oette); *Introduction to International Arbitration* (CUP, 2015); *Sovereign Debt and Human Rights* (OUP, 2018, with C Lumina); *Commentary on the Convention on the Rights of Persons with Disabilities* (OUP, 2019, with MA Stein); and *International Law* (4th edn, OUP, 2019, with E Papastavridis).

Jessie Blackburn is Assistant Professor in Public Law and Human Rights at Durham Law School, Durham University. Her interests lie in the field of anti-terrorism laws, with a particular focus on oversight and review of those laws in comparative perspective. Jessie has published widely in this field, including in the *Modern Law Review*, *Statute Law Review* and *Parliamentary Affairs*. She is also the author of *Anti-Terrorism Law and Normalising Northern Ireland* (2014), and co-author of *Accountability and Review in the Counter-Terrorist State* (2019) (with Fiona de Londras and Lydia Morgan) and *Anti-Terrorism Law and Foreign Terrorist Fighters* (2018) (with Deniz Kay and Nicola McGarrity). Jessie has a PhD in Politics from Queen's University Belfast and a Masters of Law from Birkbeck College, University of London.

Silvia Borelli (*Laurea* in Law (Parma); MA International Relations (Bologna); PhD (Milan)) is Principal Lecturer in the University of Bedfordshire School of Law and Director of the University's Centre for Research in Law. She is also a visiting lecturer at King's College London. She has previously held research and teaching roles at University College London and the Catholic University of Milan, and worked as a researcher for INTERIGHTS, London. She collaborates as an academic consultant with several human rights NGOs and has been involved in a wide range of human rights cases before domestic and international jurisdictions. Dr Borelli has published extensively on human rights and counterterrorism, the extraterritorial application of human rights and protection of individuals against wrongful transfer and *refoulement*. In 2012, she was appointed a member of the Peer Review College of the UK Arts and Humanities Research Council (AHRC).

Iliaria Bottigliero (PhD in International Law and Diplôme d'Études Supérieures in International Law, Graduate Institute of International Studies, Geneva and *Laurea* in Political Sciences, La Sapienza, Rome) is Director of Policy, Research and Learning at the International Development Law Organization (IDLO), where she directs the Organization's research on rule of law and justice-related issues. Prior to joining IDLO, she was Lecturer and Researcher at the Raoul Wallenberg Institute of Human Rights and Humanitarian Law in Lund, Sweden, and at the Lund University Faculty of Law, where she taught humanitarian law as well as a number of international law courses. Dr Bottigliero was also a Lecturer at the Chinese University of Hong Kong and at the University of Hong Kong Faculty of Law, teaching courses on international humanitarian law, public international law and gender, and law and politics. She is the author of *Redress for Victims of Crimes under International Law* (2004), as well as several scholarly publications on victims' rights, international criminal justice and gender issues, among others. She is the recipient of the 2010 Worldwide Universities Network (WUN) International and Comparative Criminal Justice Network (ICCJnet) Fellowship.

Jane Boulden holds four degrees from Queen's University: BAH, MA, and PhD, all in International Relations, as well as an LLM in International Law. From 2004–14 she held the Canada Research Chair (CRC) in International Relations and Security Studies at the Royal Military College of Canada where she is currently a professor. Beginning in 2000, she was a MacArthur Research Fellow at the Centre for International Studies, University of Oxford where one of her areas of focus was on the United Nations responses to terrorism. She has published widely on issues relating to the work of the United Nations and is currently mainly focused on the work of the United Nations Security Council. She has served as a consultant to various government departments, as well as to a variety of research organizations and think tanks, and been awarded funding from the United States Institute of Peace, and the Carnegie Corporation of New York.

Elizabeth Chadwick has been a Reader by research at Nottingham Trent University since 2007. Her main research (and teaching) interests lie in the fields of international humanitarian law, the self-determination of 'peoples', international terrorism, and international crimes. She is the

author of *Self-Determination in the Post-9/11 Era* (Routledge Research in International Law, 2011), as well as of a number of book chapters and journal articles on a variety of related topics. Other teaching interests include intellectual property law.

Simon Chesterman is Dean of the National University of Singapore Faculty of Law. He is also Editor of the *Asian Journal of International Law*. Educated in Melbourne, Beijing, Amsterdam and Oxford, Professor Chesterman's teaching experience includes periods at the Universities of Melbourne, Oxford, Southampton, Columbia and Sciences Po. From 2006–11, he was Global Professor and Director of the New York University School of Law Singapore Programme. Prior to joining NYU, he was a Senior Associate at the International Peace Academy and Director of UN Relations at the International Crisis Group in New York. He has previously worked for the UN Office for the Coordination of Humanitarian Affairs in Yugoslavia and interned at the International Criminal Tribunal for Rwanda. Professor Chesterman is the author or editor of 12 books, including *One Nation Under Surveillance* (2011); *Law and Practice of the United Nations* (with Thomas M Franck and David M Malone, 2008); *You, The People* (2004); and *Just War or Just Peace?* (2001).

Gloria Cheung is an undergraduate student at the University of California, Berkeley currently pursuing degrees in Middle Eastern Studies and Political Science. She was Research Assistant to Professor Rohan Gunaratna, the Head of the International Center for Political Violence and Terrorism Research, S. Educated at the Raffles Institution in Singapore, she previously interned at the Middle East and North Africa directorate in Singapore's Ministry of Foreign Affairs.

James Cockayne is Director of the United Nations University Centre for Policy Research (until June 2020) and Professor of Global Politics and Anti-Slavery at the University of Nottingham (from July 2020). He previously served as Co-Director of the Center on Global Counterterrorism Cooperation in New York, leading their work at the UN and in Africa. James was also Principal Legal Officer in the Transnational Crime Unit of the Australian Attorney-General's Department, and Chair of the Editorial Committee of the *Journal of International Criminal Justice*. He was a founding editorial committee member of the *Journal of International Humanitarian Legal Studies*. His books include *Hidden Power: The Strategic Logic of Organized Crime* (Hurst/OUP, 2016); *Peace Operations and Organized Crime: Enemies or Allies?* (Routledge, 2011, edited with Adam Lupel); and *Beyond Market Forces: Regulating the Global Security Industry* (IPI, 2009).

Emily Crawford BA (Hons), LLB, PhD is an Associate Professor at the University of Sydney Law School, where she teaches and researches in international law, international humanitarian law and international criminal law. She has published widely in the field of international humanitarian law, including two monographs (*The Treatment of Combatants and Insurgents under the Law of Armed Conflict* (OUP, 2010) and *Identifying the Enemy: Civilian Participation in Hostilities* (OUP, 2015)) and a textbook (*International Humanitarian Law* (with Alison Pert, OUP, 2015)), and is currently working on her third monograph, on the impact of non-binding instruments in international humanitarian law. She is an associate of the Sydney Centre for International Law at the University of Sydney, and a co-editor of the *Journal of International Humanitarian Studies*.

Fiona de Londras is Professor of Global Legal Studies at Birmingham Law School, University of Birmingham and Honorary Professor at the Australian National University. Her work is focused primarily on the role of rights in contentious policy fields, with a particular focus on counter-terrorism. Her research has been funded by the European Commission, British Academy, Joseph Rowntree Charitable Trust, and Leverhulme Trust. She was awarded the Philip Leverhulme Prize in 2017, which supports her research agenda from 2018–21.

Marcello Di Filippo holds a PhD in International and European Community Law from the University of Rome ‘La Sapienza’. In 2001 he was appointed as Associate Professor in International Law at the University of Pisa, while in 2016 he got his Full Professorship in the same university. From 1999 to 2014 he taught International Law and Humanitarian Law in the Italian Navy Academy for officials of the ‘Stato Maggiore’. His main areas of research are international criminal law, jurisdictional immunity of international organizations, migration and refugee law, media law and regional international organizations. He is a member of the International Institute of Humanitarian Law (Sanremo and Geneva) and of the Scientific Committee of the Italian Council for Refugees. He is member of the Scientific Committee for the legal journal *Revista de Derecho Comunitario Europeo*. Amongst his publications, a particular mention must be made of an extensive article on the definition of terrorism published in the *European Journal of International Law* in 2008. In 2014, he launched and since then coordinates the Observatory on EU Migration Law (University of Pisa). In 2015–18 he coordinated the Jean Monnet Module on ‘EU Migration Law, Human Rights and Democratic Principles’.

Anton Du Plessis (B-Iuris, LLB, LLM) is Executive Director of the Institute for Security Studies (ISS) in South Africa. He has worked on human security, international criminal justice and rule of law issues in over 20 African countries, with a focus on delivering training and technical assistance to senior law enforcement and criminal justice officials. He has worked as a senior legal expert and consultant and expert adviser to various UN entities and other intergovernmental organizations, including the UN’s Counter-Terrorism Implementation Task Force, and is vice-chair of the World Economic Forum’s Global Agenda Council on Terrorism. Before assuming his current positions, Anton was head of the International Crime in Africa Programme (ICAP) at the ISS. Prior to joining the ISS to found ICAP in early 2008, Anton was a criminal justice and counter-terrorism legal expert for the United Nations Office on Drugs and Crime (UNODC) in Vienna. Anton has also worked as a Senior State Advocate at the National Prosecuting Authority of South Africa where he specialized in the prosecution of serious and violent offences, including rape and gang-related crimes. Anton has published numerous articles, book chapters and training guides, and is the co-author of *Counter-Terrorism Law and Practice: A Practitioners’ Handbook* (2009).

Helen Duffy runs an international human rights practice (‘Human Rights in Practice’) in The Hague that seeks innovative ways to secure justice and counter impunity for serious human rights violations. She provides legal representation and support in cases in the Inter-American, African and European human rights systems, and before treaty bodies, sub-regional courts and national proceedings where issues of international law and practice arise. She has many publications in the field of terrorism and national security including ‘The War on Terror and the Framework of International law’ (CUP, 2005; 2nd edn, 2014). Prior positions include: Legal Director of INTERIGHTS; Legal Officer at the International Criminal Tribunal for the former Yugoslavia; Counsel to Human Rights Watch; Legal Director of CALDH (Centre for

Human Rights Legal Action) Guatemala; Legal Adviser to the UK 'Arms for Iraq' Inquiry and Legal Officer in the UK government legal service. She is Honorary Professor of International Law at the University of Glasgow and teaches at the universities of Leiden and Webster. Helen is a graduate of the universities of Glasgow (LLB), University College London (LLM), Edinburgh (Dip.LP) and Leiden (PhD). She serves on the advisory boards of several NGOs.

Martin Ewi (BA (with Distinction), Peace Studies and International Politics (Juniata College), MA, International Peace Studies (University of Notre Dame)) has been Senior Researcher at the Institute for Security Studies in South Africa since 2010. From 2005–10 he was the Political Affairs Officer for the Organisation for the Prohibition of Chemical Weapons. From 2002–2005 he was the African Union Counter-terrorism Analyst and concurrently the Officer-in-Charge of the Strategic Security Issues Unit, Addis Ababa and from 2005–10 he was a Political Affairs Officer at the Technical Secretariat of the Organisation for the Prohibition of Chemical Weapons (OPCW). Throughout this time he has conducted research and analysis as well as practical implementation and advice activities. In his current role he advises, trains and conducts research on transnational threats and international crimes in Africa for states, pan-African organizations, civil society and research institutions.

David Fidler is a visiting professor at the Washington University School of Law and an adjunct senior fellow with the Council on Foreign Relations, USA. He has worked and published extensively on security challenges presented by biological, chemical, nuclear and cyber weapons, including *Biosecurity in the Global Age: Biological Weapons, Public Health, and the Rule of Law* (2008) (with Lawrence O Gostin) and 'The Meaning of Moscow: "Non-lethal" Weapons and International Law in the Early 21st Century' (2006) 87 *International Review of the Red Cross* 525. He holds a JD from Harvard Law School, an MPhil in international relations from the University of Oxford and a BCL from the University of Oxford.

Mary Flanagan studied law at University College Dublin and Université Paris X, then qualified as a barrister at the Society of the Kings Inns in Dublin. She then completed the BCL at Oxford. She spent four months in New York working with the Delegation of the European Union to the UN, after which she did an internship in President Meron's office at the International Criminal Tribunal for the Former Yugoslavia. She then worked for a year in the legal division of the Irish Ministry of Foreign Affairs and Trade, primarily on law of the sea matters. She was an academic visitor at the Sydney Centre of International Law at the Faculty of Law, University of Sydney in late 2013.

Craig Forcese (BA, Jnt Geography/Anthropology (McGill University), MA, International Affairs (Carleton University), LLB (University of Ottawa), LLM (Yale Law School)) is an Associate Professor and Vice Dean at the University of Ottawa, Faculty of Law. From 2010–12 he was the President of Canadian Council on International Law. He is the author and editor of numerous books, which include *National Security Law: Canadian Practice in International Perspective* and *The Human Rights of Antiterrorism*. He has also written a number of journal articles in the area of national security law and has appeared a number of times before the Canadian Parliament and as an expert witness at Public Inquiries dealing with national security matters.

Geoff Gilbert (LLB (Hons) (Leicester), LLM, SJD (Virginia), Barrister-at-Law (NP)) is a Professor of International Human Rights & Humanitarian Law in the School of Law and

Human Rights Centre at the University of Essex and has been a Professorial Visiting Fellow at the University of New South Wales, Sydney, in 2012. He was Editor-in-Chief of the *International Journal of Refugee Law* from 2002–15 and he sits on the Advisory Board. In 2014, he was appointed a consultant to UNHCR (with Anna Magdalena Rüsçh) on Rule of Law: Engagement for Solutions, carrying out field missions in Niger and Colombia, and he is part of the Solutions Alliance Thematic Group on Rule of Law. In 2017–18, he received an ESRC Impact Acceleration Award to second him to UNHCR where he worked on the Global Compact on Refugees, on the Political Participation of Refugees in their Country of Nationality, and on Exclusion and National Security.

Lisa Ginsborg works at the EUI School of Transnational Governance and is a Lecturer in International Human Rights at NYU Florence. She has worked as a Post-Doctoral Researcher at University College Dublin (UCD) and at the EUI-based Centre for Media Pluralism and Media Freedom in the Robert Schuman Centre for Advanced Studies; as a Teaching Fellow at the European Inter-University Centre for Human Rights and Democratisation (EIUC); and was a visiting researcher at New York University School of Law and at the Sydney Centre for International Law at the University of Sydney. Previously she worked in the legal department of the International Secretariat of Amnesty International (2006–2009) and in the NGO Liaison Office of the Office of the UN High Commissioner for Human Rights (OHCHR) (2005–2006). She holds a PhD in Public International Law from the EUI and an MSc in Political Sociology from the London School of Economics and Political Science (LSE).

Elsbeth Guild is Jean Monnet Professor *ad personam* at Radboud University, Nijmegen and Queen Mary, University of London, and Senior Research Fellow at the Centre for European Policy Studies in Brussels. Professor Guild has specialized in EU borders and immigration law for more than 20 years. She also researches EU privacy and data protection law and the nexus with human rights. She co-ordinated the European Commission's Network of Experts on Free Movement of Workers at Radboud, bringing together academic experts from the 28 Member States. She is also co-editor of the *European Journal of Migration and Law* and *Free Movement of Workers* (the European Commission's on-line journal) and on the editorial board of the *Journal of International Political Sociology*. She is co-editor of the book series *Immigration and Asylum Law and Policy in Europe*. Professor Guild provides regular advice to the European Parliament, the European Commission, the Council of Europe and others on migration law issues. Her recent publications include: *Security and Migration in the 21st Century Polity* (2009); and (with SA Mantu), 'Acts of Citizenship Deprivation: Ruptures between Citizen and State' in EF Isin and M Saward (eds), *Enacting European Citizenship* (2013).

Rohan Gunaratna is Head of the International Centre for Political Violence and Terrorism Research and Professor of Security Studies at the S. Rajaratnam School of International Studies at the Nanyang Technological University in Singapore. He is a specialist of the global threat environment. He serves on the board of advisers of the International Centre for Counter Terrorism, The Hague, and the International Institute for Counter Terrorism, Israel; the World Economic Forum's Global Agenda Council on Terrorism; and the Steering Committee of George Washington University's Homeland Security Policy Institute. Author and editor of 16 books, he wrote the international bestseller *Inside al Qaeda: Global Network of Terror*. He received a PhD in International Relations from the University of St Andrews, where he was

British Chevening Scholar, and an MA in International Peace Studies from the University of Notre Dame, where he was Hesburgh Scholar.

Luis Miguel Hinojosa-Martínez is the Director of the Department of Public International Law and International Relations of Granada University. After working as an attorney in Brussels, he joined Granada University teaching staff. His main areas of teaching and research include international economic law, European Union law and international terrorism. He has written books on international economic law (2010), the financing of international terrorism (2008), the competencies of the European Union (2006), fair trade and social rights (2002) and the international and European regulation of capital movements (1997). He is a member of the Editorial Boards of the *Revista de Derecho Comunitario Europeo* and the *Revista Española de Derecho Internacional*. He is also a member of the Executive Boards of both the European Society of International Law and the Spanish Association for the Study of European Law, and a member of the Society of International Economic Law and the Spanish Association for International Law (and a former member of its Executive Board). Professor Hinojosa has been a Visiting Scholar in the Stetson School of Law, Florida (2007) and in Berkeley University, California (2010). He obtained his law degrees at Granada University (PhD, 1996); London School of Economics and Political Science, London University (LLM, 1990); and the Institut d'Etudes européennes, Université Libre de Bruxelles (Licence spécial en droit européen, 1989).

Jayne Huckerby is Professor of Clinical Law at Duke University School of Law, where she directs the International Human Rights Clinic. Her scholarly publications focus on gender and human rights, counter-terrorism, and trafficking in persons, and she is co-editor of *Gender, National Security, and Counter-Terrorism: Human Rights Perspectives* (2012). She was previously Research Director and Adjunct Professor of Clinical Law at the Center for Human Rights and Global Justice at New York University (NYU) School of Law and has also served as an advising expert to regional bodies and UN special procedures and agencies in the areas of gender equality and constitutional reform, gender and counter-terrorism, gender and human rights indicators, gender and conflict, anti-trafficking, gender budget initiatives, and violence against women. She holds a BA and LLB (Hons 1) from the University of Sydney and an LLM from NYU School of Law.

Sandra Krähenmann is a Thematic Legal Adviser at Geneva Call. Previously she was a Senior Research Fellow at the Geneva Academy of International Humanitarian Law and Human Rights; worked at the Swiss Ministry of Defense; and was a consultant for various NGOs and a teaching assistant at the University of Geneva. She holds a PhD in international law from the Graduate Institute of International and Development Studies in Geneva.

David Kretzmer (LLB, LLM (Jerusalem), Dr Jur (York University, Canada)) is Bruce W Wayne Emeritus Professor of International Law at the Hebrew University of Jerusalem and Professor of Law at Sapir College. He has been a visiting professor at Columbia University, the University of Southern California, Tulane University, the Fletcher School of Law and Diplomacy of Tufts University and Bar Ilan University, and a visiting fellow at the Institute for Advanced Legal Studies of London University, and the Max Planck Institute for Comparative and Foreign Law in Heidelberg. From 2006–2009 he was Professor of Law at the Transitional Justice Institute at the University of Ulster and in 2009–10 he was an Inaugural Fellow at the Straus Institute for the Advanced Study of Law and Justice at New York University

Law School. He was the founding director of the Centre for Human Rights at the Hebrew University and from 1997–2000 served as Director of the Minerva Centre for Human Rights of the Hebrew and Tel Aviv Universities. Professor Kretzmer was a member of the UN Human Rights Committee from 1995–2002, and vice-chairperson in 2001 and 2002. His books include *The Occupation of Justice: The Supreme Court of Israel and the Occupied Territories* (2002), *The Concept of Human Dignity in Human Rights Discourse* (edited with E Klein, 2002) and *The Legal Status of the Arabs in Israel* (2nd edition, 2002). Recent articles of his on the law of armed conflict, human rights and constitutional law have appeared in leading law journals, including *American Journal of International Law*, *European Journal of International Law* and *European Constitutional Law Review*.

Andrew Lynch is a Professor in the Faculty of Law, University of New South Wales and teaches and researches in the field of Australian constitutional law. His authored publications include *What Price Security? Taking Stock of Australia's Anti-Terror Laws* (2006), *Inside Australia's Anti-terrorism Laws and Trials* (2014), and *Blackshield & Williams' Australian Constitutional Law and Theory* (6th edn, 2014; 7th edn, 2018). He is a co-editor of *Law and Liberty in the War on Terror* (2007) and *Counter-Terrorism and Beyond: The Culture of Law and Justice After 9/11* (2010). Andrew has contributed submissions and oral evidence to parliamentary and other inquiries on Australia's counter-terrorism legislative scheme.

Guénaél Mettraux is a Judge at the Kosovo Specialist Chambers, Affiliate Professor of International Criminal Law Practice, Dickinson Law School, Penn State University, Guest Professor at the University of Fribourg and Lecturer at Sciences Po – Paris School of International Affairs (PSIA).

Mauro Miedico is an Italian attorney at law with post-graduate studies at the Diplomatic Academy of the Ministry for Foreign Affairs of Italy, and at the prestigious Ecole Nationale d'Administration (ENA) in France. He has been working with the Organization of the United Nations since 1996, in the United States, Austria, Haiti, Serbia, Sierra Leone and Colombia, holding different positions as Legal Advisor with the United Nations Department of Peacekeeping Operations (UNDPKO), with the Office of the UN High Commissioner for Human Rights (UNHCHR), with the United Nations Development Programme (UNDP), with the United Nations Office on Drugs and Crime (UNODC) and with the United Nations Office of Counter Terrorism (UNOCT). Mr Miedico has particularly worked in the field of justice reform and as an advisor to a number of governments on criminal justice and on preventing and countering terrorism. Mr Miedico is currently the Director of the Special Projects and Innovation Division of UNOCT. He provides strategic and programmatic advisory services and expertise to the Under-Secretary General of Counter-Terrorism addressing complex strategic, operational and policy issues. As a senior staff of the United Nations Office of Counter Terrorism, he also oversees, and has lead responsibility on, a variety of counter terrorism technical assistance initiatives and programmes under the Division. Previous to joining UNOCT, Mr Miedico worked for 15 years at the Terrorism Prevention Branch of UNODC, including as its Chief (2016–18). He has undertaken more than 100 technical assistance missions and has chaired a large number of regional or sub-regional conferences and workshops, providing technical advice to dozens of countries on counter-terrorism issues.

Cian C Murphy is Reader in Law at the University of Bristol and a Visiting Researcher at the Grotius Centre for International Legal Studies in The Hague. His research focuses on the

relationship between collective power, legal principles, and the individual – in particular in relation to terrorism. He is the co-Editor in Chief of the *Common Law World Review*.

Efthymios (Akis) Papastavridis is a Researcher and Part-time Lecturer at the Faculty of Law, University of Oxford, and Oxford Martin Fellow at the Oxford Martin School, University of Oxford.

Dr Papastavridis is also Research Fellow at the Academy of Athens and Senior Fellow at the Athens Public International Law Center, University of Athens. He was formerly Expert Counsellor on Public International Law at the Ministry of Foreign Affairs, Greece (2016–19); Part-time Lecturer at the Faculty of Law, Democritus University of Thrace (2010–16) and Post-doctoral Fellow at the Faculty of Law, National and Kapodistrian University of Athens (2012–15).

Dr Papastavridis read law at the National and Kapodistrian University of Athens and University College London. In 2009 he was awarded a PhD in Public International Law from University College London. He has taught international law at various universities, including University College London, Westminster University, Democritus University of Thrace, National and Kapodistrian University of Athens, the University of Piraeus and the University of Oxford. He has consulted the UN Office on Drugs and Crime on transnational organized crime at sea and the UNHCR on questions concerning rescue at sea. He is currently consulting the European Border and Coast Guard Agency (FRONTEX) on international law of the sea matters. In 2012, Dr Papastavridis was the Director of the Centre for Research Studies of The Hague Academy of International Law.

Amrith Rohan Perera is the former Legal Adviser of the Ministry of Foreign Affairs, Sri Lanka. Dr Perera served as a Member of the International Law Commission (ILC) from 2007–11. In 2000, Dr Perera was unanimously elected as Chairman of the UN Ad-hoc Committee on Measures to Eliminate International Terrorism established by UN General Assembly Resolution 51/210. The Ad-hoc Committee is currently negotiating the Draft Comprehensive Convention on Terrorism, having successfully concluded the International Convention against Nuclear Terrorism in 2005. Dr Perera served as its Vice-Chairman, representing the Asian Region. During this period the Committee adopted two landmark conventions on the suppression of terrorist bombings and terrorist financing. Dr Perera is a visiting lecturer in International Law at the Department of Law of the University of Peradeniya, the Faculty of Law of the University of Colombo, the Bandaranaike International Diplomatic Training Institute and the Kotelawala Defence University. He has several publications, including *International Terrorism* (Vikas, New Delhi).

Marc Porret is a Legal Officer in the Africa Cluster of the UN Counter-Terrorism Executive Directorate (CTED) dealing with West Africa, and topics such as kidnapping for ransom and internet and communication technologies. He was assigned to establish the UN Counter-Terrorism Centre in March 2012 to become its first Programme Coordinator and launch its activities. Mr Porret has also been dealing with different aspects of terrorism, including legal, criminal justice, political, social and reform of governmental structures. Mr Porret also worked for the UN Office of Legal Affairs on general legal issues and the Canadian Department of Foreign Affairs on cooperation with the international criminal tribunals. Mr Porret has worked in Switzerland in private practice as a lawyer, on the implementation of the

Swiss money laundering legislation and white collar investigations and in international arbitration cases. Mr Porret studied common law and civil law at McGill University in Montreal (LLB and BCL) and international law at the Graduate Institute of International Studies in Geneva (DES) and is admitted to the Bar in Québec, Canada.

Javaid Rehman is the former Head of the School of Law, Brunel Law School, Brunel University London and is a Professor of Islamic Law and International Human Rights Law. As a member of the International Law Association, Professor Rehman is the co-rapporteur of the Committee of International Law and Islamic Law. He was a member of the International Bar Association (IBA) Taskforce on International Terrorism (2009–11). He is an internationally recognized legal scholar from Pakistan and an expert on Islamic law, Muslim constitutionalism and international human rights law. His recent works include *International Human Rights Law* (2010), *Islamic State Practices, International Law and the Threat from Terrorism* (2005), and (with SC Breau) (eds) *Religion, Human Rights and International Law* (2007). He is on the editorial boards of several journals. Professor Rehman has also been involved in legal cases and policy making. He received his first university degree in History and English Literature (Government College Lahore, Punjab University), before studying in the UK (LLB, Hons at the University of Reading; PhD in International Law, Hull University).

Mitchell Robinson served as the international specialist for a defence team as part of the 9/11 trial taking place at Guantanamo Bay, Cuba. He obtained his doctorate from the Graduate Institute in Geneva in 2012 before moving to Oslo and joining the MultiRights (PluriCourts) project at the University of Oslo. Dr Robinson was hired by the Pentagon from Oslo in 2013 and worked on the 9/11 case in 2018. To date, Dr Robinson is the only specialized international lawyer in the history of Guantanamo Bay prisons to obtain Top Secret Clearance and work ‘behind the wire’ with ‘high value detainees’. As of September 2018, Dr Robinson returned to his home State of Mississippi where he works on the issues of jobs, economic rights and water security in the most impoverished area of the United States.

Yaël Ronen (PhD 2006, Cambridge University) is senior lecturer of public and private international law at Sha’arei Mishpat Academic Center in Israel, and academic editor of the *Israel Law Review*. Her areas of expertise are international human rights law, international humanitarian law and international criminal law, focusing particularly on the intersection between these areas and issues of territorial status, and on aspects relating to non-state actors. She has published articles in leading international law journals, including the *Leiden Journal of International Law* and the *Journal of International Criminal Justice*, as well as three books, including *Transition from Illegal Territorial Regimes in International Law* (2011).

Katja Samuel is the founding Director of Global Security and Disaster Management Ltd (GSDM), a consultancy specializing in security, disaster risk management and resilience planning, notably their growing interconnectedness in the context of novel and emerging technology. Formerly a practising barrister then lecturer at the University of Reading, UK her specialist areas include rule of law and security issues, counter-terrorism and the influences of Islamic law and the Organization of Islamic Cooperation on international law-making. Some of her work in this area is published in KLH Samuel, *The OIC, the UN, and Counter-Terrorism Law-Making: Conflicting or Cooperative Legal Orders?* (2013) for which she won the prestigious Society of Legal Scholars Birks Prize for outstanding legal scholarship (2015).

Ben Saul (BA (Hons), LLB (Hons) (Sydney), DPhil (Oxford)) is Challis Chair of International Law, the Whitlam and Fraser Visiting Chair of Australian Studies at Harvard University and an Associate Fellow of Chatham House, London. He is author or editor of 20 books and over 100 academic articles, including *Defining Terrorism in International Law* (2006) and *The International Covenant on Economic, Social and Cultural Rights: Commentary, Cases and Materials* (2014) (awarded a Certificate of Merit by the American Society of International Law). His research has been used in national and international courts. Ben has taught law at Oxford, The Hague Academy of International Law, and in China, India, Nepal and Cambodia. Ben practises as a barrister in international and national courts, has advised United Nations bodies, foreign governments and NGOs, and delivered foreign legal assistance projects.

Mirko Sossai (PhD Siena) is Associate Professor of international law at the Law Department of the Roma Tre University, Italy. He was co-rapporteur of the ILA study group on UN sanctions and international law. He has published a number of books and journal articles in English and Italian, including *La prevenzione del terrorismo nel diritto internazionale* ('The prevention of terrorism in international law', 2012) and *Multilevel Regulation of Military and Security Contractors* (co-edited with C Bakker, 2012). He presented his scholarship at the meetings of both the European and American Society of International Law.

Lyal S Sunga has been Visiting Professor at the Raoul Wallenberg Institute of Human Rights and Humanitarian Law since 2010 and was the Institute's first Director of Research and served as Senior Lecturer (2005–2009). He is also currently Visiting Professor, The American University of Rome, Visiting Professor, Strathmore University Law Faculty, Nairobi, RWI Visiting Professor at the Addis Ababa University Centre for Human Rights and Lecturer, John Cabot University in Rome. A specialist on international human rights law, international humanitarian law and international criminal law, Sunga was Director of the LLM programme in Human Rights at the University of Hong Kong (2001–2005) and Human Rights Officer at the UN Office of the High Commissioner for Human Rights (UNOHCHR) in Geneva (1994–2001). In 2007, he was Coordinator for the UN Human Rights Council's Group of Experts on Darfur. Over the last 20 years, he has worked or consulted with the UN Security Council, UNOHCHR, UNDP, UNDEF, UNU, UNHCR, UNITAR, UNODC, the ILO, EU and IDLO and he has given conference presentations, lectures or training in more than 55 countries. He holds the following degrees: BA (Carleton University, Ottawa), LLB (Osgoode Hall Law School at York University, Toronto), LLM (Master of Laws in International Human Rights Law) (Essex University, UK), PhD (Docteur ès Sciences Politiques) (Droit International) (Graduate Institute of International Studies, University of Geneva, Switzerland).

Anina Timmermann majored in public international and European law. She has worked for several years at the Department for Foreign and International Criminal Law as a student research assistant to Professor Kai Ambos, as a Junior Fellow of the Legal Tools Project of the International Criminal Court, and at the Department of Legal Philosophy as a research assistant to Professor Dietmar von der Pfordten. She also has a master's degree in physics and is currently working towards a PhD in Astrophysics at the Georg-August-University Göttingen.

Kimberley N Trapp is Professor of Public International Law and Vice Dean (International) at the Faculty of Laws, UCL. Prior to joining UCL in 2012, she was a Lecturer at Newnham College and an Affiliated Lecturer at the Faculty of Law, University of Cambridge. Kimberley obtained a BA (philosophy), BCL and LLB (all with great distinction) from McGill

University, and an LLM and PhD from the University of Cambridge. Kimberley's doctoral thesis was awarded the Cambridge Yorke Prize for a dissertation of distinction, and is the basis of her OUP monograph *State Responsibility for International Terrorism* (2011) and UN Audio Visual Library lecture on the same subject. Kimberley collaborates as an academic advisor on issues of international humanitarian and human rights law with various NGOs and Government departments, has published in leading academic journals and edited collections on issues relating to the use of force, human rights, State responsibility, the settlement of international disputes, and the interaction between international humanitarian law and terrorism suppression, has directed research at the Centre for Studies and Research in International Law and International Relations of the Hague Academy of International Law, co-edits the OUP 'Elements of International Law' book series, and is a member of the Academic Review, Editorial or Advisory Boards for several journals.

Clive Walker (LLB, University of Leeds, PhD and LLD, University of Manchester) is Professor Emeritus of Criminal Justice Studies at the University of Leeds. He formerly served as the director of the Centre for Criminal Justice Studies and Head of the School of Law. He has also held visiting professorships at the University of Louisville (1993), George Washington University (1995), University of Connecticut (2003), Stanford University (2006), University of Washington (2006), University of Melbourne (2007), Institute of Advanced Legal Studies (University of London) (2009), University of New South Wales, Sydney (2012) and the University of Toronto (2016). He is the author of numerous books and journal articles including *Terrorism and the Law* (2011), *The Routledge Handbook of Law and Terrorism* (2015), and *The Palgrave Handbook of Criminal and Terrorism Financing Law* (2018). He was appointed in 2010 by the Home Office as Senior Adviser to the Independent Reviewer of Terrorism Legislation and became a Queen's Counsel (Hon) in 2016.

Sharon Weill (PhD, University of Geneva, 2012) is an Assistant Professor of International Law at the American University of Paris and an Associate Researcher at Sciences-Po Paris. Her research focuses on the relationship between law, conflict and the role of courts, while using socio-legal approaches including trial ethnography. In the last decade she has studied the role of criminal judges as transnational actors in the global war on terror and the transformation of national criminal justice systems in response to transnational jihadism. Since 2017, she conducts empirical research on foreign fighters' trials in France, financed by the French Ministry of Justice. During 2015–16 she spent a year as a visiting scholar at the Berkeley Center for The Study of Law and Society, where she specialized in empirical methods of research and socio-legal scholarship. Prior to that she was for a few years a research fellow at the Geneva Academy for International Humanitarian Law and Human Rights. Professor Weill is an expert member of the French National Consultative Commission on Human Rights (CNCDH). She was recently nominated by the United Nations High Commissioner for Refugees to serve as a judge in French Asylum Courts. She is the author of *The Role of National Courts in Applying International Humanitarian Law* (OUP, 2014) and the co-editor of *Prosecuting the President: The Trial of Hissène Habré* (OUP, forthcoming 2020).

Leah West is Lecturer of National Security and Intelligence at the Norman Paterson School of International Affairs at Carleton University, Canada. She previously served as Counsel with Canada's Department of Justice in the National Security Litigation and Advisory Group, where she appeared before Canada's Federal Court in designated proceedings and the Security

Intelligence Review Committee. Before being called to the Ontario Bar in 2016, she clerked for the Honourable Justice Mosley of the Federal Court of Canada. Leah previously served in the Canadian Armed Forces for ten years as an Armoured Officer and deployed to Afghanistan in 2010. She has a JD from the University of Toronto; an LLM (International Humanitarian and Security Law) from the University of Ottawa; an MA (Intelligence Studies) from the American Military University; and a BA (Hons) (Politics) from the Royal Military College of Canada.

Samuel Witten is a counsel in the international practice group at Arnold & Porter LLP. Prior to this he served in the US Department of State for 22 years, including 19 years in the Office of the Legal Adviser where he was Deputy Legal Adviser from 2001–2007. He also held three senior State Department foreign policy positions, including Acting Assistant Secretary of State, where he managed the State Department’s international refugee assistance programmes and the resettlement of refugees into the US. He is the immediate past President of the Washington Foreign Law Society, a non-profit group that advances understanding of international law and foreign affairs, and sits on the Board of Directors of the Women’s Refugee Commission and the Board of Advocates of Human Rights First. He holds a BA from the University of Maryland and a JD from the Columbia University School of Law.

Michael Wood is a member of the UN International Law Commission, and a Senior Fellow of the Lauterpacht Centre for International Law, University of Cambridge. He is a barrister at Twenty Essex Chambers, London, where he practises in the field of public international law, including before international courts and tribunals. He was the principal Legal Adviser to the UK Foreign and Commonwealth Office (FCO) between 1999 and 2006, having joined as an Assistant Legal Adviser in 1970. During 35 years as a lawyer in the FCO, he attended many international conferences, including the UN Conference on the Law of the Sea. He spent three years at the UK Mission to the UN in New York, dealing chiefly with Security Council matters. He was Agent for the UK for a number of years before the European Commission and Court of Human Rights, and UK Agent in cases before the International Court of Justice, as well as in proceedings before the International Tribunal for the Law of the Sea and arbitral tribunals.

Andrej Zwitter (PhD, University of Graz, with distinction) is Professor of International Relations and International Law and the head of Political Sciences at the Department of Legal Theory, University of Groningen. He is Director of the European Centre for Applied Research (ECFAR) and co-chairs the inter-faculty research section Research in Ethics and Globalisation. His main areas of research are: international law of humanitarian action, international and domestic regulation of states of emergency, ethics of international law, and long-term terrorism prevention. Among his recent books and edited volumes are: *Human Security, Law and the Prevention of Terrorism* (Routledge, 2010); *International Law and Humanitarian Aid* (Springer, 2011); and *Humanitarian Action: International, Regional and Domestic Legal Responses* (with Cambridge University Press, 2014).
