Lucyna Czechowska is an Assistant Professor at the Department of the History of Diplomacy, the Faculty of Political Sciences and International Studies, Nicolaus Copernicus University in Toruń. A graduate of International Relations at NCU, she specialized in Eastern European studies. Her research is focused on international relations theory, in particular on strategic partnerships, the foreign policy of the Third Republic of Poland and the external policy of the European Union. She did internships at the Ministry of Foreign Affairs and the Polish Embassy in Washington, as well as scientific internships and research stays at the Library of Congress and the University of Rostock.

Agata Domachowska is an Assistant Professor at the Balkan Studies Department of Nicolaus Copernicus University and an expert at the Casimir Pulaski Foundation. A recipient of a Kosciuszko Foundation scholarship, she conducted research at the University of Pittsburgh, George Washington University and Humboldt University of Berlin as well as in archives and libraries in Serbia, Montenegro, Albania, Macedonia and Croatia.
