Jaewoo CHOO is Professor of Chinese foreign policy in the Department of Chinese Studies at Kyung Hee University, South Korea. He graduated from Wesleyan University (BA in Government) and Peking University (MA & Ph.D. in International Relations). His research areas are Chinese foreign policy, multilateral security cooperation, and China–North Korea relations. In addition to numerous contributions to edited volumes, his academic journal work includes “China’s Frustration over North Korea: Editorial Analysis, Dec. 2012–April 2013,” *Korea Journal of Security Analysis* (2014), “Does China’s Charm Offensive Pose a Dilemma for South Korea?” *China Brief* (2014) and “China’s Dilemma on the Korean Peninsula: Not an Alliance but a Security Dilemma,” *Korea Journal of Defense Analysis* (2013).

Jihwan HWANG is Professor of International Relations at the University of Seoul, South Korea. He was a visiting scholar at the Catholic University of America in Washington DC in 2017 and also taught at George Washington University. He has served in several advisory positions in the Korean government, including in the President’s Committee for Unification Preparation, the Ministry of Foreign Affairs and the Ministry of Unification. His publications include the articles ‘The paradox of South Korea’s unification diplomacy’ and ‘The two Koreas after U.S. unipolarity’. He is a graduate of Seoul National University and received his PhD in Political Science from the University of Colorado, Boulder, USA.

Catherine JONES is a lecturer at the University of St Andrews, UK. Her research focuses on China’s interaction with and contribution to international norms and their implementation. Her work on Sino-DPRK relations was funded by the Korea Foundation through their Next Generation of Scholars award in 2017–2018. In her current research project, she is exploring East Asian cooperation and coordination in the areas of humanitarian assistance and disaster relief. She teaches on Northeast Asian international relations and the politics and development of Southeast Asia. Her publications have appeared in *The Pacific Review*, *Pacific Focus* and *International Politics*, and her first monograph, *China’s Challenge to Liberal Norms*, was published by Palgrave in 2018.

Seungho LEE is Professor at the Graduate School of International Studies, Korea University. His research interests are institutional change in water policy, transboundary water cooperation and conflict, and public private partnership projects in water supply and sanitation services with reference to China, Korea, Southeast Asia (the Mekong River Basin) and Europe. His recent publications include ‘Power asymmetry over hydropower development in the Mekong River Basin’, *Southeast Asia Studies* (2017); ‘Benefit sharing in the Mekong River Basin’, *Water International* (2015); and ‘Wastewater treatment transfer-operate-transfer projects in China – the case of the Hefei Wangxiaoying Wastewater Treatment TOT Project’, *KSCE Journal of Civil Engineering* (2015). He is the author of *Water and Development in China: The Political Economy of Shanghai Water Policy* (World Scientific, 2006). He holds a PhD from SOAS University of London, and previously worked at the School of Contemporary Chinese Studies, University of Nottingham, UK and the Korea Institute of Construction Technology.

LIU Ming is a professor, former director of the Institute of International Relations, former director of the Institute of Asia-Pacific Studies, at the Shanghai Academy of Social Sciences (SASS), a Senior Fellow of the China Charhar Institute, and Editor-in-Chief of the Journal of International Relations Studies. He holds a PhD in Political Sciences from World Economy Institute, Fudan University, China, obtained in 1999. He was also a visiting scholar at Columbia University, Seoul National University and Stanford University in 1993, 1996 and 2000, respectively. His research interests cover major power relations, US strategy, and Northeast Asia security. Liu has contributed extensively to several English language journals in Canada, the UK and South Korea. His articles include ‘BRICS development: A long way to a powerful economic club and new international organization’, *The Pacific Review* (2016); ‘Northeast Asia order after WWII: Continuity, compliance, power-transition and challenges’, *Korean Journal of Defense Analysis* (2015); and ‘China and the North Korean crisis: Facing test and transition’, *Pacific Affairs* (2003).

Sarah TEITT is an Australian Research Council DECRA Senior Research Fellow and Deputy Director of the Asia Pacific Centre for the Responsibility to Protect, in the School of Political Science and International Studies, the University of Queensland, Australia. Sarah’s research focuses on Chinese foreign policy in relation to peacekeeping, peacebuilding and humanitarian emergency response. Sarah coordinates the China–Australia Dialogue on the Responsibility to Protect, an annual dialogue she established in 2014 for Chinese and Australian foreign affairs officials and experts to exchange viewpoints and concerns on international responses to mass

atrocities situations. In 2016, she was a visiting research fellow at the China Institute of International Studies, the think tank of China's foreign ministry, researching Chinese perspectives on the Syrian crisis. Her research has featured in leading international and Chinese journals, and she is currently undertaking a three-year research fellowship focused on China's role in international peacebuilding in Myanmar, Afghanistan and South Sudan.

WANG Xingxing is a distinguished professor in the School of International Relations and Public Affairs at Shanghai International Studies University (2020–present). Wang holds a Ph.D. in International Studies from Seoul National University, which was jointly achieved at the University of California-Los Angeles. She is currently a visiting scholar at the Fairbank Center for Chinese Studies at Harvard University and previously held a postdoctoral fellowship at Johns Hopkins University in Washington, D.C.

Over the last decade, Dr. Wang has taught and conducted research at the Institute for Far Eastern Studies at Kyungnam University—among several other universities in South Korea—and was a visiting professor at Kim Il Sung University in North Korea. Her research primarily concerns Northeast Asian studies, particularly focusing on the intersection between China, the Korean Peninsula and China-U.S. relations. Concurrently, Dr. Wang has contributed op-ed articles and commented on international affairs issues for multiple media outlets such as *The Korea Times* and Phoenix TV.

ZHENG Jiyong is Professor and Director at the Centre for Korean Studies, Fudan University, China and Secretary-General of the Shanghai Institute of Korean Studies, China. Zheng joined the Chinese People's Liberation Army and studied at the School of Foreign Languages. In 1991, he was assigned a project to research the military and diplomacy of the Korean Peninsula. In 2009, he retired from the army and joined Fudan University. He received his Doctoral Degree at Fudan University, and has had post-doctoral experiences at IFES, Kyungnam University, ROK (2009–2010) and at Kim Il Sung University, DPRK (2014). He is a visiting scholar at Seoul National University, ROK (2016–2017) and is currently a resident visiting scholar at the Stimson Center, USA (2019–2020). His research focuses on domestic politics in the two Koreas, and on bilateral and multilateral relations in the Korean Peninsula. He is the author and co-author of more than a hundred scholarly articles and author or editor of more than ten books, including *ROK's Political Party Systems* (2008), *ROK's Parliamentary Politics* (2017), 'The "conflict-reconciliation" cycle on the Korean Peninsula: A Chinese perspective' (2012), and 'Road Map to a Korean Peninsula Peace Regime: A Chinese Perspective' (2015).
