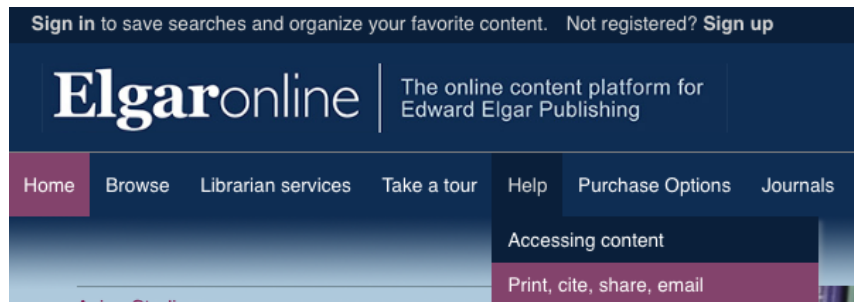


## Welcome to Elgaronline

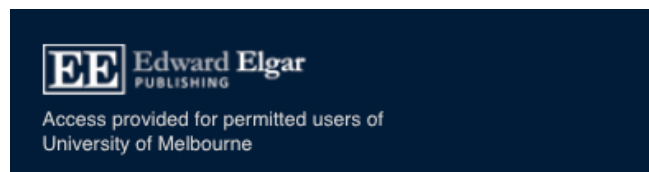

### Accessing your new content:

Your users and patrons will now be able to access Elgar content via our digital platform, [www.elgaronline.com](http://www.elgaronline.com). Access is authenticated using the IP ranges you have supplied. If your institution supports a Shibboleth or OpenAthens login system, we ask you to send the relevant URL link resolvers(s) to our sales team who can add these details to your account.


To ensure you are signed in correctly, please check the bottom left-hand corner of any Elgaronline webpage. You should see the 'Access provided for ...' text if you are successfully logged in to your account:



## Platform Accessibility Standards



## Using Research Literature Reviews

If you have purchased any Elgaronline major collection, you will now have access to a number of [Elgar Research Literature Reviews](#). These titles are the digital version of the [Elgar Research Collections](#), providing an authoritative summary of the seminal works that establish a field of research. Research Literature Reviews consist of two principal components: a Literature Review Article and a list of Recommended Readings. Whilst we do not own electronic rights for the readings provided in the **print** Research Collections, we have instead supplied the full references of each article/chapter for your information. Using these references, as well as the sourced Google Scholar link, your users can easily search and locate the given article in various databases and repositories. To find your accessible Research Literature Reviews, use the 'Refine by Type' filter; after selecting a title, browse through the table of contents as below:

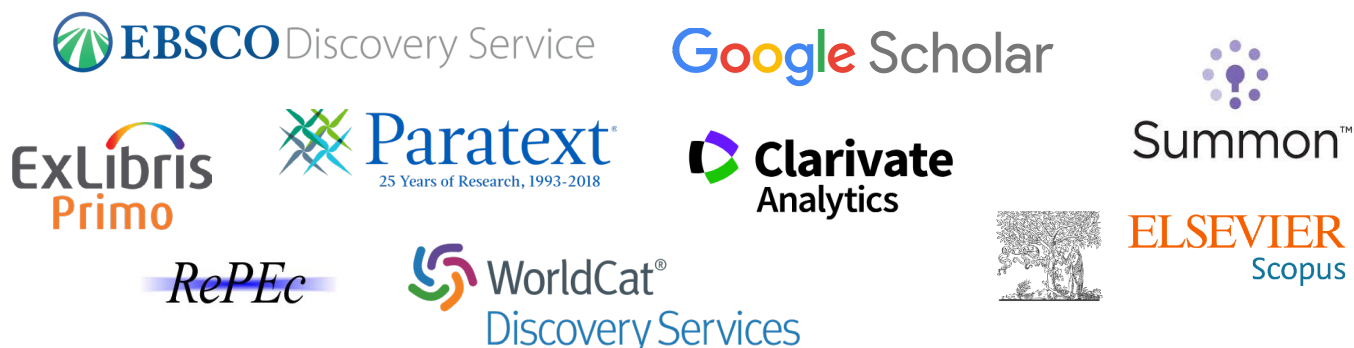
